COASTAL ZONE MANAGEMENT & RESTORATION ADVISORY COMMITTEE MINUTES OF April 2, 2024

1. Chairman Ernie Babin called the regular meeting of the Coastal Zone Management & Restoration Advisory Committee to order at 5:00 p.m. Tuesday, April 2, 2024, in the Council Meeting Room, 2nd Floor, Government Tower. Chairman Babin led the Invocation and the Pledge of Allegiance.
2. Upon roll call, present were Ernie Babin, Matt Benoit, Jan Rogers, Barry Soudelier, and Mickey Thomas. Absent: Tony Antill, Jeff DeBlieux, Jordan Lirette, and Merlin Lirette. Also present was Mr. Mart Black, Director of the Terrebonne Parish Office of Coastal Restoration and Preservation.
3. Mr. Thomas moved, seconded by Mr. Rogers, "THAT the Coastal Zone Management & Restoration Advisory Committee **accepts** the minutes for the meeting of March 5, 2024." *NO OPPOSITON, MOTION CARRIED, CHAIRMAN DECLARED MOTION ADOPTED.*

Local Concern Applications: -

- The Chairman called to order the local concern application for **Eddie Pellegrin**; Proposed clearing access trail around the perimeter of the property so it can be surveyed & permitting a bridge to access his property. 124 Timberwood Drive, Gray, LA; Terrebonne Parish, LA P20230998 – Public Notices ends – January 7, 2024.

Mr. Black informed the Committee that we still waiting on the Terrebonne Parish Public Works Department's Letter of No Objection to continue with the CIC process. Mr. Black recommended putting it on hold until we receive the Letter of No Objection for the Terrebonne Parish Public Works Department.

Mr. Thomas moved, seconded by Mr. Roger, "THAT the Coastal Zone Management & Restoration Advisory Committee **hold** the issuance of a Coastal Impact Certificate and Coastal Use Permit until we receive a Letter of No Objection from Public Works Department for P20230998 submitted by Eddie Pellegrin" *NO OPPOSITON, MOTION CARRIED, CHAIRMAN DECLARED MOTION ADOPTED.*

8. Public Comment –

- Mr. Mark Roberson following up on the Local Concern P20230998 regarding Eddie Pellegrin's permit application for building a bridge to access his property located at 124 Timberwood Drive in Gray, LA. They

continue to express concerns regarding the bridge's placement and observe some clearing of the property. Additionally, Mr. Roberson informed the Committee about the apparent digging of a ditch.

Mr. Black responded to the concerns by explaining that we haven't received the Letter of No Objection from the Public Works Department, making the permit not yet authorized. Once we obtain the Letter of No Objection, we can move forward with the permit process, readdress this matter on the agenda, and update Mr. Roberson. Additionally, Mr. Black will revisit the property for a more thorough investigation.

Discussion took place regarding this permit.

9. Committee Member Comments – -

Mr. Thomas provided feedback on the updated Borrow Pit Ordinance. He expressed satisfaction with the language and emphasized that it should not hinder the progress of building the levees.

10. Chairman Babin stated that the next scheduled meeting of the Coastal Zone Management & Restoration Advisory Committee would be held Tuesday, May 7, 2024, at 5:00 pm in the Terrebonne Parish Council Meeting Room located on the Second Floor of Government Tower.
