ORDINANCE NO. 9543

IN ACCORDANCE WITH CHAPTER 2, ARTICLE X, SECTION 2-229 OF THE TERREBONNE PARISH CODE OF ORDINANCES, AN ORDINANCE TO AUTHORIZE THE APPOINTMENT OF ANTHONY J. ALFORD INSURANCE CORPORATION TO SERVE AS AGENT OF RECORD FOR THE LIFE, DISABILITY AND OTHER BENEFITS COMMENCING ON JANUARY 1, 2024, AND EFFECTIVE THROUGH DECEMBER 31, 2024, WITH THE OPTION TO RENEW FOR TWO ADDITIONAL ONE YEAR TERMS AS MORE FULLY DESCRIBED HEREIN.

WHEREAS, Terrebonne Parish Consolidated Government (TPCG) does provide employee group health insurance/self-funded insurance coverages for life and disability benefits through its Risk Management Department; and

WHEREAS, The Terrebonne Parish Council, pursuant to Section 2-229 of the Terrebonne Parish Code of Ordinances, has selected an insurance agent of record for the year 2024, commencing January 1, 2024, and effective through December 31, 2024; and

WHEREAS, TPCG is authorized to exercise right to renew the option for two (2) oneyear renewals, subject to the same terms and conditions. The parties need not execute a new agreement to exercise the two (2) renewal terms.

SECTION I

NOW THEREFORE BE IT ORDAINED by the Terrebonne Parish Council on behalf of the Terrebonne Parish Consolidated Government that Anthony J Alford Insurance Corporation is hereby appointed to serve as Agent of Record for life, disability and other benefits, submitted to Terrebonne Parish Council on the 11th of December, 2023, for the period commencing January 1, 2024, effective through December 31, 2024.

WHEREAS, 100% of immovable property identified as 302 Island Road, Montegut LA 70377, tax parcel number 32061, with an owner of record of Luke Naquin, was adjudicated to the Terrebonne Parish Consolidated Government on July 6, 2012 for nonpayment of taxes; and

WHEREAS, the three (3) year period for redemption provided by Art. 7, Sec 25 of the Louisiana Constitution has elapsed without redemption; and

WHEREAS, on August 11, 2022, the Terrebonne Parish Consolidated Government, by virtue of Terrebonne Parish Ordinance No. 9410, declared its intention to acquire ownership of this property; and

WHEREAS, since the adoption of Ordinance No. 9410, the Terrebonne Parish Consolidated Government has made no further effort to finalize the acquisition of this property, nor has it used this property for a public purpose; and

WHEREAS, Louisiana Revised Statute 47:2196, et seq. authorizes the parish to sell adjudicated property in accordance with law; and

WHEREAS, the Terrebonne Parish Consolidated Government now wishes to repeal and rescind Ordinance No. 9410 and to declare the property described herein surplus and not needed for public purpose, and to dispose of the property in any manner authorized by Louisiana Revised Statute 47:2196, et seq.

NOW THEREFORE BE IT ORDAINED by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government that Terrebonne Parish Ordinance No. 9410 is hereby declared null and void and is rescinded and repealed.

BE IT FURTHER ORDAINED by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government that the following described property, adjudicated to the Terrebonne Parish Consolidated Government is hereby declared surplus:

AN ORDINANCE TO AUTHORIZE THE ACQUISITION OF PROPERTY LOCATED AT 105 BAYOU GUILLAUME ROAD, HOUMA LA 70363, TO BE DONATED BY LOUISIANA LAND TRUST; TO AUTHORIZE THE PARISH PRESIDENT OR HIS AUTHORIZED DESIGNEE TO EXECUTE ANY AND ALL DOCUMENTS NECESSARY TO ACQUIRE SAID PROPERTY

SECTION I

RESOLUTION TO REDEDICATE TAX MILLAGE

A RESOLUTION PROVIDING TO REPURPOSE AND REDEDICATE THE REVENUE OF ONE (1) MILL OF THE ALREADY AUTHORIZED SPECIAL TAX OF ONE AND SIXTY-SIX HUNDREDTHS (1.66) MILLS ON ALL PROPERTY SUBJECT TO TAXATION (THE "TAX") IN THE

PARISH OF TERREBONNE, STATE OF LOUISIANA (THE "PARISH") ENDING IN THE YEAR 2030, LEVYING AND PROVIDING FOR THE ASSESSMENT, COLLECTION, PAYMENT AND DEDICATION OF THE PROCEEDS OF SUCH TAX AND FURTHER PROVIDING FOR THE REDEDICATION OF THE REVENUE OF ONE (1) MILL OF THAT SPECIAL TAX, SUCH TAX HAVING BEEN AUTHORIZED AT A SPECIAL ELECTION HELD IN THE PARISH ON OCTOBER 14, 2023.

WHEREAS, under the provisions of Article VI, Section 26 of the Constitution of the State of Louisiana of 1974, and other constitutional and statutory authority and an election held on October 14, 2023, the Terrebonne Parish Council (the "Governing Authority"), acting as the governing authority of the Parish of Terrebonne, State of Louisiana (the "Parish"), is authorized to repurpose the revenue of one (1) mill of the already authorized special tax of one and sixty-six hundredths (1.66) mills on all property subject to taxation in the Parish (the "Tax"), authorized pursuant to an election held on November 6, 2012, and ending in the year 2030, currently dedicated and used for the purpose of acquiring, constructing, operating and maintaining the Terrebonne Parish Health Unit and health unit facilities and rededicate the revenue of one (1) mill of that special tax to provide additional funds for improving, operating, providing and maintaining public safety personnel, pedestrian facilities and at school sites within the Parish as provided by law, pursuant to the following proposition which was approved at said election held on October 14, 2023:

PARISHWIDE PROPOSITION

(Rededication)

Shall the Parish of Terrebonne, State of Louisiana (the "Parish"), be authorized to repurpose the revenue of one (1) mill of the already authorized special tax of one and sixty-six hundredths (1.66) mills on all property subject to taxation in the Parish (the "Tax") authorized pursuant to an election held on November 6, 2012, and ending in the year 2030, currently dedicated and used for the purpose of acquiring, constructing, operating and maintaining the Terrebonne Parish Health Unit and health unit facilities and rededicate the revenue of one (1) mill of that special tax to provide additional funds for improving, operating, providing and maintaining public safety personnel, pedestrian facilities and at school sites within the Parish (an estimated \$982,768.66 reasonably expected to be collected from the levy of the Tax for an entire year)?

WHEREAS, in compliance with Article VI, Section 26 of the Constitution of the State of Louisiana of 1974, aforementioned statutory authority and said special election October 14, 2023, it is the desire of this Governing Authority to provide for the levy and collection of the Tax and to provide for distribution of the proceeds thereof and other matters in connection therewith as hereinafter provided in this Resolution;

NOW, THEREFORE, BE IT RESOLVED by the Terrebonne Parish Council (the "Governing Authority"), acting as the governing authority of the Parish of Terrebonne, State of Louisiana (the "Parish"), that:

SECTION 1. <u>Imposition.</u> Pursuant to the authority of a special election held in the Parish on October 14, 2023, the Tax is hereby levied upon all owners of immovable property in the Parish, as defined by law. The Parish of Terrebonne shall apply in the assessment, collection, administration and enforcement of the Tax, the provisions of which are hereby incorporated by reference.

SECTION 2. <u>Rate.</u> The Parish of Terrebonne, State of Louisiana, continues the levy of the Tax, until the year 2030, one and sixty-six hundredths (1.66) mills tax on all property subject to taxation in the Parish.

SECTION 3. <u>Effective Date.</u> The repurposed Tax shall be effective on January 1, 2024, without lapse in collection.

- **SECTION 4.** Expiration Date. The repurposed Tax is effective for a period of six (6) years, beginning with the year 2024 and ending in the year 2030.
- **SECTION 5.** <u>Purposes.</u> The proceeds of one (1) mill of that special tax are rededicated to provide additional funds for improving, operating, providing and maintaining public safety personnel, pedestrian facilities and at school sites within the Parish, as set forth in the propositions approved by the voters in the special election held in the Parish on October 14, 2023, which proposition is set forth in the preamble hereto.
- **SECTION 6.** <u>Limits on Interest, Penalty and Attorney Fees</u>. Should the interest, penalties or attorney fees herein, or the combined interest, penalties and attorney fees be declared to be in excess of limits provided by other law, including relevant jurisprudence, then the maximum interest, penalties and attorney fees allowed by such other law shall apply.
- **SECTION 7.** Collector. The Tax levied by this Resolution is authorized to be collected by a "Collector" which term shall mean the Sheriff of the Parish of Terrebonne, State of Louisiana.
- **SECTION 8.** <u>Powers of Collector</u>. The Collector is hereby authorized, empowered and directed to carry into effect the provisions of this Resolution, to appoint deputies, assistants or agents to assist it in the performance of its duties, and in pursuance thereof to make and enforce such rules as it may deem necessary.
- **SECTION 9.** Revenues of Taxes. All taxes, revenues, funds, assessments, moneys, penalties, fees or other income which may be collected or come into the possession of the Collector under any provision or provisions of this Resolution relating to the Tax shall be promptly deposited by the Collector of the Parish.
- **SECTION 10.** Costs and Expenses. In compliance with the said special election of October 14, 2023, authorizing the rededication of a portion of the Tax, after all reasonable and necessary costs and expenses of collecting and administration shall be available for appropriation and expenditures by the Governing Authority solely for the purposes designated in the propositions authorizing the levy of the Tax.
- **SECTION 11.** Severability. If any or more of the provisions of this Resolution shall for any reason be held to be illegal or invalid, such illegality or invalidity shall not affect any other provision of this Resolution, but this Resolution shall be construed and enforced as if such illegal or invalid provisions had not been contained herein. Any constitutional or statutory provision enacted after the date of this Resolution which validates or makes legal provision of this Resolution which would not otherwise be valid or legal, shall be deemed to apply to this Resolution.
- **SECTION 12.** <u>Publication and Recordation.</u> This Resolution shall be published in one issue of the official journal of this Governing Authority as soon as is reasonably possible. A certified copy of this Resolution shall be recorded in the mortgage records of the Parish of Terrebonne, State of Louisiana.
- **SECTION 13.** <u>Effective Date of Resolution.</u> This Resolution shall be in full force and effect immediately upon its adoption and approval, being a Resolution affecting the public peace, health and safety.

RESOLUTION NO. 24-009

RESOLUTION TO CONTINUE TO LEVY TAX MILLAGE

A RESOLUTION PROVIDING FOR THE LEVY WITHIN THE ROAD LIGHTING DISTRICT NO. 7 OF THE PARISH OF TERREBONNE, STATE OF LOUISIANA (THE "DISTRICT"), A SIX AND TWENTY-TWO HUNDREDTHS (6.22) MILLS TAX (THE "TAX") ON ALL PROPERTY SUBJECT TO TAXATION IN THE DISTRICT, FOR A PERIOD OF TEN (10) YEARS, BEGINNING WITH THE YEAR 2024, **PROVIDING LEVYING AND FOR** THE ASSESSMENT, COLLECTION, PAYMENT AND DEDICATION OF THE PROCEEDS OF SUCH TAX AND THE PURPOSE FOR WHICH THE PROCEEDS OF THE TAX MAY BE EXPENDED, SUCH TAX HAVING BEEN AUTHORIZED AT A SPECIAL ELECTION HELD IN THE DISTRICT **ON OCTOBER 14, 2023.**

WHEREAS, under the provisions of Article VI, Sections 30 and 32 of the Constitution of the State of Louisiana of 1974, and other constitutional and statutory authority and an election held on October 14, 2023, the Terrebonne Parish Council (the "Governing Authority"), acting as the Governing Authority of the Road Lighting District No. 7 of the Parish of Terrebonne, State of Louisiana (the "District"), is authorized to levy and collect within the Parish a special tax (the "Tax"), more specifically to continue the collection of a 10 year, six and twenty-two hundredths (6.22) mill tax on all immovable property subject to taxation in the District, as provided by law, pursuant to the following proposition which was approved at said election held on October 14, 2023:

ROAD LIGHTING DISTRICT NO. 7 PROPOSITION (TAX RENEWAL)

Shall Road Lighting District No. 7 of the Parish of Terrebonne, State of Louisiana (the "District"), continue to levy a six and twenty-two hundredths

- (6.22) mill tax on all property subject to taxation in the District (an estimated \$367,907 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of ten (10) years, beginning with the year 2024 and ending with the year 2033, for the purposes of providing and maintaining electric lights on the streets, roads, highways, alleys and public places in said District?
- **WHEREAS,** in compliance with Article VI, Sections 30 and 32 of the Constitution of the State of Louisiana of 1974, aforementioned statutory authority and said special election October 14, 2023, it is the desire of this Governing Authority to provide for the levy and collection of the Tax and to provide for distribution of the proceeds thereof and other matters in connection therewith as hereinafter provided in this Resolution;
- **NOW, THEREFORE, BE IT RESOLVED** by the Terrebonne Parish Council (the "Governing Authority"), acting as the Governing Authority of the Road Lighting District No. 7 of the Parish of Terrebonne, State of Louisiana (the "**District**"), that:
- **SECTION 1.** <u>Imposition.</u> Pursuant to the authority of a special election held in the District on October 14, 2023, the Tax is hereby levied upon all owners of immovable property in the District, as defined by law. The Parish of Terrebonne shall apply in the assessment, collection, administration and enforcement of the Tax, the provisions of which are hereby incorporated by reference.
- **SECTION 2.** Rate. The Parish of Terrebonne, State of Louisiana, continues the levy of the Tax, a 10 year, 6.22 mills tax on all property subject to taxation in the District.
 - **SECTION 3.** Effective Date. The Tax shall be effective on January 1, 2024.
- **SECTION 4.** Expiration Date. The Tax is effective for a period of ten (10) years, beginning with the year 2024 and ending in the year 2033.
- **SECTION 5.** <u>Purposes.</u> The proceeds of the Tax shall be used for the purposes set forth in the propositions approved by the voters in the special election held in the District on October 14, 2023, which proposition is set forth in the preamble hereto.
- **SECTION 6.** Limits on Interest, Penalty and Attorney Fees. Should the interest, penalties or attorney fees herein, or the combined interest, penalties and attorney fees be declared to be in excess of limits provided by other law, including relevant jurisprudence, then the maximum interest, penalties and attorney fees allowed by such other law shall apply.
- **SECTION 7.** Collector. The Tax levied by this Resolution is authorized to be collected by a "Collector" which term shall mean the Sheriff of the Parish of Terrebonne, State of Louisiana.
- **SECTION 8.** <u>Powers of Collector</u>. The Collector is hereby authorized, empowered and directed to carry into effect the provisions of this Resolution, to appoint deputies, assistants or agents to assist it in the performance of its duties, and in pursuance thereof to make and enforce such rules as it may deem necessary.
- **SECTION 9.** Revenues of Taxes. All taxes, revenues, funds, assessments, moneys, penalties, fees or other income which may be collected or come into the possession of the Collector under any provision or provisions of this Resolution relating to the Tax shall be promptly deposited by the Collector for the account of the Parish a special fund heretofore established and maintained for the deposit of such proceeds, which fund shall be a separate bank account established and maintained with the regularly designated fiscal agent of the Governing Authority; provided, however, any amount which is paid under protest or which is subject to litigation may be transferred to a separate account established by the Collector with said fiscal agent pending the final determination of the protest or litigation.
- **SECTION 10.** Costs and Expenses. In compliance with the said special election of October 14, 2023, authorizing the Tax, after all reasonable and necessary costs and expenses of

collecting and administration shall be available for appropriation and expenditures by the Governing Authority solely for the purposes designated in the propositions authorizing the levy of the Tax.

SECTION 11. Severability If any or more of the provisions of this Resolution shall for any reason be held to be illegal or invalid, such illegality or invalidity shall not affect any other provision of this Resolution, but this Resolution shall be construed and enforced as if such illegal or invalid provisions had not been contained herein. Any constitutional or statutory provision enacted after the date of this Resolution which validates or makes legal provision of this Resolution which would not otherwise be valid or legal, shall be deemed to apply to this Resolution.

SECTION 12. <u>Publication and Recordation.</u> This Resolution shall be published in one issue of the official journal of this Governing Authority as soon as is reasonably possible. A certified copy of this Resolution shall be recorded in the mortgage records of the Parish of Terrebonne, State of Louisiana.

SECTION 13. <u>Effective Date of Resolution.</u> This Resolution shall be in full force and effect immediately upon its adoption and approval, being a Resolution affecting the public peace, health and safety.

change and reallocate the functions, powers, duties and responsibilities of certain departments, to amend the Administrative Organizational Chart accordingly; and to further amend portions of the Code to avoid conflicts with the reorganization of the Parish Departments; and call a public hearing on said matter on Wednesday, January 24, 2024 at 6:30 p.m." (*MOTION ADOPOTED AFTER DISCUSSION)

At Mr. B. Pledger's request, the Chairman recognized Parish President Jason Bergeron who gave an overview of the proposed reorganization and the renaming of certain departments. Mr. Bergeron noted that the reorganization only addressed the existing departments and responsibilities of the Parish then shared his optimism for adding additional investment and support into other areas of Quality of Life for the Parish once funding was available.

Discussion ensued relative to the renaming of the Terrebonne Parish Recreation Department and potential issues with updating current equipment and materials for a rebranded department.

Mr. Bergeron explained that the name change came from his team after several conversations about what success looks like to them then noted that all the materials that the Parish already has with the current logos or branding will be used first before any new materials would be produced. He then commended his directors for taking his idea of a name change and turning it into something more efficient with the plan of moving Terrebonne Parish forward. He then added that the organizational chart will be updated to reflect the positions and the names of each person holding those positions once approved by the Council.

Discussion ensued relative to potential concerns for the Quality of Life Department having a focus on a specific area of the Parish over the Parish as a whole.

The Chairman recognized Interim Chief Administrative Officer Noah Lirette who shared what Houma means to him and noted that the Quality of Life Department would operate to serve all people, not one specific group.

At the request of B. Pledger, Chief Financial Officer Kandance Mauldin explained that Recreation millage funding will continue to fund parks and recreation based on the millage's guidelines regardless of a change in department name and that salaries for those pre-existing departments will be funded from their original sources.

Discussion continued relative to providing new projects and programs in areas across the Parish through the Quality of Life Department and its divisions.
