FEBRUARY 27, 2024

The Chairman, Ms. J. Amedée, called the meeting to order at 6:00 p.m. in the Terrebonne Parish Council Meeting Room. Council Member C. K. Champagne led the Invocation and the Pledge of Allegiance. Several Council Members thanked Mrs. Price and her agency for all that they do for those who have addictions.

The Chairman recognized Ms. Cherie Roger, LSU AgCenter Extension Agent, who provided an update on the LSU AgCenter and the services and programs it provides to local residents, including agricultural extension programs, 4-H youth development, nutrition and community health programs, and other services.

The Chairman thanked Ms. Roger then encouraged the public to visit the AgCenter and to consider signing their children up for the 4-H program.

The Chairman noted that several engineering firms will be presenting to the Parish Council over the next few weeks in order to inform both Parish Council and the public regarding engineering projects in Terrebonne Parish.

The Chairman recognized Mr. Ben Malbrough, GIS Engineering, who provided an update on GIS's current engineering projects for the Parish, including several pump stations, miter gates, bridges, facility, and levee repairs, and dredging projects.

At Mr. C. Harding's request, Mr. Malbrough confirmed that, once completed, the Bayou Cane Pump Station will be able to address high water conditions following rainstorms along Savanne Road.

At Mr. C. Harding's inquiring, Parish President Jason Bergeron noted that cleanup efforts for Bayou Terrebonne are being reviewed to allow the dredging of the bayou to begin.

WHEREAS, the Downtown Development Board has received State Revenue Sharing from Hotel/Motel Tax in the amount of \$143,362, for the 2024 year, and

WHEREAS, the Hotel/Motel Tax has been allocated by the Downtown Development Board for beautification and operations of the Folklife Cultural Museum and to help maintain the existing buildings, parks, and the Court Square in the Historic District, as well as advertising to market Houma's Historic District attractions.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government that the 2024 Adopted Budget be amended to adjust various Downtown Development Corporation Accounts. (**Attachment C**)

SECTION IV

WHEREAS, the Downtown Development Board has received State Revenue Sharing from Hotel/Motel Tax in the amount of \$14,684, for the 2024 year, and

WHEREAS, the Hotel/Motel Tax has been allocated by the Downtown Development Board for camera equipment in the Houma Historic District.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government that the 2024 Adopted Budget be amended to adjust various Downtown Development Corporation Accounts. (**Attachment D**)

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2024 Adopted Operating Budget be amended for the Animal Shelter. (**Attachment E**)

SECTION VI

WHEREAS, the Terrebonne Parish Consolidated Government (TPCG) has received an award for \$1,000,000 from the National Oceanic and Atmospheric Administration (NOAA) through the Coastal Habitat Restoration and Resilience Grants for Underserved Communities, and

WHEREAS, TPCG and NOAA will work in partnership with the Lowlander Center and the First People's Conservation Council of Louisiana, including the Grand Caillou/Dulac Band of Biloxi-Chitimacha-Choctaw Tribe, the Point-au-Chien Indian Tribe, and the Jean Charles Choctaw Nation, and

WHEREAS, the funds will be used for feasibility studies and engineering design to reverse canals that have been carved into the delicate but resilient marshes and wetlands for commercial exploration decades ago.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2024 Adopted 5-Year Capital Outlay Budget be amended for Restoring Louisiana Marshes. (**Attachment F**)

SECTION VII

WHEREAS, Administration is requesting to amend the Budgeted Positions by transferring the Grants Writer position, and

WHEREAS, Administration has determined the efficient department for the Grants Writer position is in the Accounting Department, and

WHEREAS, the Grant Writer, Grade 206 will be transferred from the Housing and Human Services Department to the Accounting Department.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2024 Adopted Operating Budget and the 2024 Budgeted Positions be amended to recognize the transfer of the Grants Writer position. (**Attachment G**)

RESOLUTION NO. 24-094

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT BETWEEN THE TERREBONNE PARISH CONSOLIDATED GOVERNMENT AND THE TERREBONNE COUNCIL ON AGING

WHEREAS, Article VII, Section 14 of the Louisiana Constitution provides that, "For a public purpose, the state and its political subdivisions or political corporations may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private association, corporation or individual"; and

WHEREAS, in partnership with Terrebonne Parish Consolidated Government, the Terrebonne Council on Aging (TCOA), utilizing millage funding received from TPCG, has developed the Tenant Based Housing Voucher Program (Program) to address the affordable housing needs of low-income elderly households in Terrebonne Parish; and

WHEREAS, TPCG addresses housing needs within Terrebonne Parish through its Department of Housing and Human Services which department agrees to manage the voucher Program on behalf of TCOA; and

WHEREAS, pursuant to Louisiana Constitution Art. 7, Section 14, the parties hereto believe that this voucher Program will constitute a social program for the elderly and thus justify the utilization of public funds necessary to implement the program; and

NOW THEREFORE BE IT RESOLVED that the Terrebonne Parish Consolidated Government hereby authorizes its Parish President to execute any and all documents necessary to effectuate this Cooperative Endeavor Agreement in accordance with substantially the same terms as the attached documents.
