ORDINANCE NO. 9460

AN ORDINANCE DECLARING PROPERTY ADJUDICATED TO TERREBONNE PARISH CONSOLIDATED GOVERNMENT AS SURPLUS AND NOT NEEDED FOR A PUBLIC PURPOSE; 300 WILLOWDALE DR. (PARCEL #6511) AND TO ADDRESS OTHER MATTERS RELATIVE THERETO.

WHEREAS, 27% of immovable property owned by JACOBY BUSHIDO JONES (9/200), LAKISHA B. JONES (9/80) AND LYNNETTA K. JONES (9/80) and described below was adjudicated to the Terrebonne Parish Consolidated Government on JUNE 25, 2015 for nonpayment of taxes; and

WHEREAS, LA R.S. 47:2196, *et seq.* authorizes the parish to sell adjudicated property in accordance with law; and

WHEREAS, the three (3) year period for redemption provided by Art. 7, §25 of the Louisiana Constitution has elapsed without redemption; and

WHEREAS, the Terrebonne Parish Consolidated Government now wishes to declare the property described below surplus and not needed for a public purpose and to dispose of said property in accordance with LA R.S. 47:2196, *et seq.*; and

NOW BE IT ORDAINED by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the following described properties adjudicated to the Terrebonne Parish Consolidated Government and depicted on the attached plats, if any, are hereby declared surplus

LOT 1 BLOCK 4 WILLOWDALE SUBD.

BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that Administration be hereby authorized to dispose of the property in accordance with LA R.S. 47:2196, *et seq.* and inclusive of the following terms.

SECTION I

Each bid shall be accompanied by a deposit in the form of a Certified Check, Cashier's Check, Money Order or Bid Bond with Power of Attorney (Letters of Credit WILL NOT be accepted) in the amount of twenty percent (20%) of the proposed price made payable to the Terrebonne Parish Consolidated Government. Bid deposits made for non-winning bids shall be returned. The bid deposit made with the winning bid shall be non-refundable, unless redemption occurs, and paid towards the purchase price. The balance of the purchase price is due at the time of closing and payable in the form of a Certified Check, Cashier's Check, or Money Order.

SECTION II

Additionally, the winning bidder shall bear the cost of recording the sale document into the conveyance records of the Parish of Terrebonne pursuant to La. R.S. 47:2207.

SECTION III

The winning bidder, otherwise known as the Purchaser or Acquirer, of this adjudicated property is solely responsible for compliance with La. R.S. 47:2206 regarding notification of parties who may have had an interest in the property regarding their rights of redemption and La. R.S. 47:2208 regarding recordation of those notices. Copies of the applicable law will be distributed along with bid packets for this adjudicated property. Terrebonne Parish Consolidated Government has not and will not perform these requirements; thus, it is the purchaser's or acquiring person's responsibility to do so. Terrebonne Parish Consolidated Government encourages the Purchaser or Acquiring Person to consult legal counsel regarding Louisiana law on adjudicated property.

SECTION IV

By acquiring a bid packet for the bid/purchase of this adjudicated property, each bidder acknowledges that he/she/it has received all information discussed in this ordinance as well as the statutes (laws) discussed in Section II above, and that he/she/it understands these procedures must be followed in order to fully protect he/she/its rights in the adjudicated property purchased from the parish.

SECTION V

If any word, clause, phrase, section or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections and other portions of this ordinance shall remain in force and effect, the provisions of this ordinance hereby being declared to be severable.

SECTION VI

Any ordinance or part thereof in conflict herewith is hereby repealed.

SECTION VII

This ordinance shall become effective upon approval by the Parish President, or Administration, or as otherwise provided in Section 2-13 (b) of the Home Rule Charter for a Consolidated Government for Terrebonne Parish, whichever occurs sooner.

The Chairwoman recognized Mr. Lawrence Dehart, Terrebonne Churches United Food Bank President, who announced that the Food Bank was celebrating its thirty-fifth anniversary and presented to the Parish Council an award commemorating its years of service with the Food Bank. Mr. Dehart then invited the Council and the public to consider attending upcoming events and fundraisers for the Food Bank.

Several Council Members thanked the Food Bank for its service to Terrebonne Parish residents, especially during times of crisis and disaster, and commended them on their successes over the past thirty-five years.

The Chairwoman called for discussion regarding Agenda Item 2.A. then recognized Mr. G. Michel who shared his concerns regarding potential discrepancies with information being made available to the Parish Council.

Parish President Gordon E. Dove clarified the procedures followed by the Parish Administration for providing information to the Parish Council as needed.

Discussion ensued relative to the availability and notification to the Parish Council regarding pertinent or time-sensitive information from the Parish Administration.

The Chairwoman called for discussion regarding Agenda Item 2.B. then recognized Mr. G. Michel who led a discussion regarding an update on FEMA reimbursements for Terrebonne Parish.

- At Mr. G. Michel's request, Chief Financial Officer Kandace Mauldin clarified that the figures included on the distributed spreadsheet regarding submissions for FEMA reimbursement were only a "snapshot" of the totals to be submitted to FEMA for approval and are continually updated as more information is collected.
- At Mr. J. Amedée's request, Ms. Mauldin clarified that several outside agencies would be allocated their FEMA reimbursements through the Parish, not directly from FEMA, and that said allocations would require some time for processing once received by the Parish.

The Chairwoman called for discussion regarding Agenda Item 2.C. then recognized Parish Attorney Julius Hebert who advised the Council to refrain from discussion regarding the temporary power plant, stating any questions regarding the power plant could be addressed in an upcoming Executive Session.

- At Mr. G. Michel's request, Mr. Hebert clarified that several claims and confidentiality agreements have been filed regarding various aspects of an ongoing lawsuit. He then reiterated his recommendation that the matter be discussed in Executive Session.
- Mr. G. Michel shared his concerns regarding the Council's ability to discuss aspects of the temporary power plant and noted that he would not attend an Executive Session to discuss the temporary power plant.

Discussion ensued relative to information presented to the Council in connection with previously adopted actions regarding the temporary power plant.

Mr. J. Amedée moved, seconded by Mr. D. J.
