Discussion ensued relative to the dredging required by the project and its potential effects on the seafood industry.

AN ORDINANCE TO AMEND THE 2024 ADOPTED OPERATING BUDGET AND 5-YEAR CAPITAL OUTLAY BUDGET OF THE TERREBONNE PARISH CONSOLIDATED GOVERNMENT FOR THE FOLLOWING ITEMS AND TO PROVIDE FOR RELATED MATTERS.

- I. SOLID WASTE DEPARTMENT, \$450,000
- II. HOLLYWOOD ROAD ROUNDABOUT, \$1,825,000
- III. AMERICAN RESCUE PLAN, \$920,000
- IV. HOUMA POLICE DEPT-EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT, \$17,578

SECTION I

WHEREAS, Administration is requesting funding of \$450,000 for the Solid Waste Department to purchase two crew cab trucks and two mule trucks, and

WHEREAS, the funding is from the Solid Waste Department fund balance.

NOW, THEREFORE BE IT ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2024 Adopted Operating Budget be amended for the Solid Waste Department. (**Attachment A**)

ORDINANCE NO. 9563

AN ORDINANCE TO AUTHORIZE THE RELOCATION OF A TERREBONNE PARISH PRECINCT POLLING LOCATION FOR THE

ELECTION OF JULY 17 - 19, 2024, AND ALL SUBSEQUENT ELECTIONS

SECTION I

WHEREAS, Precinct 029, which was previously located at the Honduras Elementary School, is no longer available to use for elections; and

WHEREAS, the following listed precinct polling location is no longer available to use for the July 17 - 19, 2024 election and all subsequent elections; and

WHEREAS, TPCG wishes to relocate this polling location in accordance with La R.S. 18:534 because the polling locations need to be changed; and

WHEREAS, notice of the relocation of the location of these polling places shall be published in Terrebonne Parish's Official Journal by the governing authority and the Parish Board of Election Supervisors in accordance with La. R.S. 18:535; and

WHEREAS, proper notice of the relocation of the location of the polling places shall be given, as applicable, in accordance with La. R.S. 18:536; and

WHEREAS, nothing herein shall change the Geographical boundaries of the precinct.

SECTION II

NOW THEREFORE BE IT ORDAINED that beginning on the July 17 - 19, 2024, election, and continuing every election thereafter, the following voting polling location shall be relocated as follows:

1) Pct. 029- Honduras Elementary School located at 530 Grand Caillou Road, Houma, LA 70363 **is moved to** East Houma Recreation Center located at 126 Boundary Road, Houma, LA 70363.

AUTHORIZE ORDINANCE TO THE PARISH AN **PRESIDENT** OR ADMINISTRATION TO ENTER INTO A COOPERATIVE ENDEAVOR WITH THE STATE OF LOUISIANA, OFFICE OF LANDS, AND EXECUTE NECESSARY DOCUMENTS FOR THE USE OF CERTAIN WATER BOTTOMS.

SECTION I

WHEREAS, the Louisiana Constitution of 1974, in Article VII, Section 14(C), provides that the State and its political subdivisions may engage in cooperative endeavors with each other and with any public or private association, corporation or individual for a public purpose; and

WHEREAS, the State is the owner of Bayou Terrebonne, located in Section 39, T17S-R17E, Terrebonne Parish, Louisiana, as shown on the attached plats; and

WHEREAS, by virtue of the provisions of La. R.S. 41:1701, et. seq. the State is authorized to lease water bottoms for any legitimate private, public, or commercial use; and

WHEREAS, the State desires to lease to the Parish a portion of Bayou Terrebonne for the construction, operation, and maintenance of a Bulkhead, two Timber Docks, and Kayak Launch, which will be made available to the public for recreational activities. It is understood that the public recreation will not generate public or private revenue and are solely being constructed for the recreational purpose of enhancing recreational opportunities on Bayou Terrebonne; and

WHEREAS, the Parties desire to enter into an Agreement to facilitate and advance the goals recited herein, as well as other goals for the public benefit of the State; and

NOW THEREFORE BE IT ORDAINED, by the Terrebonne Parish Council on behalf of the Terrebonne Parish Consolidated Government that:

SECTION I

the Parish President (or Administration) is hereby authorized to execute and enter into and enforce a Cooperative Endeavor Agreement, subject to legal, with the State of Louisiana, Office of Lands, to lease to the Parish a portion of Bayou Terrebonne for the construction, operation, and maintenance of a Bulkhead, two Timber Docks, and Kayak Launch, not inconsistent with the proposed agreement attached to this Ordinance, and that the Parish President (or Administration) is hereby authorized to execute and enter into and enforce any agreements necessary and proper to effectuate the attached Cooperative Endeavor Agreement, all in accordance with the terms contained in that agreement, which is attached hereto.

SECTION II

He stated that the master plan is not regulatory and that the ideas, suggestions and strategies could later become ordinances for future projects. He stated that housing, historic structures, streetscapes, jobs and residential analysis were some of the things researched for the master plan. The stated that plan can be viewed on the parish's website at www.tpcg.org/recovery.

At the request of Mr. C. Harding, Planning and Zoning Director C. Pulaski reiterated that the plan will be presented to the council as a resolution in two weeks for adoption. Mr. Polaski added that more time to review the plan may be given, but he would not recommend much more time.

Mr. B. Pledger inquired about the study area indicated on the master plan. He mentioned that the study should include more historic structures within the parish.

Discussion ensued relative to the list of projects highlighted in the master plan. C. Pulaski stated that the parish has one grant writer and a consulting firm contracted to assist Terrebonne parish with applications. He also stated that there is a project criterion for each funding source.

Planning and Zoning Director Christopher Pulaski presented a proposed Houma Main Street Corridor Revitalization Plan, sharing a brief history of the plan and highlighting a number of concerns being addressed. He then noted that the plan is only being presented at this time for the Council to review and that it would be submitted for adoption at a later meeting. He then shared that the plan, along with other projects, programs, and presentations related to recovery efforts, could be found online at www.tpcg.org/reovery.

Discussion ensued relative to timelines to adopt the proposed plan and public input on the plan from various stakeholders.

Chauvin's request, the Chairman recognized Mrs. Ana Gale-Orellana, Entergy Regional Customer Service Manager who gave a presentation on the current status of Terrebonne Parish streetlighting statistics, adjustments in billing, and best practices for reporting streetlight outages and other issues.

Several Council Members shared their concerns regarding the upkeep of streetlights in the Parish in various areas and thanked Entergy in their efforts toward reducing the amount of reported outages throughout the parish.

The Chairman recognized Mr. Chad Aucoin, Entergy Statewide Lighting Supervisor, who gave an overview of Entergy's work order system and their procedures used for responding to a reported street light outage.

Discussion continued relative to street light outage reporting vis Entergy's app and a potential for billing changes once installation and maintenance charges for a fixture have been addressed.

Mr. C. Harding led a discussion relative to Bayou Country Sports Park, plans for Capital Outlay funding, and an anticipated date of completion.

Upon the request of C. Harding, the Chairman recognized Quality of Life Director Jim Wendell who provided a report on the completed and current projects for the Bayou County Sports Park, noting that multiple projects have received some but not all funding required for completion.

Several Council Members shared their concerns regarding the Sports Park facilities and offered suggestions for partnerships and other options that could provide more funding.

The Chairman recognized Parish President Jason Bergeron who noted that establishing an estimated point of completion and total costs to use as a goal was difficult to determine at this time, due to inflation and other increasing project costs.

Discussion ensued regarding funding for the Bayou Country Sports Park and completing enough of the park to host larger sports tournaments for economic development.
