OF THE

TERREBONNE PARISH COUNCIL

IN SPECIAL SESSION

APRIL 7, 2014

The Chairman, Russell Hornsby, called the meeting to order at 5:00 p.m., in the Terrebonne Parish Council Meeting Room for the sole purpose of conducting condemnation hearings.

Following the Invocation, offered by B. Amedée, and the Pledge of Allegiance, led by D. Babin, the Minute Clerk called the roll. Upon roll call, Council Members recorded as present were: J. Navy, A. Williams, Capt. G. Hood, Sr. (Ret.), B. Amedée, R. Hornsby, D. Babin, D. Guidry, and P. Lambert. Councilwoman C. Duplantis-Prather was recorded as absent. A quorum was declared present.

Assistant Planning Director Geoffrey Large stated the structures being considered for removal through the FEMA, Community Development Block Grant (CDBG) funded program is a voluntary program to assist low to moderate income owners who have structures that may be considered as slum or blight. He continued that the nine (9) structures have been damaged by hurricanes and pose an immenient danger to their communities; that the removal of the structures will reduce nuisance complaints; and that the cost for the removal is derived from CDBG funding in additional to income based cost share contributions from the property owners. Mr. Large stated that all owners have been notified and have requested that they be included in the aforementioned program; that all owners have been notified of the hearing this evening; that the target addresses have been published; and that the hearings this evening address "right-of-entry" to access the properties for removal. He then presented a summation of the condition of each of the structures being considered for removal this evening (The power point presentation given by Administration tonight, which contain the background and history of each property, photographs of the structures in question, and Administration's recommendations, has been made a part of the official record of these proceedings, a hard copy of which is to be maintained in the office of the Planning Department.).

In default of which the Terrebonne Parish Consolidated Government may proceed to demolish and remove the residential structures through the FEMA, Community Development Block Grant program addressing slum and blight, being administered by Terrebonne Parish Consolidated Government, and for this purpose, the obligation and release of up to \$160,952 in CDBG funding previously approved and appropriated to meet the various costs associated with this project is hereby approved."
