### IN SPECIAL SESSION

# **APRIL 21, 2014**

The Chairman, Russell "Red" Hornsby, called the meeting to order at 5:30 p.m., in the Terrebonne Parish Council Meeting Room for the primary purpose of conducting condemnation hearings.

Following an Invocation offered by Minute Clerk S. Thomas, and the Pledge of Allegiance led by Councilman P. Lambert, the Minute Clerk called the roll. Upon roll call, Council Members recorded as present were: A. Williams, Capt. G. Hood, Sr., C. Duplantis-Prather, R. Hornsby, D. Babin, D. Guidry, P. Lambert, and J. Navy. Councilwoman B. Amedée was recorded as absent due to a personal obligation. A quorum was declared present.

The Chairman recognized former Terrebonne Parish Councilman Wayne Thibodeaux who was present in the audience.
