The Chairwoman, Ms. B. Amedée, called the meeting to order at 6:00 p.m. in the Terrebonne Parish Council Meeting Room. Following an Invocation, offered by Councilwoman A. Williams, Councilman D. Babin led the Pledge of Allegiance.

Upon roll call, Council Members recorded as present were: D. Babin, D. Guidry, P. Lambert, J. Navy, A. Williams, G. Hood, Sr., B. Amedée, C. Duplantis-Prather and R. Hornsby. A quorum was declared present.

Council Clerk C. Poché read aloud the following returns and declared the results of special election held on May 4, 2013 to include the parish within the boundaries of the Bayou Lafourche Fresh Water District:

FOR: 10,846 AGAINST: 5,892

MAJORITY FOR: 4,954, PROPOSITION PASSED

# **RESOLUTION NO. 13-237**

A resolution providing for canvassing the returns and declaring the result of the special election held in the Parish of Terrebonne, State of Louisiana, to include the Parish within the boundaries of the Bayou Lafourche Fresh Water District, on Saturday, May 4, 2013.

BE IT RESOLVED by the Terrebonne Parish Council (the "Governing Authority"), acting as the governing authority of the Parish of Terrebonne, State of Louisiana (the "Parish"), that:

SECTION 1. <u>Canvass.</u> This Governing Authority does now proceed in open and public session to examine the official tabulations of votes cast at the special election held in the Parish of Terrebonne, State of Louisiana, on SATURDAY, MAY 4, 2013, to include the Parish within the boundaries of the Bayou Lafourche Fresh Water District, and said Governing Authority does further proceed to examine and canvass the returns and declare the result of the special election.

SECTION 2. <u>Procès Verbal</u>. A *Procès Verbal* of the canvass of the returns of said election shall be made and a certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, who shall record the same in his office; another certified copy thereof shall be forwarded to the Clerk of Court and *Ex-Officio* Recorder of Mortgages in and for the Parish of Terrebonne, who shall record the same in the Mortgage Records of said Parish; and another copy thereof shall be retained in the archives of this Governing Authority.

SECTION 3. <u>Promulgation of Election Result.</u> The result of said election shall be promulgated by publication in the manner provided by law.

### **PROPOSITION**

Shall the Parish of Terrebonne, State of Louisiana (the "Parish"), under the provisions of Act 2 of the 2005 Regular Legislative Session of the Louisiana State Legislature, be included within the boundaries of the Bayou Lafourche Fresh Water District (the "District") as of the day following promulgation of the results of this election, with the Parish being thereafter subject to taxes levied by the District, which currently consist of a 2.11 mills ad valorem tax (an estimated \$1,700,000 reasonably expected at this time to be collected from the levy of the tax in the Parish for an entire year), authorized to be levied from and including the year 2013 through the year 2033, for the purpose of acquiring, administering, constructing, improving, maintaining and/or operating improvements, equipment, structures, facilities, projects and programs of and for the District, including paying personnel costs?

WHEREAS, the Men's Health Network, a non-profit educational organization composed of physicians, researchers, public health workers, individuals and other health professionals was founded in 1992, and

WHEREAS, the role of the group, among many other things, is to heighten the awareness of preventable health problems and to encourage early detection and treatment of disease among men and boys, and

WHEREAS, research shows that men see doctors for a physical exam only half as often as do women; men die almost 6 years younger than women and suffer higher mortality rates for the top causes of death; and men are more likely to be uninsured than women, and

WHEREAS, in 1994, "Men's Health Month" was enacted, nationally recognizing June as a time to increase awareness of men's health issues and the importance of early detection and treatment, and

WHEREAS, the Terrebonne Parish Council wishes to participate in this endeavor, as the lives of hundreds of thousands of men and boys will continue to be threatened unless action is taken to combat this expanding problem.

AN ORDINANCE AUTHORIZING THE PARISH PRESIDENT TO EXECUTE AN ACT OF DONATION TO DONATE A TIMBER BRIDGE TO THE TERREBONNE LEVEE AND CONSERVATION DISTRICT IN ORDER TO FACILITATE THE DISTRICT'S ACCESS TO THE EASTERN SIDE OF THE MTG REACH J-2 IN CONNECTION WITH THE CDBG POINTE-AUX-CHENES CONNECTION LEVEE PROJECT, AND TO PROVIDE FOR RELATED MATTERS

WHEREAS, LA R.S. 33:1324, also known as the Local Services Act, provides that any parish or political subdivision of the state may make agreements between or among themselves to engage jointly in the acquisition or improvement of any public project or improvement provided that at least one of the participants to the agreement is authorized under a provision of law to perform such activity for completion of the undertaking; and

WHEREAS, LA R.S. 38:329 and 33:1236 specifically authorizes TLCD and TPCG to enter into agreements of this nature; and

WHEREAS, TLCD has been granted by the Louisiana Legislature certain rights, powers, and duties, including but not limited to establishing, constructing, operating, or maintaining flood control works, as they relate to hurricane protection, tidewater flooding, saltwater intrusion, and conservation, in addition to all other rights, powers and duties provided by law; and

WHEREAS, the TPCG has been granted by the Louisiana Legislature certain, rights, powers, and duties to establish, construct, operate, and maintain flood control works, in furtherance of which it has obtained Community Development Block Grant ("CDBG") funds for the construction of the Pointe-Aux-Chenes Connection Project, along the Morganza to the Gulf Reach J-2 alignment (the "Project"); and

WHEREAS, in furtherance of their mutual goals, TLCD has contracted with the TPCG to administer certain parish levee projects funded with CDBG funds;

WHEREAS, in order to facilitate TLCD's administration of the Project, TLCD requires access to the eastern side of the MTG Reach J-2, which is only attainable by way of a parishowned timber bridge located in Section 53, T18S, R19E and connecting the southwestern corner of Terrebonne Parish Tax Parcel No. R06-42823 bearing a municipal address of 2428 Highway 665, Montegut LA 70377, to Terrebonne Parish Tax Parcel No. A06-42349 owned by the Louisiana Department of Wildlife and Fisheries (the "Bridge"); and

WHEREAS, TLCD and TPCG desire to enter into an intergovernmental agreement in order to effectuate the transfer of ownership of the Bridge from TPCG to TLCD for the purpose of facilitating their shared mission of establishing additional flood protection for the residents of Terrebonne Parish; and

NOW, THEREFORE, BE IT ORDAINED by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that:

#### SECTION I

The Parish President, Michel Claudet, be and he is hereby authorized to execute an Act of Donation and any other necessary legal documents to effectuate the donation of TPCG's timber bridge, as further described in the attached map, to the TLCD for maintenance and operation for a public purpose and in substantially the same form as the above referenced Act of Donation.

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT BETWEEN THE TERREBONNE PARISH CONSOLIDATED GOVERNMENT AND THE SOUTH CENTRAL PLANNING AND DEVELOPMENT COMMISSION ("SCPDC")

WHEREAS, SCPCD, in accordance with the Department of Homeland Security/GOHSEP Grant Number 2010-SS-T0-0043, desires to deliver possession and ownership to TPCG of laptops and installation, radios and accessories, GIS printer and accessories, tactical and medical equipment, GIS equipment, hazmat equipment, satellite phones and accessories, and other emergency preparedness equipment, in consideration of the TPCG immediately putting them to full use in such a manner to achieve the purpose described above; and

WHEREAS, SCPCD would like to donate its equipment to the TPCG for the purpose listed above;

The Chairwoman recognized Mr. Charles Bass, a Levron Street, who addressed the Council relative to the matter of "maintenance of Bayou LaCarpe and the closed gate at Dumas". Mr. Bass explained that with the recent rain event several streets in his neighborhood flooded, although Bayou LaCarpe had been put in place to relieve this type of flooding. He further explained that he has contacted the Drainage Department about the closed gate at the Dumas railroad crossing. Mr. Bass said that if that gate is open during rain events, it would help the flow of water, which would decrease flooding, noting that the proper maintenance of Bayou LaCarpe would also help.

Mr. D. Babin moved, seconded by Mr. J. Navy, "THAT, the Council extend Mr. Charles Bass's time an additional minute."

The Chairwoman called for a vote on the motion offered by Mr. D. Babin.

Mr. Bass continued by suggesting that this flooding was unnecessary and that at least one of the streets is used as an evacuation route when necessary. He further explained that if these streets continue to flood, then there will be a problem if an emergency situation occurs in the area during a rain storm event, and that no emergency response vehicle will be able to travel in the area. Mr. Bass asked the Council and Administration for help in alleviating this problem and for answers as to why the area still floods when the study of Bayou LaCarpe in 2003 indicated that the problem would be resolved.

Ms. A. Williams explained that there were five components to the 2003 Bayou LaCarpe study that Mr. Bass referred to, and that four phases of that study have been completed. Ms. Williams deferred questioning to Administration for a status report on the final phase of the project.

Upon questioning, Parish President M. Claudet explained that the gate at the Dumas railroad crossing is open and is used to stabilize and equalize the flow of water to the Baroid Pump Station and the M & L Pump Station. Mr. Claudet further stated that the Parish is in the process of upgrading the Baroid Pump Station and changing the culverts, along with upgrading a pump station on Corporate Dr. that should also decrease the flow of water in the aforementioned area.

The Chairwoman called for a report on the Public Services Committee meeting held on 05/20/13, whereupon the Committee Chairman, noting that ratification of the minutes calls a public hearing on 06/12/13 at 6:30 p.m., rendered the following:

# PUBLIC SERVICES COMMITTEE

### MAY 20, 2013

The Chairman, Daniel Babin, called the Public Services Committee meeting to order at 5:30 p.m. in the Terrebonne Parish Council Meeting Room with an Invocation offered by R. Hornsby and the Pledge of Allegiance led by D. Guidry. Upon roll call, Committee Members recorded as present were: B. Amedée, D. Babin, C. Duplantis-Prather, D. Guidry, Capt. Greg Hood, Sr., HPD Ret., R. Hornsby, P. Lambert, J. Navy, and A. Williams. A quorum was declared present.

The Chairman recognized Public Works Director Lt. Col. (Ret.) Greg Bush, who narrated a power point presentation on the current status of Drainage Pump Stations throughout the Parish, highlighting the following:

- Ashland D-09 Pump Station (District 7) is a completely new pump station; the old station has been removed from the site; new fully automated Tier 3 engines have been installed with telemetry panels; the telemetry monitors measures oil levels, heat, engine failure, and pump failures; and Community Development Block Grant (CDBG) funding was used to complete the improvements.
- Baroid Pump Station is a full station replacement; once complete the old structure will be removed; four pumps have been added; Tier 3 engines have been installed; the Ashland Pump Station has been contracted to complete the outfall; the project is 60 % complete and includes widening and in some cases deepening the canal to make sure complete hydraulic range to the outfall ditch; bids should be let soon for the Baroid Station; and the project is part of the Gulf South Study location D;
- Summerfield D-29 Pump Station (District 6) is a completely new pump station; Substantial Completion was recently completed; new Tier 3 engines with fully automated telemetry; and one additional pump was added for increased pumping capacity and expansion acreage;
- Gulf Access Road D-43 Pump Station (District 1) 18 inch self priming pumps have been installed; and funding was derived from District 1 funding sources;
- Industrial Boulevard D-13 Pump Station (District 7) replaced 24 inch electric pump with a 36 inch diesel pump; a small building has been built where the new pumps have been installed; the deteriorated trash screen has been replaced; the project is 60% complete and should be functional within two weeks; and all work completed was done utilizing Parish work crews.
- Bonanza D-27 Pump Station (District 3) is an upcoming project; upgraded telemetry control panels have been installed utilizing Parish work crews; two engines have been replaced with Tier 3 engines for increased fuel efficiency; Hazard Mitigation Grant (HMGP) funding has been received to raise the piles on each side of the discharge side; the piles will be raised from 8 ft. to 10 ft; there is a problem with water returning into the pump stations so check valve will be placed along the outfall canal; and the project is being designed by T. Baker Smith, LLC;
- Williams Avenue D-41 Pump Station (1-1B) (District 5) recently one pump station has been added using Parish work crews; previously in 2012 a pump station was replaced; and currently, there are two new pump station as the location;
- Coteau D-58 Pump Station (District 9) has the largest problem within the Parish with debris; HMGP grant funding has been used to install automatic bar screens; there was an initial problem with the bar screen and are now fully operational; and the contractor changed some of the components on the bar screens;

■ Smithridge D-07 Pump Station (District 8) - HMGP provided funding for the installation of new bar screen cleaners and a bridge; previously there was a tiered screen that was hard to clean and has been replaced; and the bar screens are fully functional;

- Upper Montegut D-03 Pump Station (District 9) HMGP provided funding for the installation of new bar screen cleaners and a pipe was installed for by-pass purposes;
- Bayou Neuf D-05 Pump Station (District 8) Administration recently received HMGP funding for the replacement of the aforementioned pump station; the pump station had extensive damage as a result of Hurricane Gustav; the structure is not sitting on the piling which have shifted approximately 4 to 5 inches; the HMGP funding will be used to replaced the entire station and remove the old station; and Providence/GSE has been contracted to design the pump station;
- Shrimpers Row D-11 Pump Station (District 7) has been scheduled for replacement and relocation; the station is currently next to the road, but will be moved to the levee to bring the water into the levee with borrow canals; the changes will bring efficiency to the station; and the pump station is being designed by Providence/GSE and awaiting the release for bid.
- Fuel Containment Phase 5 has been completed; all fuel containment for all of the pump stations have been changed to double insulated walls in the event of leak the fuel would be contained and provide for fuel by-pass clogged locations; valves have been installed to fuel the stations; and the valves automatically close if there is a water surge;
- Telemetry Lab the lab is located in the Parish Barn Yard; all control panels are tested and programmed for the individual pump stations at the lab; lab services include sizing engines and adapting software; all pump stations can be controlled by telemetry from the lab; although the stations have attendants monitoring can be done by the lab and immediate dispatching services can be issued; and the lab has blinking lights and alarms to alert individuals that a pump station has problems.

In response to questioning, Lt. Col. (Ret.) Bush stated that the telemetry lab is located in a safe location between other buildings and is flood-protected; the computers are removable and can be placed into laptops; and that three shift employees have been assigned to monitor the telemetry lab in addition to the Public Works Director, Public Works Operations Superintendent, and Operations Manager.

Parish President Michel Claudet stated that, although the Baroid Pump Station was not included in the power point presentation slides, a request for bids has been advertised for the Baroid Pump Station this week; the Baroid culverts will be replaced with larger culverts in Bayou LaCarpe; that the design has been approved in the budget for the Corporate Boulevard Pump Station, which will also assist the M & L Pump Station. President Claudet thanked the employees of the Public Works Department for their work during a recent rain event.

Committee Member J. Navy noted that the residents of Gulf Access Road have been pleased with the function of the Gulf Access Road Pump station productivity.

In response to additional questioning, Lt. Col. (Ret.) Bush stated that approximately 4 out of 72 of the Parish's pump stations have telemetry capability.

President Claudet interjected that Administration's goal is to continue to expand telemetry systems at all of the Parish's pump station. He noted that the installation of the telemetry system is being performed at the larger pump stations first. (NO ACTION TAKEN)

The Chairman relinquished the chair to the Vice Chairman after reading the agenda item regarding expanding the Mechanicville Summer Camp Program from 5 to 8 weeks. He then explained his reasons for his wish to expand the term of the aforementioned program.

Recreation Director Sterling Washington explained the procedure for allocating funding for the various summer camp programs in Terrebonne Parish, noting that the programs are administered by the various applicable recreation districts. He noted that additional funding is not available this year to fund an extension of the Mechanicville Summer Camp Program, however, Administration will re-assess any access funding from approved summer camps once the camps have been opened for 2-3 weeks.

Parish President Michel Claudet stated that he understands the need to provide additional funding for the Mechanicville Summer Camp, however, funding for 2013 has already been allocated and there is no funding currently available. He added that he is aware of problems in the Mechanicville area, for which the Chief of Police has ordered additional patrols. He stated that Administration will work with the Recreation Director regarding the aforementioned request, and will review the matter at a later date.

In response to questioning by the Chairman, Mr. Washington stated that funding is allocated to the various recreation districts that in turn hire their own staffing; that Administration monitors the programs, and that it conducts unannounced site visits.

Committee Member R. Hornsby suggested that the Chairman contact the Recreation District No. 11 Board to seek additional funding for the expansion of the Mechanicville Summer Camp program.

Mr. Washington interjected that Administration does not provide total funding of the summer camp programs, only supplemental funding.

Committee Member A. Williams offered to collaborate with the Chairman to coordinate summer camp efforts; suggested that the Schriever Summer Camp Program be reviewed as a model camp; and noted that the Department of Health & Hospitals has begun distributing information regarding the summer feeding programs, which may be a source of reduced funding for summer camps.

Upon additional questioning, Mr. Washington stated that funding for the summer camp programs is based upon the submission of proposals and the projected number of participants. He noted that some recreation districts are not open to recommendations or suggestions regarding the operation of its camps. He stated that he could provide a cost estimate for the extension of the Mechanicville Summer Camp by 3 weeks to the Council Clerk, for distribution to the Council.

The Chairwoman called for a vote on the motion offered by Mr. R. Hornsby and Mr. D. Guidry.

The Chairwoman called for a vote on the motion offered by Mr. R. Hornsby.

Discussion ensued and questions arose as to whether consistent policy and procedure was used in appointing the above members to various boards, committees and commissions, with some Council members inquiring whether or not the uniform policy discussed will be enforced "across the board" or if the Council can deviate from policy when agreed upon.

Council Clerk C. Poché explained that items are placed under the agenda category "Vacancies" upon notification of upcoming term expirations from Staff, and when notice of resignation by an individual from a Council-appointed position is received by the Council Clerk's Office. She said that the Council then has the option to open nominations and advertise these positions, or to appoint if timely and valid documentation has been received from individuals interested in filling these positions.

At this time in the proceedings, the Council Chairwoman relinquished her chair to the Vice-Chairman.

Discussion ensued with several Council members concurring that some kind of uniformity should exist when making appointments that have been previously publicized, and that the Council should not deviate from the policy unless first voted upon.

Council Clerk C. Poché suggested that omitting from the agenda information on individuals who are interested in serving may keep the policy regarding "Vacancies" consistent.

At this time in the proceedings, the Council Chairwoman resumed the chair position.

• Councilman D. Babin commended the Public Works Department for all of their hard work during the recent rain event

- Councilman D. Babin noted the recent article published in the *Courier* about the Houma Navigation Canal "Bubba Dove Floodgate" and the effects that it will have on Terrebonne Parish this hurricane season
- Councilman D. Babin reminded everyone that hurricane season is approaching and that now is the time to get prepared
- Councilwoman C. Duplantis-Prather announced to the residents and/or constituents of District 5 that she will be meeting with Parish President M. Claudet and the Drainage Department to find out about ongoing projects in their areas that may help alleviate the flooding problem
- Councilman R. Hornsby announced that Recreation District No. 2,3 has agreed to provide the funding (\$140,000.00) for an Adaptive Park which will be incorporated into the plans for Summerfield Park. He thanked Mr. Gary Besson, Mr. Ivy Bernard, Mr. Ray LeCompte, and Mr. John Disalvo for all of their support in this endeavor

Councilwoman A. Williams exited the proceedings at this time (7:24 p.m.).

Councilwoman C. Duplantis-Prather exited the proceedings at this time (7:25 p.m.).

- Councilman D. Guidry announced the Annual Veterans' Day Celebration to be held on Monday, May 27<sup>th</sup> beginning at 10:00 a.m. at the Regional Military Museum
- Councilwoman B. Amedée announced that she is participating in a fundraiser entitled "Over the Edge for Adoption" to be held on May 31<sup>st</sup> in Baton Rouge, LA and challenged others to get involved to bring attention to adoption needs
- Councilwoman B. Amedée inquired of Administration about the "striping" work that was performed on St. George Road prior to the completion of the overlay project. Parish President Claudet said that he would get an updated status on this project, and provide her with the pertinent information.
- Councilman R. Hornsby thanked Mr. D. Babin, Mr. D. Guidry and Mr. Chris Pulaski for all of their help with plans for the Adaptive Park.

Under Agenda Item 6B, Announcements -Parish President:

- Construction work is being done on Industrial Blvd. near Chabert Medical Center to widen the lanes and to install a traffic signal on Denley Road.
- The St. Louis Bayou contract has been awarded and there have been some delays, but work should begin shortly.
- The CCC Ditch Expansion from Bayou Gardens Blvd. to Coteau Road Project is currently being advertised for bid receipts.
- Three permits for the construction of parish levees have been submitted for Corps of Engineers approval: the Ward 7 Levee that begins at the Boudreaux Canal extending to Thompson Road, the Grand Caillou Road Levee from the Ashland Dump extending to Thompson Road; and the East Dularge Levee.
- Coalitions and steering committees have been formed to make the appropriate changes to the Biggert-Waters Act, dealing with the probability of drastic increases in flood insurance rates for residents of coastal areas.
