Council Chairwoman B. Amedée recognized La. Senator R. L. "Bret" Allain, who presented the Council and the Administration with a brief synopsis of the recent Legislative Session, highlighting some of the bills that he authored and that were passed. He noted Senate Bill No. 6 (a bill that provides additional protection for the shipbuilding and marine industries), the Sunshine Bill (a bill that gives the public a 30-day notice before a sales tax or a property tax can be passed) and the Rigs to Reef Program, also known as the Artificial Reef Program, that now has its funding protected under the Constitution. He also discussed a Senate Concurrent

Resolution to memorialize Congress to amend the Biggert-Waters Act to prevent unreasonable increases in flood insurance rates.

Senator Allain also gave a brief synopsis of the additional funding that will be allotted to Terrebonne Parish for capital outlay projects, which would include the Morganza to the Gulf Project, the Terrebonne Sports Complex, La. Hwy. 1 Improvements, the South Lafourche Levee District, Terrebonne Port Commission, Nicholls State University and Fletcher Technical Community College for their Integrated Petroleum Technical Program and their Diesel Marine Center, Company Canal, Bayou Terrebonne Broadwalk, the Emergency Operations Center for Terrebonne Parish and the St. Louis Canal Project.

Several Council Members thanked Senator Allain for being a positive voice for Terrebonne Parish, and for working to get projects funded. The Council also thanked Legislators Gordon Dove, Lenar Whitney, Norby Chabert and "Joe" Harrison for their contributions.

ORDINANCE NO. 8306

AN ORDINANCE AMENDING THE PARISH CODE OF TERREBONNE PARISH, CHAPTER 18, ARTICLE IV. OPERATION OF VEHICLES, DIVISION 3. CITY, SECTION 18-120 TO ESTABLISH A "3-WAY STOP" AT THE INTERSECTION OF LEONA AND SYLVIA STREETS, AND TO AUTHORIZE THE INSTALLATION OF SAID SIGNS; AND TO ADDRESS OTHER MATTERS RELATIVE THERETO.

SECTION I

BE IT ORDAINED by the Terrebonne Parish Council, in regular session convened, acting pursuant to the authority invested in it by the Constitution and laws of the State of Louisiana, the Home Rule Charter for a Consolidated Government for Terrebonne Parish, and including, but not limited to, LSA R.S. 33:1368 and other statutes of the State of Louisiana, to amend the parish

Code of Terrebonne Parish, Chapter 18, Article IV, and Section 18-120 to create a " 3 WAY STOP" at the intersection of Leona and Sylvia Streets, as follows:

CHAPTER 18, Motor Vehicles and Traffic ARTICLE IV, Operation of Vehicles DIVISION III, City SECTION 18-120

(a) Through (c) remain the same

(d) *Three-way stop intersections*. Persons operating vehicles on the following streets shall stop such vehicles at the named intersections, which are designated as three-way stop intersections:

(ADD TO LIST) Leona Street and Sylvia Street

SECTION II

The intersection of Leona Street and Sylvia Street shall be declared as a "3 Way Stop" intersection, and appropriate "STOP" signs shall be erected and maintained along said roadways. Any vehicle traveling on Leona Street and/or Sylvia Street shall adhere to the provisions of this ordinance.

SECTION III

If any word, clause, phrase, section or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections or other portions of this ordinance shall remain in full force and effect, the provisions of this section hereby being declared to be severable.

SECTION IV

Any ordinance or part thereof in conflict herewith is hereby repealed.

SECTION V

This ordinance shall become effective upon approval by the Parish President or as otherwise provided in Section 2-13 (b) of the Home Rule Charter for Consolidated Government for Terrebonne Parish, whichever occurs sooner.

ORDINANCE NO. 8307

AN ORDINANCE TO AMEND THE 2013 ADOPTED OPERATING BUDGET AND THE 5 YEAR CAPITAL OUTLAY BUDGET OF THE TERREBONNE PARISH CONSOLIDATED GOVERNMENT FOR THE FOLLOWING ITEMS:

- I. MARMANDE LEVEE REPAIRS (CONTRACTOR REPAIRS), \$50,000
- II. ST. LOUIS CANAL DRAINAGE, \$253,106

SECTION I

WHEREAS, the Drainage Contractor performs various repairs to drainage resources, and

WHEREAS, repairs to the Marmande Levee is estimated to cost \$50,000, and

WHEREAS, funds remaining in the Concord Road Levee Project is sufficient to cover those costs.

BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2013 Adopted Budget and Five Year Capital Outlay of the Terrebonne Parish Consolidated Government, be amended to transfer funds to cover the cost of repairs to the Marmande Levee. SECTION II

WHEREAS, the Governor's Office of Homeland Security and Emergency Preparedness has approved and executed a Hazard Mitigation Grant Program Project HMGP under FEMA-4041-DR-LA, in the amount of \$253,106 for the St. Louis Can Drainage Project (Westview Blvd and St. Louis Canal Road), and

WHEREAS, the Parish has the 25% local share from \$100,000 available in the Project Account.

BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2013 Adopted Budget and Five Year Capital Outlay of the Terrebonne Parish Consolidated Government, be amended to recognize the Federal Grant Funding for the St. Louis Canal Drainage Project. ORDINANCE NO. 8308

AN ORDINANCE AMENDING CHAPTER 8, ARTICLE 11 SECTION 8-22(E) OF THE PARISH CODE, AND ADDING TO SAID SECTION A PARAGRAPH TO BE DESIGNATED AS (F) TO PROVIDE FOR AN INCREASED BOARD OF COMMISSIONERS TO SERVE AS GOVERNING AUTHORITY FOR THE BAYOU CANE FIRE PROTECTION DISTRICT, AND PROVIDING FOR OTHER MATTERS RELATIVE THERETO.

WHEREAS Louisiana Revised Statute 40:1495 grants the Terrebonne Parish Council the authority to serve as the governing body of a created Fire Protection District or to appoint a Board of Commissioners to serve as the governing body for the district;

WHEREAS, Act No. 135 (Enrolled) of the 2013 Louisiana Legislature, enacts R.S. 40:1496(B)(5)(c), and authorizes an increase in the membership of the governing board of the Bayou Cane Fire Protection District, to consist of seven members;

WHEREAS the Council wishes to expand the Board of Commissioners to serve as the governing body for the Bayou Cane Fire Protection District;

NOW THEREFORE BE IT ORDAINED by the Terrebonne Parish Council, in regular session convened and on behalf of the Terrebonne Parish Consolidated Government that:

SECTION I

Chapter 8. FIRE PROTECTION AND PREVENTION, Article 11. Fire Protection Districts, Section 8-22(C) is hereby amended to read as follows:

Section 8-22. Powers, governing bodies.

(a) through (d) remain the same

(e) In accordance with R.S. 40:1495 and 1496, five-member governing boards of the Bayou Blue Fire Protection District, Bayou Cane Fire Protection District, Coteau Fire Protection District, Schriever Fire Protection District and Village East Fire Protection District are hereby created. The duties and responsibilities of said district boards shall be found in R.S. 40:1498-1500 et seq.

(f) In accordance with R.S. 40:1496(B)(5)(c), a seven-member governing board of the Bayou Cane Fire Protection District is hereby created. The duties and responsibilities of said district board shall be found in R.S. 40:1498-1500 et seq.

BE IT FURTHER ORDAINED that, as authorized by the above referenced Legislation, it is hereby provided that the parish governing authority appoints the two additional members and shall provide for the initial terms of such additional members.

SECTION II

If any word, clause, phrase, section or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections and other portions of this ordinance shall remain in full force and effect, the provisions of this ordinance hereby being declared to be severable.

SECTION III

This ordinance shall become effective at 12:01 a.m. on August 1, 2013. This ordinance, having been introduced and laid on the table for at least two weeks, was voted upon as follows:
