ORDINANCE NO. 9502

AN ORDINANCE AUTHORIZING THE PARISH PRESIDENT TO EXECUTE AN INTERGOVERNMENTAL AGREEMENT WITH THE HOUMA RESTORATION DISTRICT TO PROVIDE ACCESS FOR THE DISTRICT TO TPCG-OWNED AND/OR OPERATED PUBLIC SPACES FOR PURPOSES OF THE MAINTENANCE OF VEGETATION, REMOVAL OF TRASH OR WEEDS, AND REGULAR BEAUTIFICATION AND CLEANUP OF THOSE PUBLIC SPACES IN HOUMA, LOUISIANA.

WHEREAS, LA R.S. 33:1324, also known as the Local Services Act, provides that any parish or political subdivision of the state may make agreements between or among themselves to engage jointly in the acquisition or improvement of any public project or improvement provided that at least one of the participants to the agreement is authorized under a provision of law to perform such activity for completion of the undertaking; and

WHEREAS, the HRD was created by the Louisiana Act 352 of the 2022 Legislative Session, codified as La. R.S. 33:4709.31, as may be amended, for the primary purposes of providing for restoration and preservation of the character of the area within the jurisdiction of the District, providing opportunity for cultural events, and encouraging economic development within the jurisdiction of the District that is consistent with the District's plan.; and

WHEREAS, HRD wishes to facilitate economic development, cultural events, and restoration of the areas within its jurisdiction by providing regular cleanup and attention to vegetation in the public spaces within its jurisdiction through a contract with a third party; and

WHEREAS, HRD, therefore, desires to obtain authority from the TPCG to have its contractor perform those services in and on TPCG-owned and/or operated public spaces situated within the jurisdiction of the HRD; and

WHEREAS, TPCG wishes to authorize such access, and the Parties agree to cooperate for the public purposes set forth herein; and

WHEREAS, the Terrebonne Parish Charter at Section 2-11 (11) requires Council approval in the form of an ordinance for the conveyance of any property rights owned by the TPCG; and

WHEREAS, a copy of the proposed agreement is attached to this ordinance and incorporated herein;

NOW THEREFORE BE IT ORDAINED that the Terrebonne Parish Consolidated Government hereby authorizes its Parish President or his designee to execute the attached intergovernmental agreement, or one materially similar, on behalf of the Terrebonne Parish Consolidated Government with the Houma Restoration District, subject to legal department approval.

This ordinance shall become effective upon approval by the Parish President or as otherwise provided in Section 2-13(b) of the Home Rule Charter for a Consolidated Government for Terrebonne Parish, whichever occurs sooner.

ORDINANCE NO. 9503

AN ORDINANCE TO AMEND THE 2023 ADOPTED OPERATING BUDGET AND 5-YEAR CAPITAL OUTLAY BUDGET OF THE TERREBONNE PARISH CONSOLIDATED GOVERNMENT FOR THE FOLLOWING ITEMS AND TO PROVIDE FOR RELATED MATTERS.

- I. FMA FLOOD MITIGATION, \$953,245
- II. LA. 24 SIDEWALK REHAB PROJECT, \$28,887
- III. CIVIC CENTER SIDEWALK PROJECT, (\$14,782)
- IV. LOUISIANA HIGHWAY SAFETY COMMISSION GRANT AWARD, \$77,940
- V. HOUMA POLICE DEPARTMENT, \$35,241

SECTION I

WHEREAS, the Terrebonne Parish Consolidated Government applied for funding allocated as a result of the yearly Flood Mitigation Assistance (FMA) program through the Federal Emergency Management agency (FEMA) and the National Flood Insurance Program (NFIP), and

WHEREAS, by communication from the GOHSEP dated May 2, 2023, the Terrebonne Parish Consolidated Government has been notified that its application for federal assistance allocated to elevate repetitive loss structures was approved by FEMA September 1, 2022, and

WHEREAS, the approved funding under FMA-PJ-06-LA-2020-0003 to elevate or otherwise mitigate approximately three (3) flood damaged structures in the Parish for \$953,245, and

WHEREAS, the Governor's Office of Homeland Security and Emergency Preparedness (GOHSEP) is the grantee under this Flood Mitigation Assistance Program, and

WHEREAS, Terrebonne Parish Consolidated Government is a subgrantee.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2023 Adopted Operating Budget be amended for the Flood Mitigation Assistance Program. (**Attachment A**)

SECTION II

WHEREAS, Administration is requesting additional funding of \$28,887 to the La. 24 Sidewalk Rehab Project, and

WHEREAS, the funding is from the Civic Center Sidewalk Project.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2023 Adopted Operating Budget and 5-Year Capital Outlay Budget be amended for the LA. 24 Sidewalk Rehab Project. (**Attachment B**)

SECTION III

WHEREAS, the La. Highway Trust Fund-DOTD has de-obligated funds of \$14,782 for the Civic Center Sidewalk Project due to the project being complete, and

WHEREAS, the funds will be decreased from the Civic Center Sidewalk Project account.

NOW, THEREFORE BE IT ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2023Adopted Operating Budget and 5-Year Capital Outlay Budget be amended for the Civic Center Sidewalk Project. (**Attachment C**)

SECTION IV

WHEREAS, the Houma Police Department of the Terrebonne Parish Consolidated Government has been approved for a grant from the Louisiana Highway Safety Commission (LHSC) for the Federal Fiscal Year 2022/2023 LHSC Grant in the amount of Seventy-seven Thousand Nine Hundred Forty dollars (\$77,940) for the Terrebonne Parish Consolidated Government, and

WHEREAS, the Federal Fiscal Year 2022/2023 LHSC will provide grant funding to improve the effectiveness and safety of our Police Officers by providing them with overtime to address highway safety issues.

NOW, THEREFORE BE IT FURTHER ORDAINED, that the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2023 Adopted Operating Budget be amended for the Houma Police Department. (**Attachment D**)

SECTION V

WHEREAS, the Houma Police Department received \$35,241 for vehicles sold at auction, and

WHEREAS, these funds will be placed into the Other Fees account.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2023 Adopted Operating Budget be amended for the Houma Police Department. (Attachment E)

SECTION VI

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, hereby authorizes Gordon Dove, Parish President, to execute any and all documents for these amendments as approved by the legal department.

If any work, clause, phrase, section, or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections, and other portions of this ordinance shall remain in full force and effect, the provisions of this ordinance hereby being declared to be severable.

This Ordinance shall become effective upon approval by the Parish President or as otherwise provided in Section 2-13(b) of the Home Rule Charter for a Consolidated Government for Terrebonne Parish, whichever occurs sooner.

The Chairwoman declared the motion adopted.

The Chairwoman recognizes Captain Kendra Arenson, a Plaquemine Parish, who shared her concerns regarding the impacts of foreign imports and other challenges on local shrimping industries. She then asked the Council to support the resolution as a measure to address these and other concerns.

At Mr. D. J Guidry request, the Chairwoman recognized Ms. Kim Chauvin resident, who gave an overview of the federal assistance and subsidies once provided to the shrimping industry. She then gave an overview of the active task forces and lobbyist groups representing shrimping industries and noted additional challenges being faced by shrimping industries including environmental and health concerns.

Discussion ensured relative to other parishes requesting similar action from state and federal legislation and available assistance through state or federal programs.

At the Chairwoman's request, Mr. Cohen Guidry, Terrebonne Economic Development Authority Director, shared that a study would be competed regarding economic impacts of local shrimping industries within formation from the Louisiana Department of Wildlife and Fisheries.

Discussion continued relative to plans and necessary support for future shrimping and other seafood industry opportunities. (*RESOLUTION ADOPTED AFTER DISCUSSION)

RESOLUTION NO. 23-301

A RESOLUTION URGING THE U.S SECRETARY OF COMMERCE AND THE U.S. TRADE REPRESENTATIVE TO IMPLEMENT THE EXISITING MEASURES TO LIMIT THE OVERALL VOLUME OF IMPORTED SHRIMP IN AMERICA IN ORDER TO ENSURE THE SURVIVAL OF OUR DOMESTIC WILD CAUGHT SHRIMP HARVESTERS AND AMERICA'S ACCESS TO WILD HARVESTED SHRIMP FROM DOMESTIC WATERS; URGING THE COMMISSIONERS OF THE INTERNATIONAL TRADE COMMISSION, WHEN CONSIDERING IMPORTS TO INCLUDE ALL FORMS OF SHRIMP FROM ALL COUNTRIES; AND OTHERWISE TO PROVIDE WITH RESPECT THERETO.

WHEREAS, the influx of imported shrimp in America has resulted in the catastrophic collapse of the domestic shrimp industry; and,

WHEREAS, many boat owners/operators has been docked thereby creating significant challenges to our local economy and the countless individuals who rely on this sector; and,

WHEREAS, the Northern Gulf of Mexico has historically been a thriving hub for shrimp production, with rich waters and a favorable climate creating optimal conditions for shrimp stocks and harvest; and,

WHEREAS, imported shrimp now dominates cold storage, distribution hubs and the American market at a level that voids the margin of the market the domestic harvesters are able to fulfill; and,

WHEREAS, if action is not taken, not only will small family fishing businesses owners go under but, also businesses with which we conduct commerce with will go under. Furthermore, working waterfront and land-based fishery infrastructure will be lost, thereby losing access to this wild caught food source; and

WHEREAS, the consequences of the inundation of imported shrimp into our markets have caused immense disruption and economic instability for our local shrimp producers, including the risk of closure or already being shut down. The loss also extends to the loss of livelihoods and the socio-economic well-being of the communities reliant of this industry.

NOW THEREFORE, BE IT RESOLVED, that the Terrebonne Parish Council, the governing authority, urges the U.S. Secretary of Commerce and the U.S. Trade Representative to implement the existing measures to limit the overall volume of imported shrimp in America in order to ensure the survival of our domestic wild caught shrimp harvesters and America's access to wild harvested shrimp from domestic waters; and urging the Commissioners of the international Trade Commission, when considering imports, to include all forms of shrimp from all countries.

He then suggested that recreation districts could provide insurance as available for vendors sponsoring free events or donating services for events.

Discussion ensued relative to recreation districts co-sponsorship events that would provide free items or services to the public as part of their programming and providing applicable insurance coverage.

The Chairwoman recognized Parish Attorney Julius Hebert who gave an overview regarding the expenditure of public funds and co-sponsorship policies practiced by the Parish. He then shared several concerns regarding outside entities operating on public property such as a recreation district facility and the need for appropriate insurance coverage being in place for them to operate. Mr. Hebert then suggested that entities interested in hosting an event and in need of insurance coverage could request assistance at the recreation district level provided they complete associated paperwork similar to the Parish's co-sponsorship procedures to establish goals and expected benefits.

At Mr. S. Trosclair's request, Chief Financial Officer Kandace Mauldin clarified that the Parish purchases special event insurance policies for its co-sponsored events if insurance assistance is requested.

Discussion continued relative to researching methods for recreation districts to provide insurance coverage for events and other concerns through the Recreation Subcommittee.

The Chairwoman recognized Mr. Justin Solet, a Houma resident, who shared his concerns regarding wetland preservation and requested that a moratorium be placed on carbon capture and sequestration surveys, evaluations, and seismic testing. He then shared his intent to hold community meetings to inform the public about carbon capture and sequestration processes and encouraged the Council to attend.
