# **AUGUST 14, 2013**

The Chairwoman, Ms. B. Amedée, called the meeting to order at 6:04 p.m. in the Terrebonne Parish Council Meeting Room. Following an Invocation, offered by Councilman D. Babin, Councilman J. Navy led the Pledge of Allegiance.

Upon roll call, Council Members recorded as present were: G. Hood, Sr., B. Amedée, C. Duplantis-Prather, D. Babin, D. Guidry, P. Lambert, and J. Navy. Mr. R. Hornsby was absent due to an out-of-town business commitment and Ms. A. Williams was absent due to emergency family matter. A quorum was declared present.

The Council Chairwoman read aloud a memo from Councilman R. Hornsby explaining that his absence from tonight's proceedings was due to an out-of-town business commitment.

The Council Chairwoman read aloud a memo from Councilwoman A. Williams explaining that her absence from tonight's proceedings was due to a family emergency.

Ms. C. Duplantis- Prather moved, seconded by Mr. J. Navy, "THAT, the Council approve the minutes of the Regular Council Session held on 07/10/13."

The Chairwoman called for a vote on the motion offered by Ms. C. Duplantis-Prather.

Councilwoman C. Duplantis-Prather read aloud a proclamation congratulating Cardiovascular Institute of the South (CIS) and Terrebonne General Medical Center (TGMC) for a 30-year partnership in the Houma-Terrebonne community.

Dr. Craig Walker, MD, thanked the Council and the Administration for this honor and for giving him, along with other doctors and medical professionals, the platform needed to provide innovative health care for this region as well as throughout the world.

At this time, Councilman R. Hornsby entered the proceedings (6:12 p.m.).

Ms. Phyllis Peoples, Terrebonne General Medical Center CEO, thanked the Council and the Administration for this gesture and reiterated to Terrebonne Parish, the surrounding

communities and the entire world that their primary goal and devotion is, and will continue to be, their commitment to cardiovascular health.

Several Council members thanked Dr. Walker for his continued commitment, his renowned vision and for redefining cardiovascular techniques worldwide throughout his career; and Terrebonne General Medical Center for being an asset to the community as well.

Mr. D. Babin moved, seconded by Mr. D. Guidry, "THAT, the Council introduce an ordinance authorizing the issuance of \$938,400.00 of Sewer Revenue Bonds, Series 2013, of the Parish of Terrebonne, and providing for all matters relative thereto; and calling a public hearing on said matter on Wednesday, August 28, 2013 at 6:30 p.m.

Ms. McBride mentioned that after reading an article in the *Tri-Parish Times* she was appalled. She explained that the wording in the article and the person and/or person(s) interviewed gave a "bad" image of Terrebonne Parish and the comments were immoral, inhuman and insensitive, as they relate to the defense of TPCG in the ongoing litigation.

Mr. D. Guidry moved, seconded by Mr. J. Navy, "THAT, the Council extend Ms. Lucretia McBride's time an additional minute."

Ms. McBride continued that she would like for the Council and the Administration to take a leadership role and have the parish official's quotes extracted from the records because the language used is not an "appropriate" line of defense when litigating a lawsuit, in her opinion.

The Council Chairwoman acknowledged Ms. Carolyn McNabb, a Terrebonne Parish attorney, who addressed the Council relative to the matter of "Parish litigation: Mary Doe vs. TPCG" and the aforementioned the article published in *Tri-Parish Times*. Ms. McNabb read several quotes from the newspaper article and explained that after reading it, she sent the person who made the accusations and/or "quotes" a memorandum asking to have the language extracted from litigation documents.

Mr. D. Guidry moved, seconded by Ms. C. Duplantis-Prather, "THAT, the Council extend Ms. Carolyn McNabb's time an additional minute."

ORDINANCE NO. 8322

AN ORDINANCE DEDICATING AND ACCEPTING THE MAINTENANCE/OPERATION OF THE STREET(S), DRAINAGE SERVITUDES, UTILITIES, GAS, SEWER, AND RIGHTS-OF-WAY FOR "SUMMERFIELD PLACE SUBDIVISION, ADDENDUM NO. 17, PHASE C"; ENERGIZE AND ACCEPT THE STREET LIGHTS; AND TO INCORPORATE "BRIANNA DRIVE" AND THE EXTENSIONS OF "CALEB DRIVE", "JULIETTE DRIVE", AND "VIOLA STREET"; AND TO INCORPORATE INTO THE ENHANCED 911 EMERGENCY RESPONSE SYSTEM FOR THE PURPOSE OF PROVIDING A BETTER MEANS OF LOCATING ADDRESSES; AND TO SET FORTH AN EFFECTIVE DATE FOR THE INCORPORATION OF STREET NAME(S), TO INFORM THE PROPER AGENCIES OF THE STREET NAME(S), AND TO AUTHORIZE THE INSTALLATION OF THE APPROPRIATE STREET SIGN(S), AND TO ADDRESS OTHER MATTERS RELATIVE THERETO.

## **SECTION I**

BE IT ORDAINED that the Terrebonne Parish Council, on behalf of Terrebonne Parish Consolidated Government, dedicates and accepts the maintenance/operation of the street(s), drainage servitudes, utilities, gas, sewer, and rights-of-way; and energize and accept the street lights as depicted on a plat, prepared on June 22, 2013, revised April 22, 2013, by GSE Associates, LLC titled "Summerfield Place Subdivision, Addendum No. 17, Phase C", a copy of which is attached hereto and made a part hereof;

BE IT FURTHER ORDAINED effective on the 21<sup>st</sup> day of August, 2013, that "Brianna Drive" and the extensions of "Caleb Drive", "Juliette Drive", and "Viola Street" be incorporated into the Enhanced 911 Emergency Response System;

BE IT FURTHER ORDAINED that a copy of this ordinance be submitted to the Terrebonne Parish Communications Board, local U.S. Postal Services, fire districts, Acadian Ambulance, Terrebonne Parish Sheriff's Office, and any other appropriate agency; and

BE IT FURTHER ORDAINED that the Parish Forces be directed to install the proper street sign on the appropriate street, and that any other actions relative thereto be addressed.

## **SECTION II**

If any word, clause, phrase, section or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections or other portions of this ordinance shall remain in full force and effect, the provisions of this section hereby being declared to be severable.

ORDINANCE NO. 8323

AN ORDINANCE TO AMEND THE 2013 ADOPTED OPERATING BUDGET AND THE 5 YEAR CAPITAL OUTLAY BUDGET OF THE TERREBONNE PARISH CONSOLIDATED GOVERNMENT FOR THE FOLLOWING ITEMS:

- I. SUMMERFIELD PUMP STATION, \$77,593
- II. LOUISIANA LAND TRUST PROGRAM, \$139,057
- III. ATCHAFALAYA LONG DISTANCE SEDIMENT PIPELINE, \$1,500,000
- IV. COUNCIL ON AGING, \$92,350

#### **SECTION I**

WHEREAS, the Parish recently received bids for the Southdown/Summerfield Watershed Project which is higher than the current estimate, and

WHEREAS, the Parish has funds available from the Savanne Road Drainage Project to cover the underfunded Summerfield Pump Station Project in the amount of \$77,593.

BE IT ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2013 Adopted Budget Terrebonne Parish Consolidated Government, and Five-Year Capital Outlay to provide the additional funding for Summerfield Pump Station Project. (Attachment A)

## **SECTION II**

WHEREAS, the Louisiana Land Trust (LTT) is a non-profit organization formed to manage the properties that have been purchased by the State under the Road Home Program as part of the ongoing recovery effort from the damage caused by Hurricanes Katrina and Rita in 2005, and

WHEREAS, Louisiana Housing Corporation has approved the application allowing the Parish to use \$139,057 in LLT program income as additional funds to their existing First Time Homebuyer Program.

BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2013 Adopted Budget of the Terrebonne Parish Consolidated Government, be amended to recognize the \$139,057 from the Louisiana Land Trust for the First Time Homebuyer Program. (Attachment B)

# SECTION III

WHEREAS, critical marshes in central and eastern Terrebonne Parish have become sediment and nutrient deficient calling for the need of the Atchafalaya Long Distance Sediment Pipeline Project, and

WHEREAS, the funds allocated to this project shall be used to advance the design of a sediment pipeline to transport sediments dredged from the areas of the Atchafalaya Basin Area eastward into the critical sediment deficient marshes of central and eastern Terrebonne Parish, and

WHEREAS, the Coastal Protection and Restoration Authority (CPRA) and the Parish has entered into an Intergovernmental Agreement (Resolution No. 13-219) regarding the Atchafalaya Long Distance Sediment Pipeline Project in the amount of \$750,000, and

WHEREAS, the Parish is also funding \$750,000 from its Coastal Restoration Projects.

BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2013 Adopted Budget and the 5 Year Capital Outlay of the Terrebonne Parish Consolidated Government, be amended to recognize the funding for the Atchafalaya Long Distance Sediment Pipeline Project . (Attachment C)

## **SECTION IV**

WHEREAS, the Terrebonne Council on Aging (TCOA) through the Parish was initially awarded funds from DOTD for the Federal Transit Authority ARRA funds in the amount of \$858,555 (Ordinance No. 8274), and

WHEREAS, the Parish has been notified that the DOTD has increased this award in the amount of \$92,350 which will be used for the Vehicle Garage and Bus Washer, and

WHEREAS, these funds will be used to reimburse TCOA for the garage with a vehicle buswashing system.

BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government that the 2013 Adopted Budget of the Terrebonne Parish Consolidated Government be amended for the Terrebonne Council on Aging. (Attachment D)
