WHEREAS, SCPCD, in accordance with the Department of Homeland Security/GOHSEP Grant Number 2011-SS-00124-SO1, desires to deliver possession and ownership to TPCG of access control system, radios and accessories, tactical and medical equipment, hazmat equipment, and other emergency preparedness equipment, in consideration of the TPCG immediately putting them to full use in such a manner to achieve the purpose described above; and

WHEREAS, the TPCG requires such equipment to be better prepared in emergency situations; and

WHEREAS, SCPCD would like to donate its equipment to the TPCG for the purpose listed above;

WHEREAS, the Terrebonne Port Commission may own, construct, acquire, operate and maintain docks, wharves, landings, etc. necessary or useful for port, harbor and/or terminal purposes, and

WHEREAS, Terrebonne Port Commission has become a true leader and economic driver for Terrebonne Parish and our region, and

WHEREAS, Terrebonne Parish Consolidated Government (TPCG), and TPC have common interests in the accomplishment of the aforementioned mission which serves a public purpose commensurate with the costs, and

WHEREAS, the TPCG has become aware of the recent incorporation of the Terrebonne Port Commission Economic Development Corporation ("Corporation"), and

WHEREAS, the Corporation was created to "manage, program, and operate an organization for the coordination of economic development, research, marketing, program development, project transaction, and other initiatives in furtherance of promoting and executing effective economic revitalization and growth policies and strategies on behalf of the Terrebonne Port Commission", and

WHEREAS, the Corporation has authority to exempt certain economic development projects from local sales and property taxes as a form of incentive, and

WHEREAS, such exemptions may impact the delivery of services by various districts, boards, and commissions in the Parish, and

WHEREAS, TPCG is the local governing authority of the Parish of Terrebonne, and is responsible for the overall health, safety and welfare of the residents of the parish, and

WHEREAS, TPCG believes that it should have a role in the determination whether the offering of any such incentives strike the proper balance between the benefits and costs to the public

NOW THEREFORE BE IT RESOLVED, by the Terrebonne Parish Council (Budget and Finance Committee), on behalf of the Terrebonne Parish Consolidated Government, that the Terrebonne Port Commission and the Port Commission Economic Development Corporation obtain the concurrence of the governing authority of the Parish before any local tax exemption benefits are offered to economic development projects, and

BE IT FURTHER RESOLVED that it is the intent of Terrebonne Parish Consolidated Government to partner with the Terrebonne Port Commission and the Port Commission Economic Development Corporation to enact a policy for the use of such incentives that is consistent with the provisions of Section 24-3 of the Terrebonne Parish Code.

BE IT FURTHER RESOLVED that a certified copy of this resolution is forwarded to the Terrebonne Port Commission and the Terrebonne Port Commission Economic Development Corporation.

A review of the proposed 2014 Budget began on the following funds/departmental budgets:

a) **Council on Aging (Fund 510; Sm. Bk. 308)** – Chief Finance Officer Jamie Elfert highlighted the proposed 2014 Terrebonne Council on Aging (TCOA) Budget noting that the COA is an outside agency which receives tax revenue through Terrebonne Parish government; that the revenue is estimated to be \$5.3 million in 2014; that the funds are collected and distributed by the Parish; and that a copy of the COA's budget has been filed with the Parish due to their budget year ending in June, 2013.

Upon questioning by Committee Member C. Duplantis-Prather, TCOA Executive Director Diana Edmonson stated that the TCOA has considered future expansion of services to provide elderly daycare services on land adjacent to an existing COA facility. She then noted the need to provide elderly services beyond existing services. (NO ACTION TAKEN)

b) **TARC (Fund 279; Sm. Bk. 114; Big Bk. 342)** - Chief Finance Officer Jamie Elfert presented the proposed 2014 Terrebonne ARC Budget stating that Terrebonne ARC's Fiscal Year ended June 30, 2013; that the agency receives a 5.33 ad valorem millage tax which generates approximately \$4.3 million annually; that the Parish Government has a Cooperative Endeavor Agreement with Terrebonne ARC to provide program services to clients; that the Parish pays Terrebonne ARC \$5 million for services rendered; and that there are no changes in the proposed budget.

The Chairman noted discussion with Terrebonne ARC with regards to providing the Recreation District No. 11 with adaptive park equipment, if agreed upon.

Terrebonne ARC Executive Director Mary Lynn Bisland stated that Terrebonne ARC's millage comes up for renewal in November and that Terrebonne ARC is the only agency in Louisiana which provides the number and the quality of services to clients.

Committee Member R. Hornsby commended Terrebonne ARC for its participation in Leadership Terrebonne's community awareness program and requested that the agency continue to participate.

Ms. Bisland stated that she has spoken with Leadership Terrebonne's facilitator with regards to Terrebonne ARC participating in the community awareness program annually and then added that, due to State provision, Terrebonne ARC can not give away, sell or donate equipment, but may enter into an Intergovernmental Agreement to allow Recreation District No. 11 to utilize the adaptive park equipment; and that there are three sets of adaptive park equipment for handicapped children that are no longer being used by Terrebonne ARC clients. (NO ACTION TAKEN)

c) Terrebonne Levee & Conservation District (Fund 283; Sm. Bk. 129; Big Bk. 374) – Chief Finance Officer Jamie Elfert summarized the proposed 2014 Terrebonne Levee & Conservation District (TLCD) Budget highlighting that the TLCD receives a ¹/₄-cent sales tax which was approved by voters in November 2011; that TPCG provides the TLCD with \$3.8 million in funding for projects; that \$3.3 million is transferred to the Parish's bond sinking fund for payment of the TLCD bonds; and that the budget details TLCD's capital outlay projects under the miscellaneous section of the proposed TPCG 2014 budget.

TLCD Executive Director Reggie Dupre, Jr. stated that the TLCD would like to present a 20-minute power point presentation on various projects that have been undertaken; added that the TLCD can provide a detailed presentation at a later date; explained that the TLCD has many funding sources; and noted that the TLC receives \$6 million in annual revenue from the ¹/₄-cent tax. He continued that \$3.2 million is paid in bonded debt; that \$6 million is collected of which \$2.8 million is available for projects; that of the ¹/₂-cent sales tax, \$97 million has been bonded out, of which the

residual amount is \$5.7 million which is available for projects plus the ad valorem tax; and that the TLCD will have approximately \$12.3 million annually for operation which takes a little less than \$4 million, and the rest will be used for capital projects for flood control. Mr. Dupre then recognized TLCD Administrative Manager Angela Rains and Project Manager Mitch Marmande.

Ms. Rains presented slides with regards to the various TLCD funding sources; funding accounts; and projects.

Committee Member R. Hornsby requested that the TLCD consider using marine power to open the Bubba Dove floodgates and then requested a copy of the power point presentation given this evening.

Upon additional questions, Ms. Rains explained the operation and maintenance budget allocations for opening and closing floodgates.

Mr. Dupre clarified the process of determining when to open and close the Parish floodgates.

In response to questions regarding projects in the northwestern portion of the Parish, Mr. Dupre stated that Mr. Marmande has been directed to devise a blueprint for the Bayou Black and Gibson areas; that the plan will prioritize flood control needs and assess the first priority, especially around the Greenwood area.

Mr. Marmande stated that there is a lot of consideration being undertaken by the TLCD regarding work which has been completed on pipelines; that determination with respect to best routes will be considered; and that the plan is under design on an alignment which may not coincide with the U. S. Army Corps of Engineers' design. He added that some of the old barrier plan may be used for the alignment. (NO ACTION TAKEN)

The Chairman recognized Judge David Arceneaux who was present in the audience.

- d) City Court (Fund 151-120; Sm. Bk. 19; Big Bk. 12) Chief Finance Officer Jamie Elfert reviewed the proposed 2014 City Court Budget explaining that personnel changes include the elimination of one Juvenile Officer and three Deputy Clerks III and the addition of one Juvenile Case Manager; that the General Fund supplement is \$857,956.00 which is the same as 2013; and that there are no capital requests. (NO ACTION TAKEN)
- e) **District Court (Fund 151-121; Sm. Bk. 21; Big Bk. 13)** Chief Finance Officer Jamie Elfert highlighted the proposed 2014 District Court Budget noting that there is one change being proposed this evening; a capital request has been submitted for one new phones system \$21,000.00; a personnel reclassification of a part-time Administrative Technician to full-time, for which additional backup was submitted prior to the meeting; the judges will reimburse the Parish 50% of the salary and fringe benefits; the Parish will pick up an additional \$9,495.00 for the newly-budgeted position; the Judges will pick up \$26,291.00 for the new position; and the proposed budget is a 2.3% increase over the 2013 budget.

Chief Justice David Arceneaux thanked the Parish for what it does for District Court; noted that the Parish provides funding for one Judicial Coordinator and a Part-time Assistant which will now become a full-time position; added that the Parish also provides funding for the Court reporters; that there are 26 employees in the department; and stated that the proposal for a new phone system may save the Parish approximately \$18,000.00 in funding over 5 years. He noted only a small concern with regards to repairs and maintenance of the phone system if purchased, as opposed to leasing as is currently being done. (NO ACTION TAKEN)

f) Coroner's Office (Fund 151-205; Sm. Bk. 48; Big Bk. 45)– Chief Finance Officer Jamie Elfert presented the proposed 2014 Coroner's Office Budget explaining that the Coroner's budget details the transfer and supplement for operation; that a separate budget is adopted for operations; that \$762,000.00 in funding has been requested for 2014 which is the same as 2013; that a request for one generator - \$26,000.00 has been requested; and a personnel request for one additional investigator.

In response to questioning by Committee Member C. Duplantis-Prather, Coroner Victor Tedesco, M.D., stated that the design of the morgue did not include square footage for Administrative office space and that the Administrative office is located on Verret Street.

Committee Member C. Duplantis-Prather requested consideration of future funding for the expansion of the morgue to include administrative office space. (NO ACTION TAKEN)

- g) **Parish Farm Agent (Fund 151-654; Sm. Bk. 65; Big Bk. 69)** Chief Finance Officer Jamie Elfert summarized the proposed 2014 Parish Farm Agent stating that the budget includes an allocation of \$118,600.00 for State operations and that there are no significant changes. (NO ACTION TAKEN)
- h) **Emergency Preparedness (Fund 151-912; Sm. Bk. 68; Big Bk. 71)** Chief Finance Officer Jamie Elfert reviewed the proposed 2014 Emergency Preparedness Budget explaining that the budget includes an allocation of \$80,000.00 for the Administrative contract; and that a capital request has been submitted for a copier/scanner/printer to replace one of the older models.

Office of Homeland Security and Emergency Preparedness Executive Director Earl Eues thanked the Committee for supporting the office and stated that OEP has been vigilant in its preparation for storm and emergency events. (NO ACTION TAKEN)

i) Fire Department (Fund 204-222; Sm. Bk. 89; Big Bk. 100) - Chief Finance Officer Jamie Elfert highlighted the proposed 2014 Fire Department Budget summarizing that one of the largest changes is an increase in the Fire Fighters' retirement system, which has increased from 24.8% to 29.3%; for personnel a 2% mandated across-the-board increase; capital requests include an annual set aside of \$100,000.00 for their major truck program; gear - \$55,000.00; modular building for a day room (extra space at the north Houma Station) - \$30,000.00; remodeling the north Houma kitchen - \$5,000.00; upgrade windows at the north Houma station - \$8,000.00; the cumulative cost for the training field updates - \$68,000.00; firehouse software - \$6,000.00; which results in a 2% increase over the 2013 budget.

In response to Committee Member A. Williams's question with regards to Breast Cancer Awareness Month, Houma Fire Chief Todd Dufrene stated that the fire department promotes awareness by wearing navy blue shirts with pink lettering, but does not wear pink shirts nor does it have a pink fire truck. (NO ACTION TAKEN)

- j) Auditoriums (Fund 205-196; Sm. Bk. 93; Big Bk. 106) Chief Finance Officer Jamie Elfert presented the proposed 2014 Auditoriums Budget explaining that the Municipal Auditorium's budget contains no significant changes in personnel or capital; however, the budget contains an offset in revenue of \$35,000.00; Dumas Auditorium - \$5,750.00; and that there is a 3.9% increase in the proposed budget over 2013. (NO ACTION TAKEN)
- k) Parks & Grounds (Fund 205-501; Sm. Bk. 94; Big Bk. 109) Chief Finance Officer Jamie Elfert summarized the proposed 2014 Parks & Grounds Budget highlighting that the budget accounts for five parks: Coteau, Mandalay, Mulberry, Presque Isle, and Grand Bois Park; that the maintenance contract for grass cutting is estimated to be \$123,000.00 for 2014; and that the budget has an overall increase of 1.1% over 2013. (NO ACTION TAKEN)

 Grand Bois Park (Fund 205-524; Sm. Bk. 95; Big Bk. 11) – Chief Finance Officer Jamie Elfert reviewed the proposed 2014 Grand Bois Park Budget noting a capital request for one tractor bush hog - \$25,000.00.

Committee Member D. Babin inquired about Coteau, Mandalay, Mulberry, Presque Isle, and Grand Bois parks under the maintenance contacts.

Mrs. Elfert explained that the five parks are handled by the Parks and Grounds Department, however, the Grand Bois Park expenditures are placed in another account. (NO ACTION TAKEN)

m) Recreation Department (Fund 280; Sm. Bk. 117; Big Bk. 346) – Chief Finance Officer Jamie Elfert highlighted the proposed 2014 Parish wide Recreation Department Budget summarizing that that estimated revenue is \$1.7 million dollars; registration fees brings in \$91,250.00; Special Olympics fees \$20,000.00; a budget allocation of \$225,000.00 for summer camps has been proposed for 2014; one of the largest increases is for the cost of salaries and benefits for the officials and referees who are now employees of the Parish - \$92,000.00; and that the department is still within the budget at +5.62%. (NO ACTION TAKEN)

n) Civic Center (Fund 385-197; Sm. Bk. 167; Big Bk. 456) – Chief Finance Officer Jamie Elfert presented the proposed 2014 Civic Center Budget noting that the budget receives revenue from a dedicated hotel/motel tax which is estimated to bring in \$275,000.00 in 2014; most of its revenue comes from the General Fund supplement \$872,000.00; self-generated revenue is \$507,000.00; capital requests are for two desktop computers - \$2,100.00; and various audio and video equipment - \$19,334.00.00. (NO ACTION TAKEN)

- o) Finance/Purchasing Warehouse (Fund 380-154; Sm. Bk. 180; Big Bk. 239) Chief Finance Officer Jamie Elfert summarized the proposed 2014 Finance/ Purchasing Warehouse Budget stating that the Purchasing Division is an internal service account funded by allocation charges to the various departments; capital requests are for one laptop computer to replace an older model \$2,200.00; replace carpet in the halls and conference room \$6,000.00; and three portable radios \$5,400.00. She noted that the overall budget increase is 2.42% over 2013. (NO ACTION)
- p) Finance/Information Technology (Fund 390-192; Sm. Bk. 183; Big Bk. 463) Chief Finance Officer Jamie Elfert reviewed the proposed 2014 Finance/Information Technology Budget highlighting that the department is an internal service fund for which revenue is derived from various departments that utilize its services; there is an anticipated \$1.8 million in 2014 based on the services to be rendered; personnel request is the elimination of one Administrative Coordinator Grade 104, and addition of one Technical Coordinator Grade 108 to accommodate the workload for the Voice Over Internet Protocol which will begin in a month; capital requests are for one server hardware upgrade \$85,000.00 which is an annual set aside for a large purchase; seven personal computers \$15,400.00 which are rotated among personnel; hurricane shutters \$28,000.00; six tape drives \$12,000.00; two blade servers \$15,000.00; one multi-functional printer \$3,000.00; and a replication server \$8,000.00 in case overall communications fail. (NO ACTION TAKEN)

Mr. D. Babin moved, seconded by Mr. D. Guidry, "THAT, the Budget & Finance Committee continue the budget hearings until the next committee meeting."

Under Agenda Item 6 - Council Members Request Discussion Of:

Councilwoman Beryl Amedee discussed a need for clarification of the current Council policies as they relate to what is covered already and what is not covered, noting that 1) meeting notices and adding agenda items are covered under State Statute, 2) travel and phone reimbursements are covered under the Parish Code, and 3) vacancies and/or appointments to boards and commissions are covered under a combination of State Statutes and the Parish Code, depending upon which body created them through legislation (although some may need to be reviewed to alter terms and/or term limits).

Councilwoman Amedée then listed policies that are not clear, which include 1) duties of the Council Chair and the Vice-Chair, 2) process to follow when Council members need the help of the Council Staff with tasks that require more than a few minutes to complete, or with work that must be accomplished outside of regular (normal) business hours, 3) basic qualifications for the recognition of outstanding persons/organizations (via proclamations, commendations, keys to the Parish, etc), 3) Council Members handling common complaints from constituents in districts other than their own, and 4) Council Members relations' with other departments.

Discussion ensued, with several Council Members questioning the importance of changing the current Council policies, and what prompted this issue. Several Council Members noted that they were elected to represent different districts with different types of constituents, and asked for clarification as to the "basic qualifications" that will be required when awarding proclamations, commendations, keys to the Parish, etc.

(ACCOUNT #A06-31659) (200 KENNEDY DRIVE) WITH AN OWNER OF RECORD OF HORACE JOHNSON - 95% AND WILLIAM H. HARPER & WIFE - 5% AND TO ADDRESS OTHER MATTERS RELATIVE THERETO.

BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that Administration be hereby authorized to dispose of the property in accordance with LA R.S. 47:2196, *et seq.* and inclusive of the following terms.

SECTION I
