EMERGENCY ORDINANCE NO. 9434

AN EMERGENCY ORDINANCE TO AUTHORIZE AN EMERGENCY APPROPRIATION TO THE OPERATING BUDGET TO ALLOCATE NECESSARY EMERGENCY USE FUNDS IN ORDER TO REPAIR DAMAGE TO THE BAYOU TERREBONNE MITER GATE LOCK SYSTEM FOR THE PURPOSE OF PROTECTING THE LIFE, SAFETY, AND WELFARE OF CITIZENS OF TERREBONNE PARISH

SECTION 1

WHEREAS, On June 3, 2022, Parish President Gordon E. Dove declared a State of Emergency relative to preparation for the 2022 hurricane season, including repairing the Bayou Terrebonne Miter Gate Lock System, recorded in the Terrebonne Parish Courthouse, Book 2675, Page 491, Entry No. 1651682; and

WHEREAS, an Emergency Ordinance is allowed pursuant to the Terrebonne Parish Consolidated Government (TPCG) Charter 2-14; and

WHEREAS, an Emergency Ordinance is allowed to make emergency appropriations to the operating budget pursuant to the Terrebonne Parish Consolidated Government Charter Sec. 504 and Sec. 5-11; and

WHEREAS, the Bayou Terrebonne Miter Gate Lock System located in Montegut, was damaged when it was hit by a vessel on April 15, 2022; and

WHEREAS, the Lock System must be fixed in order to protect the life, safety, and welfare of the citizens of Terrebonne Parish; and

WHEREAS, TPCG needs to amend the operating budget, allocating Emergency Use Funds in the amount of eight hundred thirty-six thousand dollars (\$836,000.00), for the final design cost to repair the Lock System, which is more accurately shown on the attached "Opinion of Probable Construction Cost.

SECTION 11

NOW THEREFORE BE IT ORDAINED, that TPCG amends its operating budget, allocating the necessary Emergency Use Funds, eight hundred thirty-six thousand dollars (\$836,000.00), in order to repair the Bayou Terrebonne Miter Gate Lock System; and

NOW THEREFORE BE IT ORDAINED, that the funds for this repair shall be appropriated from the Emergency Use Funds; and

BE IT FURTHER ORDAINED, that the TPCG Council, as governing authority of the parish, adopt this emergency ordinance because time is of the essence to repair the Bayou Terrebonne Miter Gate Lock System.

SECTION 111

If any word, clause, phrase, section, or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections and other portions of this ordinance shall remain in full force and effect, the provisions of this ordinance hereby being declared to be severable.

SECTION IV

Any ordinance or part thereof in conflict herewith is hereby repealed.

SECTION V

This ordinance shall become effective upon approval by the Parish President or as otherwise provided in Section 2-13(b) of the Home Rule Charter for a Consolidated Government for Terrebonne Parish, whichever occurs sooner.

At Mr. D. Babin's request, Chief Financial Officer Kandace Mauldin gave a brief update on the status of the Buquet Bridge and noted the repair costs. She then stated that due to the significant amount of damage, the Parish will proceed with replacing the bridge through FEMA reimbursement.

Several Council Members expressed their concerns for the estimated construction time of four to six years to replace the bridge and the need for certain roads experiencing heavier traffic and damages due to bridge outages.

RESOLUTION NO. 22-367

A resolution approving the 2022 Balancing Budget Adjustment and 2023 Budget Plan (Operations and Five-Year Capital Outlay) of the Terrebonne Parish Veterans Memorial District.

- 3. Submitting for voter approval any tax proposal.

4. Any other matter or action as determined by ordinance adopted by the Terrebonne Parish Consolidated Government, and

WHEREAS, the District was successful in the voters' renewal of a .5 mill property tax in 2015, and

WHEREAS, the District approved their 2022 final balancing budget amendment for their General Fund Operations, at their regular meeting of November 17, 2022, subject to Council Approval, and

WHEREAS, the District approved their 2023 Operations Budget at their regular meeting of November 17, 2022, subject to Council Approval.

NOW, THEREFORE BE IT RESOLVED by the Terrebonne Parish Council (Budget and Finance Committee), on behalf of the Terrebonne Parish Consolidated Government, to approve the Terrebonne Parish Veterans' Memorial District 2022 Final Balancing Budget adjustment and 2023 Budget Plan.

The Vice-Chairman recognized Terrebonne Council on Aging Executive Director and former Parish President Michel Claudet and former Councilman Wayne Thibodaux who were in the audience for the proceedings.

- At Mr. S. Trosclair's request, Ms. Wesley-Brown clarified that the waiting list for the program is for the members' safety with COVID-19 protocols still being followed.
- Mr. G. Michel shared his concerns regarding the proposed resolution and the funding required to provide for the potential program.

Discussion ensued relative to funding sources and partnership opportunities for providing the potential program.

The Vice-Chairman recognized Mr. Wayne Thibodaux, Gray Improvement Committee member, who thanked the Committee for considering the resolution and its benefits to the Gray community.

At Mr. D. J. Guidry's request, the Vice-Chairman recognized Terrebonne Council on Aging Executive Director Michel Claudet who shared his understanding of an agreement with the Parish regarding the use of funds for serving senior citizens.

Discussion ensued relative to pre-existing senior programs and addressing the needs of Parish residents in their communities.

The Vice-Chairman recognized Parish Attorney Julius Hebert who gave an overview of the millage funds to be used to provide for the potential program then shared his opinion that the program would meet the requirements of the millage. He then noted that the Terrebonne Council on Aging's consent would be needed before a cooperative endeavor agreement could be signed with Gulf Coast to provide the program.

Several Committee Members shared their support for the program and its potential benefits to the residents in the local communities. (*RESOLUTION ADOPTED AFTER DISCUSSION)

At Ms. J. Domangue's request, Chief Financial Officer Kandace Mauldin clarified that the \$2,984,000 for the Bayou Country Sports Park was State Capital Outlay money.

Mr. D. Babin requested that the total amount given to the Bayou Country Sports Park this year and the total revenue the park has derived be provided at the next Committee meeting.

At Mr. S. Trosclair's request, Ms. Mauldin explained that, for the Road Lighting District #6 Operations and Maintenance, they are required by state law to be within 5% favorable variance and that the millage collections were less than what was budgeted, therefore needing to be adjusted.

The Chairman called for the vote on the motion offered by Mr. D. W. Guidry, Sr. THERE WAS RECORDED:

A review of the proposed 2023 Budget began on the following funds/departmental budgets:

- a) Library (Sm. Bk. 347) Chief Financial Officer Kandace Mauldin presented the proposed 2023 Budget stating that the Sales and Use Taxes for 2023 is estimated at \$5,800,000, an increase of \$200,000.
- b) Council on Aging (Fund 278; Sm. Bk. 173; Big Bk. 316) Chief Finance Officer Kandace Mauldin highlighted the proposed 2023 Budget explaining that a 7.50 mill ad valorem tax approved by voters November 16, 2013 (2020-2029) will generate an estimated \$7.4 million in 2023. Terrebonne Parish has a cooperative endeavor agreement with Terrebonne Council on Aging (TCOA) to provide services to the elderly and disabled, \$7,500,000 estimated for 2023. An independent budget is adopted by TCOA governing authority for fiscal year ending June 30th and is submitted annually to the appointing authority. In 2023, \$150,000 has been budgeted for elderly programs at Mechanicville Community Center.
- c) District Attorney (Fund 151-123; Sm. Bk. 68; Big Bk. 15) Chief Financial Officer Kandace Mauldin summarized the proposed 2023 Budget highlighting that, under Personnel, they are adding one Assistant District Attorney.
- d) Clerk of Court (Fund 151-124; Sm. Bk. 70; Big Bk. 16) Chief Financial Officer Kandace Mauldin reviewed the proposed 2023 Budget, noting that they are requesting \$26,770 for a map imager and printer and a server.
- e) Criminal Court Fund (Fund 299; Sm. Bk. 196; Big Bk. 401) Chief Financial Officer Kandace Mauldin presented the proposed 2023 Budget noting that fines and forfeitures revenue is estimated at \$2,508,000 for 2023, general fund supplement, \$3,300,000, an increase of \$1,750,853, Juvenile Detention Supplement, \$250,000, same as 2022, and Mental Health and Drug Abuse Fund Supplement, \$47,514, same as 2022.
- f) Parish Jail (Fund 203-201; Sm. Bk. 131; Big Bk. 72) Chief Financial Officer Kandace Mauldin summarized the proposed 2023 Budget, stating that an agreement between the Parish Government and the Sheriff of Terrebonne Parish for the maintenance and operations of the jails. The Parish government agrees to pay a \$12.61 per diem for the maintenance on non-Department of Corrections (DOC) prisoners and the Sheriff shall share with the Parish 50% of the DOC reimbursements. In addition, the Sheriff agrees to make a continuous good faith effort to maintain a total DOC prisoner population of two hundred (200) inmates. For 2023, the Parish is estimating to receive \$715,327 from the Sheriff of Terrebonne, a decrease of \$99,673, and will provide a General Fund Supplement of \$3,765,000, same as 2022. Ms. Mauldin then noted that under the Parish Prisoners Department, the Parish reimburses the Sheriff for the feeding of the prisoners based on a flat formula of \$1.75 per day for (DOC) prisoners and \$12.61

- per day for all others. She added that the projected cost for 2023 is \$2,000,000, which is based on an average prison population of 650.
- g) Parish Jail Medical Department (Fund 203-202; Sm. Bk. 133; Big Bk. 75) Chief Financial Officer Kandace Mauldin reviewed the proposed 2023 Budget, highlighting that the Parish currently contracts the Haydel Clinic for physicians' care at \$90,000 per year. With the inclusion of dental care, ambulance, and hospital care, the medical services are estimated for 2023 at \$170,000, and prescriptions and OTC Medications are estimated at \$154,700.
- h) Economic Development/other (Fund 151-652; Sm. Bk. 111; Big Bk. 45) Chief Financial Officer Kandace Mauldin presented the proposed 2023 Budget noting that the fees for South Central Planning Commission is \$42,000 for Regional Membership and \$40,000 for Local match for Urban System Grant Administration. She added that the African American Museum will be allocated \$15,000, same as 2022.
- At Mr. D. Babin's request, Ms. Mauldin explained that the African American Museum provided mobile exhibits in the past year until improvements could be made at their physical location.
- At Mr. C. Harding's request, Ms. Mauldin noted that the Houma Downtown Development Corporation funding is not included in the budget until they have signed agreements and received money from the State. She then explained that once received, a budget amendment will be done to include those funds.
 - **TEDA** (Sm. Bk. 342) Chief Financial Officer Kandace Mauldin highlighted the proposed 2023 Budget, stating that TPCG will transfer \$625,000 to TEDA, an increase of \$75,000.
 - j) Public Works/Engineering (Fund 151-302; Sm. Bk. 99; Big Bk. 36) Chief Financial Officer Kandace Mauldin summarized the proposed 2023 Budget, highlighting that there were no significant changes.
 - k) Public Works/FTA Grant Fund (Good Earth Transit) (Fund 237; Sm. Bk. 203; Big Bk. 198) Chief Financial Officer Kandace Mauldin presented the proposed 2023 Budget, explaining that there were no significant changes.
 - 1) Public Works/FTA City of Thibodaux (Fund 238; Sm. Bk. 204; Big Bk. 212) Chief Financial Officer Kandace Mauldin highlighted the proposed 2023 Budget, stating that there were no significant changes.
 - m) Public Works/Federal Highway Admin (Rural Transit) (Fund 240; Sm. Bk. 205; Big Bk. 229) Chief Financial Officer Kandace Mauldin presented the proposed 2023 Budget, noting that there were no significant changes.
 - n) Public Works/Parish Transportation Fund (Fund 250; Sm. Bk. 156; Big Bk. 242)

 Chief Financial Officer Kandace Mauldin reviewed the proposed 2023 Budget, explaining that the revenues are subject to annual state appropriation; therefore, \$600,000 is estimated through the State's fiscal year end of June 30, 2023. Direct services for street repairs are estimated at \$990,502 and is based on the estimated 2023 revenue through June 30th and any unallocated fund balance at December 31, 2022.
 - o) Public Works/Road & Bridge Fund (Fund 251; Sm. Bk. 157; Big Bk. 245) Chief Financial Officer Kandace Mauldin presented the proposed 2023 Budget, noting that the voters of Terrebonne Parish approved a ¼% sales tax used to fund this division, and the 2023 collections are estimated at \$7,684,646, a 13.86% increase from 2021 actual collections and the same as the 2022 projected collections. The 2023 General Fund supplement is \$0. Major operating expenditures are as follows: Gasoline and Oil, \$125,000, same as 2022, Shells, \$250,000, an increase of \$75,000, Urban Street Lights, \$168,320, same as 2022, and street repairs contractors, \$2,017,499, an increase of \$465,576. Under Capital, they are requesting \$885,000 for various bridge work on the

Pontoon Bridge, Brady Road Bridge, and Combon Bridge, \$75,000 for one pickup truck, \$10,000 for one copy machine, \$4,030 for software, and \$200,000 for restroom renovations.

p) Public Works/Drainage Tax Fund (Fund 252; Sm. Bk. 161; Big Bk. 253) – Chief Financial Officer Kandace Mauldin summarized the proposed 2023 Budget, highlighting that the voters of Terrebonne Parish approved a ¼% sales tax used to fund this division, and the 2023 collections are estimated at \$7,684,646, a 13.86% increase from 2021 actual collections and the same as the 2022 projected collections. An ad valorem tax of 7.15 mills will generate an estimated \$7,146,458 for 2023. Major operating expenditures are as follows: other contracts, \$1,200,000; gasoline and oil, \$350,000, same as 2022; diesel/pumps, \$1,150,000, same as 2022; pump repairs, \$650,000, same as 2022; contractors' repairs, \$1,000,000, an increase of \$600,000; canal and lateral ditch maintenance, \$120,000, same as 2022; collection canal cleaning, \$20,000, same as 2022: permit monitoring, \$46,000, same as 2022. Under Capital, they are requesting \$2,575,000, two tandem axel dump truck, \$175,000 each, vacuum truck, \$550,000, telemetry, \$300,000, various projects, portable generators, additional pumps, \$1,350,000, and office furniture, \$25,000.

At Mr. D. Babin's request, Ms. Mauldin noted that the contractors' repairs increase of \$600,000 is for additional pump repairs that aren't included in the capital expense and any small projects done through the Drainage department. She then noted that the contractors will be outside contractors selected through the bid process.

At the Chairman's request, Public Works Director David Rome clarified that the lateral ditch maintenance is parishwide.

- **q)** Public Works/Pollution Control (Fund 310-312; Sm. Bk. 222; Big Bk. 436) Chief Financial Officer Kandace Mauldin reviewed the proposed 2023 Budget, explaining that sewer collections for 2023 are estimated at \$7,190,500. For the Sewerage Collection Department, Major Expenditures are as follows: Utility costs, \$445,000, 2.25% collection fee of all sewerage revenue collected by Consolidated Waterworks, \$160,000, sewer pump repairs, \$80,000, and contractor's repairs, \$180,000. Under Personnel, they are adding one (1) Field Tech II, Grade 104. For the Treatment Plant Division, under Capital, they are requesting \$3,625,000 for the North Treatment Plant improvements, to dredge pond #13, South Treatment Plant levee armoring repair, and Fairlane pond closure. For Pollution Control Administration, they are adding one (1) Admin. Coordinator I, Grade 104. For Sewerage Capital Additions, they are requesting \$269,000 to replace 34 ton HD pickup with long bed, quick hookup for generator, and some sewer rehabilitations.
- r) Public Works/Fleet Maintenance (Fund 395; Sm. Bk. 262; Big Bk. 499) Chief Financial Officer Kandace Mauldin explained the proposed 2023 Budget, highlighting that its major funding source is estimated at \$1,098,940 and is made up of user fees charged to user departments. Under Personnel, they are adding one Mechanic II, Grade 106 and eliminating one Mechanic I, Grade 105. Under Capital, they are requesting \$100,000 to replace pumps at fuel docks.
- s) Capital Projects (Fund 600's; Sm. Bk. 273; Big Bk. 554) Chief Financial Officer Kandace Mauldin summarized the proposed 2023 Budget stating that for 2023, \$3,108,961 is proposed to be added to the Capital Projects, which includes the Bayou Terrebonne Pump Station (Shell Oil Property) in the amount of \$908,961, the D-18 pump station replacement of \$1.4 million (which is the Parish Capital Outlay match), the Pontoon and Chauvin Bridge, \$700,000, and Hollywood Road roundabout, \$100,000.
- Ms. J. Domangue moved, seconded by Mr. J. Amedée, "THAT the Budget and Finance Committee introduce an ordinance to adopt the 2023 Operations and Maintenance Budget and the Five-Year Capital Improvements Budget of the Terrebonne Parish Consolidated Government as presented by the Parish President and further amended by the Terrebonne Parish Council, to amend the Parish Compensation Plan for new and/or adjusted

positions, to approve a 2% Cost of Living increase for the Parish President's Departments and Council Staff, and to address other matters relative thereto and call a public hearing on said matter on Wednesday, December 14, 2022, at 6:30 p.m."

The Chairman called for the vote on the motion offered by Ms. J. Domangue.

WHEREAS the Glen Oaks Homeowners, Association, Inc., acquired all rights title and interest to the property from Dixie Rice Agriculture, LLC, COB 2645, Folio 180, Entry No. 1633057; Pernell and Tara Pellegrin; COB 2664, Folio 460, Entry No. 1646450; Scott A. and Sarah Haydel; COB 2661, Folio 801, Entry No. 16447061; Gordon Earl Dove, Sr. and Mona Dove, COB 2661, Folio 793, Entry No. 1644705, as it relates to the ownership of property referenced herein;
