Upon questioning, Parish President M. Claudet explained that the lease with the Terrebonne Livestock and Agricultural Association, Inc. is due to expire in the Summer of 2014 and that the Krewe of Hercules securing this lease, maintaining the site and providing insurance for this facility would decrease the likelihood of damage from vandalism.

For clarification, Parish Manager A. Levron explained that this particular property is owned by the Airport Commission and that Terrebonne Parish entered into an agreement with them many years ago, thus allowing the Parish to sublease the property to the Terrebonne Livestock and Agricultural Association. Mr. Levron continued that the Parish is primarily responsible for the site and that entering into a new agreement with the Krewe of Hercules would still allow the Terrebonne Livestock and Agricultural Association to have access and use of the arena.

Discussion ensued with several Council members expressing their approval of the cooperative endeavor, noting that this lease agreement would enhance activities in the eastern area of Terrebonne Parish.

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO TERMINATE THE CURRENT LEASE AGREEMENT WITH TERREBONNE LIVESTOCK AND AGRICULTURAL ASSOCIATION, INC. AND TO EXECUTE A NEW COOPERATIVE ENDEAVOR LEASE AGREEMENT WITH THE KREWE OF HERCULES FOR A TRACT OF LAND SITUATED WITHIN THE HOUMA-TERREBONNE AIRPORT, HOUMA LA, AND TO PROVIDE FOR RELATED MATTERS.

WHEREAS, Article VII, Section 14 of the Louisiana Constitution provides that, "[F]or a public purpose, the state and its political subdivision or political corporations may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private association, corporation or individual"; and

WHEREAS, TPCG and the Terrebonne Livestock and Agricultural Association, Inc. entered into a lease on October 15, 2003 with an expiration date of June 30, 2014, for a tract of land situated within the Houma-Terrebonne Airport, and

WHEREAS, TPCG and the Terrebonne Livestock and Agricultural Association, Inc. believe it is in the best interest of the facility to terminate the current lease prior to its expiration, and have agreed to terminate their cooperative endeavor lease agreement effective January 1, 2014, and

WHEREAS, TPCG desires to enter a similar cooperative endeavor lease agreement to lease the tract of land and facilities to the Krewe of Hercules, and

WHEREAS, the Krewe of Hercules will continue to operate the facilities to serve a public recreational purpose; and

WHEREAS, TPCG finds that its expenditure or transfer according to the terms of the new cooperative endeavor, taken as a whole, is not gratuitous, and that it has a demonstrable, objective, and reasonable expectation of receiving at least equivalent value in exchange for the expenditure or transfer of its public funds; and

NOW THEREFORE BE IT RESOLVED by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government that the Parish President, Michel Claudet, is hereby authorized to negotiate and to execute all documents necessary to terminate the current lease agreement entered into by and between the TPCG and Terrebonne Livestock and Agricultural Association, Inc. as authorized by Terrebonne Parish Council Resolution No. 03-403, and to enter into a new lease agreement between the TPCG and the Krewe of Hercules, containing substantially the same terms as those contained within the current Cooperative Endeavor Lease Agreement with the Terrebonne Livestock and Agricultural Association, Inc.

ORDINANCE NO. 8382

An ordinance authorizing amendment of the Rodemacher No. 2 Power Sales Agreement by and between the Louisiana Energy and Power Authority and the City of Houma, LA to change the point of delivery to the interconnection of Rodemacher Unit No. 2 with Cleco Power LLC ("CLECO")

WHEREAS, LEPA was created by the Act to provide a means for those Louisiana municipalities which are members of LEPA to secure electric power and energy for their present and future needs; and

WHEREAS, the Participant owns and operates an electric utility system as a part of its Combined Utilities System and is a member of LEPA; and

WHEREAS, LEPA is empowered by the Act (i) to acquire and construct facilities for the generation and transmission of electric power and energy, or to acquire an interest in any such facilities; (ii) to purchase, sell, transmit or otherwise use electric power and energy within or without the state of Louisiana; (iii) to issue its revenue bonds to pay all or part of the cost of acquiring facilities for the generation and transmission of electric power and energy; and (iv) to do all acts and things necessary to carry out the purposes and to exercise the powers granted to LEPA under the Act; and

WHEREAS, LEPA entered into the Amended and Restated Agreement for Joint Ownership, Construction and Operation of Rodemacher Unit No.2 (the "Joint Ownership Agreement"), with Central Louisiana Electric Company, Inc. ("CLECO"), CLECO Construction Company, Inc., and Lafayette Public Power Authority ("LEPA"), pursuant to which LEPA acquired an undivided ownership interest in, and is entitled to a portion of the electric power and energy derived from, Unit No.2; and

WHEREAS, LEPA has taken all steps necessary for acquisition and construction, pursuant to the Joint Ownership Agreement, of its undivided ownership interest in Unit No.2 for the supply of electric power and energy to the Participant and to the other Louisiana municipalities contracting with LEPA therefor, and sells the power and energy of the Project pursuant to this Power Sales Contract and pursuant to contracts substantially similar to this contract with such other municipalities; and

WHEREAS, in order to enable LEPA to issue its revenue bonds to pay the cost of acquiring and constructing the Project was necessary for LEPA to have substantially similar binding contracts with the Participant and such other municipalities purchasing power and energy of the Project and to pledge the payments required to be made in accordance with such contracts as security for the payment of such revenue bonds; and

WHEREAS, on October 1, 1982, the Louisiana Energy and Power Authority ("LEPA") entered into power sales agreements ("the Agreements") with the City of Houma, the City of Houma, the Town of Jonesville, the City of Morgan City and the City of New Roads for the purchase and sale of output from the Rodemacher No. 2 electric generating unit located in Boyce, LA ("the Project"). These five cities are referred to collectively as "The Participants"; and

WHEREAS, it is anticipated the electric transmission systems across which the power and energy is conveyed will transition to the <u>Midcontinent Independent System Operator</u> ("MISO") Regional Transmission Organization ("RTO") in or around December 2013, and

WHEREAS, the parties agree it is advisable and beneficial to amend the Agreement to change the point of delivery of Project power and energy to the point of interconnection between the Project and the Central Louisiana Electric Company (CLECO); and WHEREAS, LEPA and the Participants are legally empowered to enter into and perform this Amended Power Sales Contract by virtue of the powers and authority granted by the Act, including particularly R.S. 33:4545.7 and 33:4545.9;

BE IT ORDAINED, in consideration of the mutual covenants and agreements herein contained, that it is agreed by and between the parties as follows. That Amendment No. 1 to the Power Sales Contract by and between the Louisiana Energy and Power Authority and the City of Houma (Rodemacher Unit No. 2) to change the point of delivery, substantially in the form attached hereto be, and is hereby, authorized; and,

BE IT FURTHER ORDAINED, that the Parish President is hereby authorized to execute any and all documents necessary.
