<u>May 13, 2015</u>

The Chairman, Mr. P. Lambert, called the meeting to order at 6:00 p.m. in the Terrebonne Parish Council Meeting Room. Following the Invocation, offered by Councilman D. Guidry, Councilman D. Babin led the Pledge of Allegiance.

Upon roll call, Council Members recorded as present were: P. Lambert, J. Navy, B. Amedée, C. Duplantis- Prather, R. Hornsby, D. Babin and D. Guidry. A. Williams and G. Hood, Sr. were recorded as absent. A quorum was declared present.

The Council Chairman read aloud a memo from Councilwoman A. Williams explaining that her absence from tonight's proceeding is due to a previously planned family engagement and from Councilman G. Hood, Sr. explaining that his absence from tonight's proceeding is due to a personal family matter.

Ms. C. Duplantis-Prather moved, seconded by Mr. D. Guidry, "THAT, the Council approve the minutes of the Regular Council Session held on 04/08/15."

Several Council members congratulated Mr. Rhett Williams on the remarkable job he has done and wished him well on his future achievements.

Councilwoman C. Duplantis-Prather read aloud a proclamation declaring June 2015 as "Hayden's Swimming Pool Safety Awareness Month in Houma-Terrebonne".

The Chairman declared the motion adopted.

Councilman J. Navy read aloud a commendation commending and thanking Terrebonne Parish's Legislative Delegation, the Terrebonne Levee and Conservation District, and the voters of Terrebonne Parish for their continued support in securing funding to provide coastal protection for Terrebonne Parish.

The Council Chairman recognized Reggie Dupre, who is a Former Councilman, State Senator, and State Representative and the current the Director of the Terrebonne Parish Levee and Conservation District and Former Councilman Carl Chauvin who were in the audience for tonight's proceedings.

The Council Chairman recognized Anthony Alford, President of The Terrebonne Levee and Conservation District who then recognized the Board of Commissioners of the Terrebonne Levee and Conservation District: Commissioners Jack Moore, Darrin Guidry, Buddy Daisy, Vice President Leward "Sou" Henry, and Administrative Manager Angela Raines who were in attendance for tonight's proceedings, and also recognized the board members who were unable to attend tonight's proceedings: Commissioners Howard Pinkston, Lee Shaffer, and Steve Ledet.

Mr. Alford continued that without the support of the citizens of Terrebonne Parish and Parish taxes, the projects would not be possible. Mr. Alford stated that it is a consolidated effort with the Council, Parish President, State, and State Legislators that make it possible to continue the efforts of conserving our coast. Mr. Alford thanked the Council and Parish President for the commendation and stated he and the board of commissioners will continue to make Terrebonne Parish Proud.

The Council Chairman recognized Reggie Dupre, Director of the Terrebonne Levee and Conservation District, who stated that in 2008 Hurricane Gustave was an "eye opener" for Terrebonne Parish and that was when it was decided not to wait on funds from the Federal Government, but to take matters into our own hands. Since then, the Parish has generously given fourteen million dollars to the Terrebonne Levee and Conservation District and with only "Reach E" left to complete, by 2017, thirty to forty miles of levee will connect all five bayous. Mr. Dupre

presented the Council with a map of the Morganza Project showing project completions and the current progress of other projects.

Several Council members and the Parish President thanked all of the Terrebonne Levee and Conservation District for the tremendous job and amazing progress they have done and urged them to keep up with the great work.

ORDINANCE NO. 8542

AN ORDINANCE AMENDING THE PARISH CODE OF TERREBONNE PARISH, CHAPTER 18, ARTICLE IV. OPERATION OF VEHICLES, DIVISION 2. PARISH, SECTION 18-88 TO ESTABLISH A "3-WAY STOP" AT THE INTERSECTION OF LANSDOWN DRIVE AND RIVERVIEW STREET, AND TO AUTHORIZE THE INSTALLATION OF THE APPROPRIATE SIGNS; AND TO ADDRESS OTHER MATTERS RELATIVE THERETO.

SECTION I

BE IT ORDAINED by the Terrebonne Parish Council, in regular session convened, acting pursuant to the authority invested in it by the Constitution and laws of the State of Louisiana, the Home Rule Charter for a Consolidated Government for Terrebonne Parish, and including, but not limited to, LSA R.S. 33:1368 and other statutes of the State of Louisiana, to amend the Parish Code of Terrebonne Parish, Chapter 18, Article IV, Section 18-88 to create a "3 Way Stop" at the intersection of Lansdown Drive and Riverview Street, as follows:

CHAPTER 18, Motor Vehicles and Traffic ARTICLE IV, Operation of Vehicles DIVISION 2. Parish SECTION 18-88. Three-way stop intersections.

(ADD TO LIST) Lansdown Drive and Riverview Street

The intersection of Lansdown Drive and Riverview Street shall be declared as a "3 Way Stop" intersection, and appropriate "3 Way Stop" signs shall be erected and maintained along said roadways. Any vehicle traveling on Lansdown Drive and/or Riverview Street shall adhere to the provisions of this ordinance.

SECTION II

If any word, clause, phrase, section or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections or other portions of this ordinance shall remain in full force and effect, the provisions of this section hereby being declared to be severable.

SECTION III

Any ordinance or part thereof in conflict herewith is hereby repealed.

SECTION IV

This ordinance shall become effective upon approval by the Parish President or as otherwise provided in Section 2-13 (b) of the Home Rule Charter for Consolidated Government for Terrebonne Parish, whichever occurs sooner.

ORDINANCE NO. 8543

AN ORDINANCE TO REVOKE PORTIONS OF CERTAIN DRAINAGE SERVITUDES RUNNING OVER AND ACROSS IMMOVABLE PROPERTY OF MORRIS P. AND SANDRA D. HEBERT, H4, L.L.C., and SDH2, L.L.C, LOCATED IN SECTION 101, T17S-R17E TERREBONNE PARISH, LOUISIANA, TO BECOME EFFECTIVE UPON THE GRANT OF NEW SERVITUDES TO TPCG BY THOSE INDIVIDUALS; AND TO ADDRESS OTHER MATTERS RELATIVE THERETO.

WHEREAS, In connection with Phase 2, Terrebonne Parish Project No. 13-DRA-03, Bayou LaCarpe Drainage (the "Project"), TPCG has planned to revise and acquire drainage and temporary construction servitudes and construct improvements of the drainage in the Bayou LaCarpe area in Houma, Louisiana, which, when complete, will traverse privately owned property, including property owned by Morris P. and Sandra D. Hebert, H4, L.L.C., and SDH2, L.L.C (the "Owners");

WHEREAS, the Owners have agreed to cooperate with TPCG for the revision of the drainage servitudes and TPCG's acquisition of temporary construction servitudes in connection with the Project as it relates to their immovable property;

WHEREAS, TPCG wishes to revoke the dedication of a portion of the existing drainage servitudes situated on their properties, to become effective upon the recordation of certain acts by Owners granting TPCG drainage, maintenance and temporary construction servitudes as further described below; and

SECTION I

NOW, THEREFORE BE IT ORDAINED that the Terrebonne Parish Council, in regular session convened, on behalf of the Terrebonne Parish Council (TPCG), acting pursuant to the authority vested in it by the Constitution and laws of the State of Louisiana, and pursuant to the Home Rule Charter for a Consolidated Government, has determined that the servitudes of drainage encumbering the following described immovable properties:

A. Morris P. Hebert & Sandra D. Hebert:

12.5' of a Drainage Servitude

A certain tract of land situated in Section 101, T17S-R17E, Terrebonne Parish, Louisiana comprising of 0.080 acres. Commencing at the intersection of Hollywood Road right-of-way (State Project 742-55-0002) and the northeast corner of Tract M-R; Thence S 65°43'13" W, a distance of 10.00' along the Hollywood Road southeasterly right-of-way line to a point, being the POINT OF BEGINNING; Thence S 24°08'25" E, a distance 61.09' to a point; Thence S 55°01'16" E, a distance of 207.73'to a point on the southeasterly property line of said Tract M-R; Thence S 23°26'23" E, a distance of 23.87' along the southeasterly property of said Tract M-R to a point; Thence N 55°01'16" W, a distance of 231.52' to a point; Thence N24°08'25"W, a distance 64.51' to a point on the southeasterly right-of-way line of Hollywood Road; Thence N 65°43'13" E, a distance of 12.50' along the Hollywood Road southeasterly right-of-way line to a point, the POINT OF BEGINNING.

Mr. Faulk explained that the current millage for the police department has been in effect for thirty (30) years. He stated he has also been discussing with the Houma Fire Department suggestions on how to possibly bring the millage to a higher level to dedicate it to salaries for law enforcement and fire department personnel.

At this time (6:52 p.m.), the Committee Chairman relinquished the chair to the Vice-Chairman.

A discussion ensued relative to suggestions of ways to look at increasing salaries of the City of Houma Police Department as well as the Houma Fire Department personnel.

Upon questioning, Parish President M. Claudet stated that his office has not received any new reports from the Houma Police Department, but he understands the pay scale that was previously submitted by the Houma Police Association was in error, but will be revised and resubmitted. He stated the parish does have a surplus, but not in the amount that was previously stated. He explained that the unemployment in Terrebonne Parish is the lowest in the area, tied with Calcasieu Parish. He stated sales tax for this quarter was sufficiently lower. He also explained that dedicated funds from millages can't be taken from other entities/agencies to supplement another because they are dedicated funds.

Discussion continued with several committee members agreeing that a plan need to be implemented to give a pay raise to the Houma Police Department and the Houma Fire Departments; noting that June 10, 2015 is the last date to put a millage position on the October election ballot.

Houma Fire Department District Chief Terry Leonard, and President of the Houma Firefighter's Association, stated that the Houma Police Department and the Houma Fire Department share a 10 mill public safety tax.

At this time in the proceedings (7:14 p.m.), the Committee Chairman resumed his chair position.

Ms. A. Williams moved, seconded by Mr. D.
