The Council Chairwoman acknowledged Ms. Linda Brashier, a Houma resident and spokesperson for the La. Cleanest City campaign, who addressed the Council relative to the matter of April 2, 2013 as being the day of the "2013 Cleanest City Contest". Ms. Brashier explained that this contest is being judged by districts and that if Terrebonne Parish wins it will move on to the state level. She informed the Council that this contest has been in existence for 55 years in Louisiana and that it wants to bring new census data points into the contest which would include the areas of Chauvin, Montegut, Bourg and Schriever. Ms. Brashier, along with Ms.

Carolyn Dupre and Ms. Carolyn Bourgeois, encouraged every citizen to help clean up Terrebonne Parish.

A request to speak had been submitted by Ms. Betty Verdin, Terrebonne Parish resident, Agenda Item 2B- (Ms. Betty Verdin wishes to address the Council relative to 'Loud Noise'); upon call by the Chairwoman, no one came forward to address the Council.

The Chairwoman read aloud a speaker card submitted by Ms. Sharon Toups, a Houma resident, who wanted to address the Council relative to the matter of a request for a variance for a fence which has been installed on a servitude at 164 Port Royal Way.

Mr. R. Hornsby moved, seconded by Mr. G. Hood, Sr., "THAT, the Council authorize the issuance of a variance for a fence which has been installed on a servitude at 164 Port Royal Way with the stipulation that the parish right-of-way be maintained at the owner's expense." (MOTION AMENDED AND ADOPTED AFTER DISCUSSION)

Discussion ensued with several Council members questioning whether or not allowing the encroachment on the servitude would cause a problem for Parish workers.

Upon questioning, Mr. Patrick Gordon, Planning and Zoning Director, explained that a permit for this project has not been applied for, and noted that the fence being installed has poles/columns that are 16 to 24 inches in length. According to Mr. Gordon, to have this fence completed the occupants of 164 Port Royal Way would still have to go before the Board of Adjustments for approval.

Ms. Sharon Toups, representing her daughter and son-in-law, explained that they were under the impression that the fencing company had taken care of all of the necessary paperwork/permits needed to erect this fence, and that they were unaware that this had not been done.

Parish Attorney C. Alcock interjected that the matter of variances is relatively new for the Council and that they are being administered and determined on a case-by-case basis, with a signed indemnity agreement required, that is filed with the Clerk of Court's Office, which protects the parish's future liability exposure.

Upon questioning, Parish Manager Al Levron explained that this matter had not been processed through Administration as of yet, but Administration's recommendation would be to authorize a Letter of No Objection provided that the applicant enters into an indemnity agreement and receives approval from the Board of Adjustments.

The Chairwoman acknowledged Parish President M. Claudet who explained that the Parish's policy is not to allow any encroachment on the Parish's servitudes, and recommended that, if approved, the matter be in conjunction with the requirements that Parish Attorney C. Alcock previously outlined.

Mr. D. Babin offered a substitute motion, "THAT, the Council concur with a recommendation by Administration to authorize the issuance of a Letter of No Objection for a fence which has been installed on a servitude at 164 Port Royal Way, along with the requirement of an indemnity agreement and approval by the Board of Adjustments".

The Chairman declared the motion died due to the lack of a second.

Mr. R. Hornsby *amended* his original motion, seconded by Mr. G. Hood, Sr., "THAT, the Council authorize the issuance of a Letter of No Objection for a fence which has been installed on a Parish servitude at 164 Port Royal Way, following approval by the Board of Adjustments, and with the condition that an indemnity agreement be entered into by the property owners."

ORDINANCE NO. 8271

AN ORDINANCE TO AMEND THE TERREBONNE PARISH CODE, CHAPTER 12, ARTICLE III, SECTION 12-66, SECTION 12-72 AND SECTION 12-73 WITH REGARDS TO COASTAL IMPACT CERTIFICATES; TO PROVIDE FOR AN EFFECTIVE DATE; AND TO PROVIDE FOR OTHER MATTERS RELATIVE THERETO.

SECTION I

BE IT ORDAINED by the Terrebonne Parish Council, in regular session convened, that the Terrebonne Parish Code, Chapter 12, Article III be amended as follows:

Sec. 12-66. – Statement of Purpose. (Delete strike, add **bold/underline**)

- (a) Remains the same
- (b) It is the purpose of the coastal impact certificate to enhance and to protect the ecological systems of the parish, whose renewable resources include numerous species of wildlife and support fisheries, and whose nonrenewable resources, such as crude oil and natural gas, serve as the economic base of the parish. The coastal impact certificate process reviews activities, outlined in section 12-71 of this article, to:
- (1) Remains the same
- (2) Assure that the proposed activity does not unnecessarily or excessively destroy impact wetlands and/or water bottoms.
- (3) through (5) Remain the same

Sec. 12-72. – Application for coastal impact certificate.

- (a) Remains the same
- (b) Accompanying the application must be a clear description of the facility and its proposed purpose, plans, specifications, locations, vicinity maps, construction costs, proposed maintenance plan, possible environmental impacts and plans for minimizing impacts, acres of wetlands and/or water bottoms affected, proposed mitigation plans, and the names and addresses of its owner, contractor, and the authorized agent or representative. (Change "and" to "and/or", as shown in bold print)
- (c) Through (d) remain the same

Sec. 12-73. – Coastal impact fees.

(a) For construction related to any single-family dwelling units requiring a coastal zone permit from the Louisiana Department of Natural Resources or a Section 10/404 permit from the United States Army Corps of Engineers, the following fees will apply:

SECTION II

If any word, clause, phrase, section or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections and other portions of this ordinance shall remain in full force and effect, the provisions of this ordinance hereby being declared to be severable.

SECTION III

This ordinance shall become effective upon approval by the Parish President or as otherwise provided in Section 2-13(b) of the Home Rule Charter for a Consolidated Government for Terrebonne Parish, whichever occurs sooner.

ORDINANCE NO. 8273

AN ORDINANCE AUTHORIZING THE PARISH PRESIDENT TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT FOR LEASE OF PARISH PROPERTY BETWEEN TPCG AND SAMANTHA M. LUKE

WHEREAS, the Terrebonne Parish Consolidated Government ("TPCG") received a ten million dollar grant from the FEMA Hazard Mitigation Grant Program in January of 2003; and

WHEREAS, TPCG is in the process of the "buy-back" portion of the program and has purchased several different properties in Terrebonne Parish; and

WHEREAS, FEMA imposes stringent deed restrictions consistent with their "open space" philosophy on the property obtained by TPCG through the grant monies; and

WHEREAS, TPCG requires assistance in the healthy and sanitary maintenance of these properties and to assure that the use of the property remains consistent with FEMA requirements; and

WHEREAS SAMANTHA M. LUKE desires to lease the property subject to maintenance requirements and FEMA restrictions; and

WHEREAS, TPCG and SAMANTHA M. LUKE believe that entering into this Cooperative Endeavor Lease Agreement will serve a public purpose and have a public benefit commensurate with the cost;

AN ORDINANCE TO AMEND THE 2013 ADOPTED OPERATING BUDGET OF THE TERREBONNE PARISH CONSOLIDATED GOVERNMENT FOR THE FOLLOWING ITEMS:

- I. COMMUNICATION EQUIPMENT CITY MARSHAL, \$25,000
- II. WESTSIDE BLVD PHASE II, \$500,000
- III. BP PROMOTIONAL GRANT, \$500,000
- IV. TERREBONNE COUNCIL ON AGING, \$858,555
- V. DOWNTOWN MARINA, \$703
- VI. ASHLAND TRANSFER STATION, \$28,930
- VII. TREE BOARD, \$15,000

SECTION I

WHEREAS, City Marshal is in need of 13 portable radios and chargers for his office estimated to cost \$25,000 which will be funded through its Fund Balance, and

WHEREAS, the deputies are using cell phones and in some areas of the parish, the cell phone service is not sufficient, and

WHEREAS, there are units on the road every day doing evictions, seizing properties, working warrants, and transporting juveniles and adult prisoners all of which effective communication with other law enforcement officials are vital to the safety of the staff of the City Marshal's Office.

BE IT ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2013 Adopted Budget of the Terrebonne Parish Consolidated Government be amended for the portable radios for the City Marshal's Office. (Attachment A)

AN ORDINANCE REQUIRING THE PUBLICATION OF A MAP CLEARLY IDENTIFYING THE BOUNDARIES OF A "DRUG FREE ZONE" AROUND THE MERRY OAKS PRESCHOOL; TO REQUIRE THAT THE MAP OF SAID ZONE BE MADE AN OFFICIAL PUBLIC DOCUMENT IN THE CLERK OF COURT'S OFFICE WITH THE PROVISIONS OF ACT 171 OF THE 1989 LEGISLATURE (LA. In accordance with the provisions of Act 171 of the 1989 Legislature (LA R.S. 17:405), the map attached hereto and incorporated herein is hereby established as the boundaries of the Merry Oaks Preschool, which will be hereby established as a drug-free zone in the Parish of Terrebonne, and said map is hereby made an official public document and shall be recorded by the Clerk Of Court in accordance with the law.

SECTION II

If any section, part, paragraph, sentence, or clause of this ordinance should be declared invalid or unenforceable, such invalidity or defect shall not affect the remaining sections, paragraphs, parts, sentences or clauses hereof and, to this end, the several provisions hereof are hereby declared to be severable.

SECTION III

Except as otherwise provided for herein, this ordinance shall become effective upon approval by the Parish President or as otherwise provided in Section 2-13(b) of the Home Rule Charter for a Consolidated Government for Terrebonne Parish, whichever occurs sooner.

AN ORDINANCE TO AMEND THE PARISH CODE OF TERREBONNE PARISH BY ADDING TO CHAPTER 18: MOTOR VEHICLES AND TRAFFIC, ARTICLE IV: OPERATION OF VEHICLES, DIVISION 2: PARISH, AND TO ADD A SECTION UNDER THE SAID ARTICLE TO BE DESIGNATED AS SECTION 18-91(3): TO RAISE THE EXISTING 35 MPH SPEED LIMIT TO 45 MPH ON VALHI BOULEVARD FROM EQUITY BOULEVARD TO SAVANNE ROAD; TO PROVIDE FOR THE INSTALLATION OF SAID SIGNS; AND TO PROVIDE FOR OTHER MATTERS RELATIVE THERETO.

SECTION I

BE IT ORDAINED, by the Terrebonne Parish Council, in regular session convened and on behalf of the Terrebonne Parish Consolidated Government, that the Parish Code of Terrebonne Parish be amended by adding to Chapter 18: Motor Vehicles and Traffic, Article IV: Operation of Vehicles, Division 2: Parish, and by adding to the said Article, a section to be designated as Section 18:-91(b)(1): raise the existing 35 mph speed limit to 45 mph on Valhi Boulevard from Equity Boulevard to Savanne Road as follows:

CHAPTER 18: MOTOR VEHICLES AND TRAFFIC

ARTICLE IV: OPERATION OF VEHICLES

DIVISON 2: PARISH

SECTION 18-91: SPEED LIMITS

The speed limit of 35 mph on Valhi Boulevard from Equity Boulevard to Savanne Road is hereby increased and is hereby designated as a 45 mph speed limit zone; and appropriate speed limit signs shall be erected and maintained along the said roadway to create and maintain said intersection. Any vehicles traveling on Valhi Boulevard from Equity Boulevard to Savanne Road shall respect the signs erected and maintained under the provisions of this section.

SECTION II

If any word, clause, phrase, section or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections and other portions of this ordinance shall remain in full force and effect, the provisions of this ordinance hereby being declared to be severable.

Housing and Human Services Community Development Administrator Kelli Cunningham explained that as a CDBG grant recipient, Terrebonne Parish is mandated to promote fair housing, and then thanked the Committee for the proclamation.

Committee Members C. Duplantis and J. Navy complimented the Housing & Human Services Division on the outstanding job they perform. (NO ACTION TAKEN)

South Central Planning & Development Commission (SCP&DC) Economic Development Administrator Cullen Curole distributed handouts and presented a power point presentation on the Revolving Loan Program noting:

- The general public is unaware of the Revolving Loan Program
- Revolving Loan Programs are low interest commercial loans for either new start and/or existing businesses that are attempting to expand and/or business retention
- In the last five or six years since Hurricane Katrina, the single Revolving Loan Program has turned into multiple programs.
- SCP&DC has received a contract for an additional \$3,000,000.00 in revolving loan proceeds
- The revolving loan program has gone from a portfolio of approximately \$2,000,000.00 to almost \$16,000,000.00
- SCD&PC needs to double its effort to locate and identify business eligible for participation in the loan program
- Hurricane Andrew funding provided for a 4% interest rate for businesses in Assumption, Lafourche, St. Charles, St. James, St. John, and Terrebonne Parishes
- The Revolving Loan Program does not compete with local banks and provides that applicants must be denied by a bank before applying
 - Local bankers review the revolving loan applications
- The revolving loan is for working capital, equipment, and real estate with no construction existing
- After Hurricane Katrina, \$6,600,000.00 of revolving loans were awarded with approximately 80% of the funding returning to SCP&DC to create the revolving loan fund
- SCP&DC must lend funding to individual in Acadia, Allen, Beauregard, Calcasieu, Cameron, Iberia, Jefferson, Jefferson Davis, Lafourche, Orleans, Plaquemines, St. Bernard, St. Charles, St. John, St. Mary, St. Tammany, Tangipahoa, Terrebonne, Vermilion, and Washington Parishes for small scale projects at a rate of 4% as part of the Hurricane Katrina funding
 - Revolving Loan Program proceeds can't be used to pay credit card debit
 - Criteria has since been amended and is void of Federal ties for revolving loan proceeds
- New funding has been allocated for Ascension, Assumption, Calcasieu, Cameron East Baton Rouge, Iberia, Ibervile, Jefferson, Lafourche, Livingston, Orleans, Plaquemines, Pointe Coupee, Rapides, St. Bernard, St. Landry, St. Mary, St. Tammany, Terrebonne and Vermilion Parishes for Hurricane Gustav funding at a rate of 1%. St. Charles, St. John, and St. James were added in November
- The Revolving Loan Program can't be used for working capital projects; however, inventory can be purchased with the proceeds

■ The loan process takes time and applicants must have patience to go through the process

■ EPA – Brownfields Revolving Loan Fund for commercial projects where a hazardous condition (petroleum or hazardous environmental clean-up_ is remediated at a rate of 4% in East Baton Rouge, Evangeline, Iberia, Lafourche, Lake Charles, St. Charles, St. James, St. John, St. Landry, St. Martin, St. Mary, Terrebonne and Vermilion; The property must be transferred from present owner to a new buyer; SCP&DC has funding to completed the environmental assessment and clean-up. Mr. Curole stated that its his intent to present annual updates on the revolving loan program to the Committee each year. In response to questioning, he stated that EPA rates are negotiable with the borrower; that only one loan has been complete with the EPA Program; however, there are several sub-loans that have been authorized; that the projects awarded funding are generally not "bankable" due to some issue so incentives are offered to allow purchasers to mediate the property; that an effort will be given to actively promote the revolving loan program; and that there less than ten (10) accounts that have defaulted. He noted some concern with regards to not expending EPA funding by June of 2013. (NO ACTION TAKEN)

Mr. Vassallo then gave a power point presentation on the 2012 Terrebonne Economic Development Authority Annual Report noting a successful visit to Panama City; that the Louisiana Entrepreneurship Fest will be held in Houma, LA June 20 -21, 2013 at 10:00 a.m., which is a Statewide event; that the Youth Advisory Council is working closely with TEDA on the fest; that the Fest Taskforce Planning meeting will be held at 12:30 p.m. April 1, 2013 at the Main Library; that most of the Fest meetings have been held in Baton Rouge; that 24 presenters have been confirmed for the June Fest; that the target audience is high school and college students, veterans, and adults; that the International Council of Shopping Centers Conference will be held May 19 - 22, 2013 in at the Convention Center in Las Vegas, NV; that the Offshore Technology Conference will be held May 6 - 9, 2013 at Reliant Park in Houston, TX; that Weihai "A Growing Alliance" relationship is ongoing; that 820 jobs are available at 39 places of business within Terrebonne Parish; that TEDA is actively educating and advising youths on starting new business with a high school sophomore gathering on April 16, 2013 at the Houma-Terrebonne Civic Center; and that the TEDFo's mission has been identified through the Louisiana Entrepreneurship. Mr. Vassallo paid special tribute to emeritus board member Mike Voisin and thanked Charles Ganier for producing this evening's brochures.

The Chairwoman, Christa M. Duplantis, called the Policy, Procedure, & Legal Committee meeting to order at 6:46 p.m. in the Terrebonne Parish Council Meeting Room with an Invocation offered by S. Thomas and the Pledge of Allegiance led by R. Hornsby. Upon roll call, Committee Members recorded as present were: B. Amedee, D. Babin, C. Duplantis, D. Guidry, Capt. Greg Hood, Sr., HPD Ret., R. Hornsby, P. Lambert, J. Navy, and A. Williams. A quorum was declared present.

Mr. R. Hornsby moved, seconded by Mr. B. Amedée, "THAT, the Policy, Procedure, & Legal Committee authorize the TPCG to co-sponsor an event to be hosted by the Terrebonne Economic Development Authority/TEDFo on April 16, 2013 at the Houma-Terrebonne Civic Center for the purpose of educating high school sophomores about economic opportunities."

The Chairwoman called for the vote on the motion offered by Mr. R. Hornsby.

UPON ROLL CALL THERE WAS RECORDED:

Committee Member J. Navy noted that the proposed ordinance to regulate the inappropriate wearing of clothing in public is based upon legislation adopted by the City of Shreveport.

Parish Attorney Courtney Alcock stated that she contacted the City of Shreveport Attorney who informed her that legislation regulating the inappropriate wearing of clothing in public was enacted in 2007, that 376 violators have been prosecuted; and added that there have been no constitutionality challenges thus far.

Mr. J. Navy moved, seconded by Mr. D. Babin, "THAT, the Policy, Procedure, & Legal Committee introduce an ordinance to prohibit the inappropriate wearing of clothing in public, and call a public hearing on said matter on Wednesday, April 10, 2013 at 6:30 p.m." (**SUBSTITUTE MOTION OFFERED AND LATER WITHDRAWN; ORIGINAL MOTION AMENDED AND ADOPTED)

Committee Member G. Hood, Sr. expressed his support of legislation to regulate the inappropriate wearing of clothing in public; however, he expressed concerns with regards to the infringement of a person's right to express himself/herself and the notation that the offense "shall by itself not be grounds for an arrest or for a full search of the person cited". He then requested that the proposed ordinance be amended to provide that any offense subject to "incidental arrest" would allow Police to search an individual and that verbiage be removed which would not allow the search of an individual.

Ms. Alcock stated that the proposed ordinance could be amended to reflect the aforementioned change, but noted that the verbiage was included to possibly avoid individual profiling claims.

Committee Member R. Hornsby stated that initially, he was not in favor of the proposed legislation, but has since changed his position. He then noted his skepticism regarding enforcement and requested that the legislation and statistics be reviewed one year from adoption for possible rescission if the law proves to have no merit.

Committee Member D. Babin informed the general public of the April10, 2013 public hearing and suggested that the public attend the meeting to express their opinions regarding the proposed legislation.

Committee Member A. Williams inquired about the proposed legislation including offenses for females who wear inappropriate clothing 3 inches from the natural waist line.

Committee Member B. Amedée requested clarity with regards to the third paragraph, second "Whereas" clerical sentence structure.

Ms. Alcock stated that the sentence should read, "WHEREAS, the Terrebonne Parish Council finds that appearing in public view while exposing one's skin or undergarments below the waist is contrary to safety, *health*, *peace*, and good order of the Parish, and the general welfare; and" and that the ordinance can be further amended to add to (a) "Shall be unlawful for any person to appear in public view or in a public place wearing pants, skirts, or other clothing".

Ms. A. Williams offered a *substitute* motion, seconded by Mr. G. Hood, Sr., "THAT, the Policy, Procedure, & Legal Committee introduce an ordinance which would prohibit the inappropriate wearing of clothing in public to include under Section I, Sec. 19-17 (a) It shall be unlawful for any person to appear in public view or in a public place wearing pants, skirts or other clothing below the waist which expose the skin or undergarments and (b) Any violation of subsection (a) shall be cited by a law enforcement officer by the issuance of a citation and summons to appear before a court of proper jurisdiction; and call a public hearing on said matter on Wednesday, April 10, 2013 at 6:30 p.m." (**SUBSTITUTE MOTION WITHDRAWN AFTER DISCUSSION; ORIGINAL MOTION AMENDED AND ADOPTED)

Committee Member B. Amedée questioned whether the ordinance should contain provisions with regards to age-specific violators and provide verbiage under Section I, Sec. 19-17 (c) offenses "One Hundred (\$100.00) Dollars and Sixteen (16) Hours of Community Services for the Third *and subsequent offenses*." She then stated that she can't support the proposed ordinance based upon constitutionality rights and suggested that maybe the legislation has not been challenged because it us cheaper to pay the fine than to hire an attorney.

Ms. Alcock reiterated that the proposed legislation is based upon criminal intent to violate the law and that the ordinance can be amended to add "subsequent offenses".

Committee Member G. Hood, Sr. requested statistical information relative to the City of Shreveport's 376 prosecutions with regards to the number of cases that were prosecuted in court; those that were placed in the Pre-Trial Intervention Programs (PTI); or that were dismissed. He then clarified that individuals 10 years of age or older can be charged as criminally responsible; anyone under 10 years of age could not be charged; 10 through 16 years of age would fall under a juvenile complaint (juvenile summons); and anyone 17 years of age or older would face criminal charges.

**Committee Members A. Williams and G. Hood, Sr. withdrew the substitute motion.
