# **JULY 21, 2014**

The Chairman, Russell Hornsby, called the meeting to order at 5:30 p.m., in the Terrebonne Parish Council Meeting Room for the sole purpose of conducting condemnation hearings.

The Chairman recognized Mr. John Lombardi, who stated that some of the photos depicted in the power point presentation do not reflect his property as of today; that a contractor has been hired to make repairs; that the structure has been vandalized; and that the structure is being used as a storage facility and not a residence.

Councilwoman B. Amedée noted her inclination to continue the condemnation hearing; requested that the Mr. Lombardi complete substantial repairs by the next condemnation hearing; suggested that the owner consult Parish regulations and the subdivision covenants with regards to utilizing the structure as a storage facility due to its location being within a residential subdivision; and added that the grass must be maintained.

Mr. Lombardi interjected that the tall grass is not on his property, but on adjacent property.

Ms. Amedée noted that Administration has taken several photos from various angles depicting the tall grass and abandoned vehicle and reiterated that substantial improvement must be made by the next condemnation hearing.

Ms. B. Amedée moved, seconded by Mr. D. Guidry, THAT, the Council continue, until October 20, 2014 at 5:30 p.m., the condemnation hearing on the residential structure located at 315 Marietta Place, Gray, LA, owned by John and Madeline Lombardi."
