WHEREAS, thousands of people across the United States are living happy, healthy and productive lives in recovery from substance use disorders, and,

WHEREAS, according to the American Psychological Association, nearly half of Americans in 2008 reported that their stress levels had increased over the past year, with as many as 30% having rated their average stress levels as extreme, and

WHEREAS, stress has been identified as a substantial factor in contributing to addiction in some form or another, and

WHEREAS, although an estimated 23.1 million people, aged 12 or older, needed treatment for an illicit drug or alcohol use problem in 2008, only approximately 1.7 million are receiving treatment, according to the 2008 National Survey on Drug Use and Health, and

WHEREAS, for the last two decades, Recovery Month has promoted education as a prime means of combating the misconceptions associated with addiction and substance abuse, and

WHEREAS, the theme for this year's National Alcohol and Drug Addiction Recovery Month is "Join the Voices for Recovery: Now More Than Ever", which emphasizes the need to treat substance use disorders as a serious health care problem that can be triggered by a variety of external circumstances, and

WHEREAS, the Terrebonne Parish Council and the Parish President support and encourage residents to become more aware of the health issues related to alcohol and drug addiction and to seek help from professionals. NOW, THEREFORE BE IT RESOLVED, by the Terrebonne Parish Council, on behalf of Parish President Michel H. RESOLUTION NO. 10-420

A resolution approving the holding of an election in the Terrebonne Parish Veterans' Memorial District, on Tuesday, November 2, 2010, to authorize the levy of a special tax therein.

WHEREAS, the Board of Commissioners of the Terrebonne Parish Veterans' Memorial District (the "Governing Authority"), acting as the governing authority of the Terrebonne Parish Veterans' Memorial District (the "District"), adopted a resolution on August 24, 2010, calling a special election in the District on Tuesday, November 2, 2010, to authorize the levy of a special tax therein; and

WHEREAS, the governing authority of the District has requested that this Parish Council, acting as the governing authority of the Parish of Terrebonne, State of Louisiana, give its consent and authority for the District to hold the aforesaid election, and in the event that the election carries to levy and collect the special tax provided for therein; and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Parish Council to approve the holding of said election and in the event that the election carries, to levy and collect the special tax provided for therein;

NOW, THEREFORE, BE IT RESOLVED by the Parish Council of the Parish of

Terrebonne, State of Louisiana, acting as the governing authority of said Parish, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of the Terrebonne Parish Veterans' Memorial District, this Parish Council hereby approves the holding of an election in the District, on Tuesday, November 2, 2010, at which election there will be submitted the following proposition, to-wit:

REGIONAL MILITARY MUSEUM PROPOSITION

Summary: Authority to levy a 10 year 0.5 mill property tax for the purpose of improving, maintaining, acquiring, constructing and operating the regional military museum, and Veterans Memorial Park on Louisiana Highway 311, in the Parish of Terrebonne, State of Louisiana.

Shall the Terrebonne Parish Veterans' Memorial District (the "District"), levy a one-half of one (0.5) mill tax on all the property subject to taxation in said District for a period of ten (10) years, beginning with the year 2011 and ending with the year 2020 (an estimated \$360,000 reasonably expected at this time to be collected from the levy of the tax for an entire year), for the purpose of improving, maintaining, acquiring, constructing, furnishing and operating a regional military museum, and the Veterans Memorial Park on Louisiana Highway 311, in the Parish of Terrebonne, State of Louisiana?

SECTION 2. In the event the election carries, this Parish Council does hereby further

consent to and authorize the District to levy and collect the special tax provided for therein.

AN ORDINANCE TO AMEND THE 2010 ADOPTED OPERATING BUDGET AND THE 5 YEAR CAPITAL OUTLAY OF THE TERREBONNE PARISH CONSOLIDATED GOVERNMENT FOR THE FOLLOWING ITEMS:

I. GOVERNOR'S OFFICE OF HOMELAND SECURITY (2010), \$27,763.00
II. CONCRETE SECTIONS PH. II – FEDERAL STIMULUS PROJECT, \$1,715,110.00

SECTION I

WHEREAS, the Parish's Office of Emergency Preparedness Department was allocated \$67,763 under the Emergency Management Performance Grant (EMPG) Program in 2010, and

WHEREAS, the fiscal 2010 grant period is from October 1, 2009 to May 31, 2011, and

WHEREAS, the 2010 budget was for \$40,000 which presents a budget excess of 27,763, and

WHEREAS, these grant monies will be used towards planning costs, organizational costs for operations, purchase of various equipment, training of personnel, and management and administrative fees needed to enable the Emergency Preparedness Department to continue to operate efficiently.

BE IT ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2010 Adopted Budget be amended for the Office of Emergency Preparedness 2010 Grant (Attachment A).

SECTION II

WHEREAS, through American Recovery and Reinvestment Act of 2009 (ARRA) and State of Louisiana, Department of Transportation and Development (DOTD) State Project Number 742-55-0113, Terrebonne Parish Concrete Section Repairs, Phase II will be 100% funded for the construction work by Forby Contracting, Inc. for \$1,715,110, and

WHEREAS, concrete section repairs are removing and replacing damaged concrete panels and stripe select locations on various streets in the Parish.

ORDINANCE NO. 7887

AN ORDINANCE AMENDING THE PARISH CODE OF TERREBONNE PARISH, CHAPTER 18, MOTOR VEHICLES AND TRAFFIC, ARTICLE IV. OPERATION OF VEHICLES, DIVISION 2. PARISH, SECTION 18-87: TO ESTABLISH A "4-WAY STOP" AT THE INTERSECTION OF COTTAGE DRIVE AND SOUTH MOSS DRIVE (CURRENTLY A "2-WAY STOP"); TO AUTHORIZE THE INSTALLATION OF THE REQUIRED SIGNS; AND TO ADDRESS OTHER MATTERS RELATIVE THERETO.

SECTION I

BE IT ORDAINED by the Terrebonne Parish Council, in regular session convened, acting pursuant to the authority invested in it by the Constitution and laws of the State of Louisiana, the Home Rule Charter for a Consolidated Government for Terrebonne Parish, and including, but not limited to, LSA R.S. 33:1368 and other statutes of the State of Louisiana, to amend the parish Codes of Terrebonne Parish, Chapter 18. Motor Vehicles and Traffic, Article IV. Operation of Vehicles, Division 2. Parish, Section 18-87: To establish a "4 Way Stop" at the intersection of Cottage Drive and South Moss Drive, as follows:

CHAPTER 18. MOTOR VEHICLES AND TRAFFIC ARTICLE IV. OPERATION OF VEHICLES DIVISION 2. PARISH SECTION 18-87. 4 WAY STOP INTERSECTIONS

The intersection of Cottage Drive and South Moss Drive (currently a "2 Way Stop") shall hereby be established as a "4 Way Stop" and the appropriate "4 Way Stop" signs shall be erected and maintained at said location. Any vehicle traveling at the afore-mentioned location shall respect and adhere to the signs as posted.

SECTION II

If any word, clause, phrase, section or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections or other portions of this ordinance shall remain in full force and effect, the provisions of this section hereby being declared to be severable.

SECTION III

Any ordinance or part thereof in conflict herewith is hereby repealed.

SECTION IV

This ordinance shall become effective upon approval by the Parish President or as otherwise provided in Section 2-13 (b) of the Home Rule Charter for Consolidated Government for Terrebonne Parish, whichever occurs sooner.

He also stated that he requested and received an Ethics opinion once he took office, regarding whether there would be a conflict with him serving on the Council and the project moving forward, and the opinion that was rendered indicated there was no conflict.

Greg Bush explained that upon commencing work on the excavation area for the Bayou Terrebonne Flood Control Improvement Project, it was discovered that there was a permit violation; that work was halted; and an application was submitted to the U. S. Army Corps of Engineers for modification of the project. He added that the permit has been approved and work has commenced.

Committee Member T. Cavalier inquired about measuring the actual amount of dredge material that has been removed.

Lt. Col. (Ret.) Bush explained that the actual dredge material is measured by technological components which measures the elevation and depth area. He added that the engineer then verifies the dredged area. In response to questioning, he further explained that the contractor has agreed to a negotiated cost to complete the project although he agreed to removing the costs associated with the demolition and rental equipment.

Mr. James Geisher of Shaw Coastal, explained that the contractor initially asked for payment in excess of \$200,000.00; that several items were deemed as inappropriate costs; that the area in question is considered to be a cow pasture; and that after the initial permit was issued, the U. S. Army Corps of Engineers determined that an additional permit was needed.

Committee Member K. Voisin inquired as to whether or not the Corps of Engineers could be billed for the incidental costs incurred due to the additional permit requirement.

Upon questioning, Parish Attorney Courtney Alcock stated that the Corps of Engineers could not be billed, but the additional cost could be borne by the engineer.

Committee Member K. Voisin requested that the Legal Department review the matter with regards to the appropriate party that should bear the \$77,271.57 additional cost and the matter be placed on the next Committee agenda for follow-up.

Parish President Michel Claudet interjected that the \$77,271.57 cost has been withheld from payment to Shaw Coastal until a determination may be made as to who's at fault for not obtaining/knowing that an additional permit was necessary.

Lengthy discussion transpired relative to who should bear the additional cost and the Parish President stated that the contractor acted in "good faith" and should not be penalized.

Chief Finance Officer Jamie Elfert presented the bi-weekly BP fund expenditures report noting that \$494,165.00 has been spent with a remaining balance of \$505,834.35; that Administration has submitted a report of the gross salaries paid for each pay period through the previous pay period; and that the current pay period will be presented by Wednesday's Council meeting.

Committee Member P. Lambert noted that, in a news program, Mr. Kenneth Feinberg stressed that BP claimants must obtain a new claim number from the Claim Center at which they filed their claim. He continued that the Chauvin Claim Center has been closed and that many people were confused as to where to go.

Office of Homeland Security & Emergency Preparedness Director Earl Eues stated that the Parish was unaware of the closure of the Chauvin Claim Center and that after being notified of the closure, an individual was sent to the site to inform claimants of the new location on Grand Caillou Road. Committee Member P. Lambert requested that Administration look into the matter and remedy the situation in order to clear up the confusion caused by the closure of the Chauvin Claim Center.

Williams announced that on 9/14/10 in Lafayette, La, she will be giving testimony before the Bureau of Ocean and Energy Management (BOEM), against the moratorium on drilling in the Gulf of Mexico. She stated that this will be the last hearing prior to their report going into the President of the U.S. She requested the Council's support and asked that any businesses in their districts that have been affected let her know as a basis for her argument.

Parish President M. Claudet announced the following:

- "The Times Picayune" indicates Terrebonne Parish has the largest job loss due to the moratorium on drilling in the Gulf.
- The Chauvin BP Claims Office being closed and Administration's and Councilman Lambert's request for them to reopen one in the area.
- DOTD's response to a request for a turn lane on Park Avenue by the Prospect Street Bridge indicating it is not warranted and a letter being sent by the Council and Administration to the Governor requested re-consideration.
- Hollywood Road asphalt work being done on the turn lanes should be completed by Monday or Tuesday next week. He stated other areas will be asphalted in the near future, such as Coteau Road at Park Avenue and also by Coteau Elementary. He stated the Polk Street project will be done with concrete and the road will have to be closed on each side. He said Highway 182 by Sixth Street should be completed.

Councilman J. Cehan stated there was a recent article in "The Times Picayune" regarding the effects the moratorium is having on Terrebonne Parish and he stated that including Houma, Gibson, and Schriever, there are over 6,000 jobs in the oilfield industry that will be effected by the moratorium. He stressed the importance of getting the moratorium lifted to move on and prosper in Terrebonne Parish.

No action was necessary on agenda item 9A – Information List.

Parish President M. Claudet stated that he had the opportunity to meet with the Under-Secretary of the U.S. Department of Interior, and asked him to give him an indication as to when the moratorium is expected to be lifted. He indicated he would not give a timeline, but did not anticipate any earlier than 30 to 45 days prior to the 11/30/10 lift date, which the earliest would be 10/15/10. He stressed to him the need to have it lifted earlier.

Councilwoman A. Williams stated that she and Councilman A. Tillman were on a conference call with members of the White House Staff and they did mention the need for the moratorium to be lifted because of the effect it is having on Terrebonne Parish.

Council Clerk P. Labat announced that Council Staff Member V. Chauvin was recently elected to the Organization of Parish Administrative Officials Executive Board as the At-Large Member.
