### **SUMMARY:**

This position is under the direct supervision of the Field Operations Supervisor and the general supervision of the Solid Waste Administrator. Utilizing street sweepers, cleans selected streets in Terrebonne Parish. Any function that may be deemed necessary to contribute to a smooth and efficient operation of the Division. As with all positions within the department, response at any time may be required to assist with workload or in any emergencies that may arise.

### **BASIC FUNCTIONS:**

1. Responsible for operating a street sweeper to achieve the systematic cleaning of selected streets and catch basins within Terrebonne Parish.
2. Must be able to learn and practice all applicable safety rules and regulations.
3. Must possess a good working knowledge of equipment assigned.
4. Prepare and maintains records required for proper maintenance of equipment utilized. Maintain daily record/reports as directed.
5. Perform general maintenance and repairs on equipment as directed.
6. Must operate all equipment assigned efficiently in all tasks.
7. Have a good working knowledge of the areas of Terrebonne Parish and the City of Houma.
8. Responsible for maintaining a street sweeping schedule submitted by Supervisor.
9. Must be capable of meeting and communication, with the general public, in a courteous manner.
10. Be willing to learn how to operate other heavy equipment in order that you may substitute for other operators within the Division.
11. Required to work for special events such as Mardi Gras, Downtown Festival, Christmas and any other event directed.
12. Performs any other duties as assigned or deemed necessary by Supervisor.

### **OTHER REQUIREMENTS:**

1. Be capable of operating street sweeper, pickup trucks, tools and any other equipment that is required to perform job functions.
2. Works equipment in field environment in which there is frequent exposure to noise, heat, dust and odorous conditions.
3. Must have mechanical aptitude and the willingness to learn the operations of machines.
4. Must be willing to work extra hours during normal week, weekends, special events and holidays.
5. Must possess and maintain a valid CDL Class B License.
6. Must practice and enforce all applicable Safety Rules and Regulations.
7. Must be willing to work under varying climatic conditions.

### **EDUCATION/EXPERIENCE:**

1. Must have a High School Diploma or GED certificate.
2. Must be able to read or write sufficiently to carry out basic instructions.
3. A minimum of one year of appropriate and responsible experience in the field of operating heavy equipment is preferable.
