PHYSICAL DEMANDS

- Lift over 50 lbs. (heavy)
- Roll carts and cages
- Bend and stretch to inspect/ disinfect cages and mop floors

WORK ENVIRONMENT

- Interactions with members of the public
- Indoors and outdoors in varying climates and conditions, including exposure to noise, chemicals, cold/ head, dust, disease, and odors.

EMERGENCY EVENTS

Required to work during emergency events.

ESSENTIAL FUNCTIONS

- Perform all housekeeping, cleaning, sanitizing, and disinfecting procedures in animal holding rooms and throughout the facility.
 Replenish supplies throughout the shelter as needed.
- Receive animals. Perform intake procedures such as vaccinating, microchip scanning, photographing, deworming, etc.
- Provide daily nutrition to shelter animals according to their species, age weight, etc.
- Bathe, flea dip, and/or groom animals to prevent suffering and to enhance adoptability.
- Assess shelter animals' behavior and health condition and implement animal behavior treatment plans. Notify veterinary staff of sickness and/or injuries. Give medication and vaccinations to animals as needed.
- Assist with euthanasia and disposal of euthanized animals. Assist veterinarian with surgery and treatment of animals. Assist animal control officers with placement of impounded animals.
- Maintain medication, vaccination, daily log, and other records as required.
- Perform general maintenance and make minor repairs on shelter equipment.
- Assist public in viewing shelter animals and answering their questions.
- Perform other duties as assigned by supervisor.

GENERAL REQUIREMENTS

- Obtain and maintain certification in Canine Behavior Assessment.
- Understand applicable scientific concepts and terminology.
- Possess basic computer skills and effective written and oral communication skills.
- Possess knowledge of overall operations of division and ability to use analytical judgment and decision-making abilities.
- Learn and practice applicable safety rules and regulations.
- Read and write sufficiently to understand and carry out basic instructions.
- An affinity for animals and respect for their welfare.
- Comfortable handling animals.
