- A Driver's License or Picture ID with person's name on it for all adults 18 years and older in the household. Handicapped ID's WILL NOT be accepted. It must be an unexpired license or ID.
- Current proof of income for everyone in household receiving income (Ex. last 4 consecutive check stubs, 2020 social security or SSI printout), 2019 income tax forms if self employed. If you receive unemployment we need the printout for the last 30 days of activity with name of recipient.
