Terrebonne Parish Information

1) Coast Guard representatives in Cocodrie reported:

· Personnel are conducting waterside surveillance for offshore and shoreline impact of oil.

 \cdot 42-inch VOSS sea boom is being deployed in sections where previously deployed boom has been ineffective and/or misplaced.

· Total personnel in Cocodrie: 792

· 72 bags of soiled sorbent boom have been removed.

 \cdot Sub-sea dispersant injection continues at the Blow Out Preventer (BOP) at a rate of 10 gallons per minute.

• The US Coast Guard (USCG) reports Drill Rig DDIII casing is set at 12,057 feet, with a well depth of 13,978 feet; drilling is on day 36 of 104 (or estimated 34 percent completed).

 \cdot Drill Rig DDII casing is set at 8,576 feet, with a well depth of 8,650 feet; a complete diagnosis is underway with an anticipated latch date of early next week.

• Daily average oil production by the ENTERPRISE is estimated at 15,082 barrels per day.

 \cdot The ENTERPRISE is at capacity with offloading scheduled to take place today with the MASSACHUSETIS.

 \cdot Of the four vents, only one has been closed on the TOP HAT.

• Deployment of Skimmers: 1 positioned between Wine Island and Trinity Island, 1 between Wine Island and Timbalier Island, 3 skimming designated routes in Lake Barre' and Terrebonne Bay.

 \cdot Reported an approximate 30'-40' section of containment boom that was washed up on the marsh bank of Grand Caillou Bayou.

 \cdot Reported 3 boats deploying containment boom from bank to bank at the mouth of the Main Pass Islettes.

 \cdot Reported 2 air boats and 2 small boats deploying deflection boom at the mouth of Pelican Bayou.

 \cdot Reported containment boom being deployed at the mouth of Little Misale Bayou. Nearby, there was a section of boom stuck on the bank of Little Misale Bayou.

· Reported 3 boom deployments in the northernmost section of Bay Blanc.

Cleanup Progress

· Continued beach reconnaissance and manual recovery of discovered oil.

2) Oil impact reports:

• Assessment Team reported from the Bay side of Whiskey Island that they observed a maximum tar ball concentration of approximately 5% per square yard. The average tar ball concentration on the entire island was approximately 0%-1% per square yard. This was observed and reported as being new oil. On the Gulf side of Whiskey Island no oil was observed on the Sargasso. Previously oiled (occurring offshore) vegetation (water hyacinths) was reported washing ashore approximately 15-20 yards on the beach.

Training Opportunities for Deck Hands and Beach Clean-up Workers
