MINUTES

HOUMA-TERREBONNE REGIONAL PLANNING COMMISSION (HTRPC) MEETING OF FEBRUARY 25, 2010

- A. The Chairman, Daniel Babin, called to order the regular meeting of February 25, 2010 of the Houma-Terrebonne Regional Planning Commission (HTRPC) at 6:35 p.m. in the Terrebonne Parish Council Meeting Room with the Invocation led by Dr. L. Arnold "Budd" Cloutier and the Pledge of Allegiance led by Mr. Richard Elfert.
- B. Upon Roll Call, present were: Mrs. Beryl Amedée, Mr. Daniel Babin, Chairman; Dr. L. E. COMMUNICATIONS:

- 1. Mr. Gordon read a memo from Mr. Paul Labat, Council Clerk, with regard to two (2) ordinances concerning establishing a moratorium in a certain area of the parish and revoking the rights-of-ways on stub out streets adjacent to Southern Estates Subdivision and Tara Subdivision.
 - a) He stated this has not changed the layout of the proposed Three Oaks Subdivision and they would have to come back to the Planning Commission should they wish to change the layout and request a variance from the cross street requirements.
 - b) Discussion was held with regard to the moratorium, ownership of the stub-outs and acceptance of engineering applications not being a good idea.

- 2. The Chairman called to order the Public Hearing for the application by Babette Scott requesting approval for Process D, Minor Subdivision for the Survey of Tracts "A", "B", & "C", A Redivision of a portion of property belonging to Babette Scott, et als.
 - a) Mr. Ken Rembert, Keneth L. Rembert Land Surveyors, representing the Developer, discussed the location and division of property.
 - b) The Chairman recognized Ms. Rosa Scott, 443 Bayou Dularge Road, who expressed concerns of the Board of Health and her driveway that is on the adjacent property.
 - c) Discussion was held with regard to the driveway and it being built in the incorrect place.

 - a) Mr. Ken Rembert, Keneth L. Rembert Land Surveyors, representing the Developer, discussed the location and division of property.

The Engineering Division of the Terrebonne Parish Department of Public Works has reviewed the plans and calculations for the above referenced subdivision. The plans and calculations fail to comply with Parish Ordinances and Subdivision Regulations in the following areas:

- 1. 24.7.6.2.6 Does not conform to SDDM:
 - a. V.A.1, 24.5.4.8.2 Contours at one (1) foot intervals or less not shown on drainage plan.
 - b. V.A.2 Lot grading need to be shown on proposed site plan.
 - c. V.A.6 Cross sections show fill being placed on neighboring property.
 - d. V.A.6 Developer is requesting that the filling and grading of the lots be deferred until the Building Permit stage.
 - e. V.A.6 Proposed lot grading blocks the drainage of adjacent property.
 - f. V.C.2 Minimum Service life is not provided for drainage structures.
 - g. V.C.8 All drainpipes under roadway are not joined in conformance with LaDOTD Type 3 joints.
 - j. V.C.10 Driveway culverts are not sized as though entire subdivision was subsurface.
 - k. VIII.A.1 Insufficient drainage servitude for CH 3.
- 2. 24.5.4.8.2,3 Proposed culvert sizes provided do not fit within the ditch.
- 3. 24.5.4.6.7 No approval letter from the following:
 - 1. Waterworks
 - 2. Gas Utility
 - 3. Electric Utility
 - 4. Department of Health and Hospitals
 - 5. TPCG Pollution Control

- 4. 24.7.6.4 Benchmark location, description, and elevation are not shown on plat.
- 5. 24.7.2.1 The concrete for the median cut should be 9" thick.
- 6. 22-353(d) Copy of the Notice of Intent (NOI) must be submitted.
