### **ZONING & LAND USE COMMISSION**

#### MEETING OF FEBRUARY 25, 2010

- A. The Chairman called the meeting of February 25, 2010 of the HTRPC, convening as the Zoning and Land Use Commission, to order at 6:00 p.m. in the Terrebonne Parish Council Meeting Room with the Invocation led by Dr. L.A. "Budd" Cloutier, Jr. and the Pledge of Allegiance led by Mrs. Marsha Williams.
- B. Upon Roll Call, present were: Mrs. Beryl Amedée; Mr. Daniel Babin, Chairman; Dr. L.A. "Budd" Cloutier, Jr., Vice-Chairman; Mr. Richard Elfert; Mr. James Erny; Mr. Keith Kurtz; Mr. John Navy; Mr. Alex Ostheimer; and Mrs. Marsha Williams, Secretary/Treasurer. Absent at the time of Roll Call were: None. Also present were Patrick Gordon, Director, and Jennifer Robinson, Senior Planner, Department of Planning & Zoning, and Laddie Freeman, Legal Advisor.
- C. Dr. Cloutier moved, seconded by Mr. Navy: "THAT the HTRPC, convening as the Zoning & Land Use Commission, accept the minutes, as written, for the Zoning and Land Use Commission for the regular meeting of January 21, 2010."

The Chairman called for a vote on the motion offered by Dr. Cloutier. THERE WAS RECORDED: YEAS: Mrs. Amedée, Dr. Cloutier, Mr. Elfert, Mr. Erny, Mr. Kurtz, Mr. Navy, Mr. Ostheimer, and Mrs. Williams; NAYS: None; ABSTAINING: Mr. Babin; ABSENT: None. THE CHAIRMAN DECLARED THE MOTION ADOPTED.

- E. NEW BUSINESS:
  - 1. Planned Building Group:
    - a) The Chairman stated the next item on the agenda was an application by James Hyatt requesting planned building group approval for placement of a triplex and a duplex at 1930 Prospect Boulevard.
      - (1) The Chairman recognized Mr. James Hyatt, 116 Timberwood, Gray, who requested planned building group approval to place a triplex and a duplex on his property at 1930 Prospect Boulevard.
      - (2) Mrs. Robinson discussed the Staff Report and stated Staff recommended approval of the planned building group request.
      - (3) Mr. Erny moved, seconded by Dr. Cloutier: "THAT the HTRPC, convening as the Zoning and Land Use Commission, grant planned building group approval for the placement of a triplex and a duplex at 1930 Prospect Boulevard."
      - (4) Discussion was held with regard to school buses, garbage, and driveways.

- b) The Chairman stated the next item on the agenda was an application by Marcellino & Clara Mora requesting planned building group approval for the placement of an additional mobile home at 218 & 218A Henderson Street.
  - (1) The Chairman recognized Mr. Marcellino Mora, represented/translated by his son, 218 Henderson Street, who requested planned building group approval for the placement of (2) mobile homes that would include a playground and enough parking.
  - (2) Mrs. Robinson discussed the Staff Report and stated Staff recommended approval of the planned building group request subject to the applicants receiving a Special Exception from the Houma Board of Adjustment.
  - (3) Mr. Erny moved, seconded by Mr. Navy: "THAT the HTRPC, convening as the Zoning and Land Use Commission, grant planned building group approval for the placement of an additional mobile home at 218 & 218A Henderson Street."

(4) Discussion was held with regard to the special exception requirement and Henderson Street's makeup as all existing mobile homes.

- c) The Chairman stated the next item on the agenda was an application by Lenard Calloway requesting planned building group approval for the placement of an additional residential structure at 349 & 349A Naquin Street.
  - (1) The Chairman recognized Mr. Lenard Calloway, who requested planned building group approval for the placement of an additional residential structure.
  - (2) Mrs. Robinson discussed the Staff Report and stated one (1) letter of objection from an adjacent property owner. She stated Staff recommended approval of the planned building group request.
  - (3) Discussion was held with regard to the location of the request, etc.
  - (4) The Chairman recognized Mr. Herman Torregano, 346 Railroad Avenue, who expressed concerns regarding crime, murders, and drugs and strongly objected to the request.
  - (5) Mr. Erny moved, seconded by Mr. Navy: "THAT the HTRPC, convening as the Zoning and Land Use Commission, grant planned building group approval for the placement of an additional residential structure at 349 & 349A Naquin Street."
  - (6) Mr. Ostheimer offered a substitute motion, seconded by Mrs. Williams: "THAT the HTRPC, convening as the Zoning and Land Use Commission, table the planned building group application for the placement of an additional residential structure at 349 & 349A Naquin Street until the next regular meeting of March 18, 2010."
