**DOWNTOWN DEVELOPMENT CORPORATION:** One (1) expired term. Representing the Economic Development Advisory Board (EDAB)/Council.

**TERREBONNE PARISH TREE BOARD:** One (1) expired term.

**TERREBONNE PARISH ADVISORY COMMITTEE FOR DISABILITIES AFFAIRS BOARD:** One (1) vacancy representing Terrebonne Parish School Board.

**CHILDREN AND YOUTH SERVICES PLANNING BOARD:** Four (4) expiring terms on 05-15-26. (Each representing the following entities: two (2) representing Social Services, one (1) representing Mental Health and one (1) representing Recreation).

**T.A.R.C.:** Three (3) expiring terms on 05-31-26.

Interested individuals wishing to be appointed to a Recreation Board must be a resident of the Recreation District and be willing to attend regularly scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein.
