RECREATION DISTRICT NO. 2-3 BOARD: One (1) vacancy due to a resignation and three (3) expiring terms on 05-31-26.

TERREBONNE PARISH TREE BOARD: One (1) expired term.

HOUMA AREA CONVENTION AND VISITOR BUREAU: One (1) vacancy due to a resignation. (Representing a Civic Non-Profit Organization)

TERREBONNE PARISH ADVISORY COMMITTEE FOR DISABILITIES AFFAIRS BOARD: One (1) vacancy representing Options for Independence.

CHILDREN AND YOUTH SERVICES PLANNING BOARD: Four (4) expiring terms on 05-15-26. (Each representing the following entities: two (2) representing Social Services, one (1) representing Mental Health and one (1) representing Recreation) and one (1) expired term. (Representing Education)

T.A.R.C.: Three (3) expiring terms on 05-31-26.

Interested individuals wishing to be appointed to a Recreation Board must be a resident of the Recreation District and be willing to attend regularly scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein.
