**RESOLUTION NO. 22-165**

A RESOLUTION TO PROCLAIM THE QUALIFYING DATES FOR THE SPECIAL ELECTION FOR THE OFFICE OF TERREBONNE PARISH CONSTABLE, WARD TWO

**WHEREAS**, the death of Louis Joseph “L.J.” Schexnayder, Sr., has resulted in a vacancy of public office of Terrebonne Parish Constable, Ward Two; and

**WHEREAS**, La. R.S. 18:604B(2)(a) requires that a local governing body issue a proclamation ordering a special election within twenty days of the vacancy of the position;

**WHEREAS**, Louisiana Revised Statute 18:602(E) requires that a local governing body issue a proclamation for a special election when the unexpired term of the vacant office exceeds one year;

**WHEREAS**, a special election has been called for Terrebonne Parish Constable, Ward Two, with a primary election date of November 8, 2022, and a general election date of December 10, 2022,

**NOW THEREFORE BE IT RESOLVED**, on behalf of the Terrebonne Parish Consolidated Government, that;

The qualifying dates for the special election for the Terrebonne Parish Constable, Ward Two shall be July 20, 21, and 22, 2022.
