## **IN REGULAR SESSION**

#### May 22, 2019

The Chairwoman, Ms. A. Williams, called the meeting to order at 6:02 p.m. in the Terrebonne Parish Council Meeting Room. Following the Invocation offered by Council Member D. J. Guidry, Council Member A. Marmande led the Pledge of Allegiance.

Upon roll call, Council Members recorded as present were: A. Williams, G. Michel, C. Duplantis-Prather, D. W. Guidry, Sr., A. Marmande, D. J. Guidry, and S. Trosclair. J. Navy and S. Dryden were recorded as absent. A quorum was declared present.

Ms. C. Duplantis-Prather moved, seconded by Mr. D. W. Guidry, Sr., "THAT the Council approve the minutes of the Regular Council Session held on April 24, 2019."

The Chairwoman called for a vote on the motion offered by Ms. C. Duplantis-Prather. THERE WAS RECORDED: YEAS: A. Williams, G. Michel, C. Duplantis-Prather, D. W. Guidry, Sr., A. Marmande, D. J. Guidry, and S. Trosclair. NAYS: None. ABSENT: J. Navy and S. Dryden.

The Chairwoman declared the motion adopted.

Ms. C. Duplantis-Prather moved, seconded by Mr. S. Trosclair, "THAT the Council approve the Accounts Payable Bill Lists for 5/13/2019 and 5/20/2019."

The Chairwoman called for a vote on the motion offered by Ms. C. Duplantis-Prather. THERE WAS RECORDED: YEAS: A. Williams, G. Michel, C. Duplantis-Prather, A. Marmande, D. J. Guidry, and S. Trosclair. NAYS: None. ABSENT: J. Navy and S. Dryden. ABSTAINING: D. W. Guidry, Sr. The Chairwoman declared the motion adopted.

Mr. D. J. Guidry moved, seconded by Ms. C. Duplantis-Prather, "THAT the Council approve the Manual Check Listing for April 2019."

The Chairwoman called for a vote on the motion offered by Mr. D. J. Guidry. THERE WAS RECORDED: YEAS: A. Williams, G. Michel, C. Duplantis-Prather, D. W. Guidry, Sr., A. Marmande, D. J. Guidry, and S. Trosclair. NAYS: None. ABSENT: J. Navy and S. Dryden. The Chairwoman declared the motion adopted.

Mr. S. Trosclair moved, seconded by Mr. A. Marmande, "THAT the Council deviate from the regular order of business to discuss Agenda Item 2.-A. 'Other Projects.'

The Chairwoman called for a vote on the motion offered by Mr. S. Trosclair. THERE WAS RECORDED:

YEAS: A. Williams, G. Michel, C. Duplantis-Prather, D. W. Guidry, Sr., A. Marmande, D. J. Guidry, and S. Trosclair. NAYS: None. ABSENT: J. Navy and S. Dryden. The Chairwoman declared the motion adopted.

The Chairwoman recognized Mr. Gordon Dove, Parish President, who gave a presentation regarding a planned Morganza Spillway opening and the measures currently being taken to address increasing water elevations and backwater flooding throughout the Parish.

Upon the Chairwoman's request, Mr. Dove clarified that additional pumps had been received through GOHSEP in order to assist with water control efforts in the Parish and that a Presidential Declaration of Emergency was expected to assist with costs related to temporary installations and other emergency response measures.

The Chairwoman recognized Mr. Mike Toups, Parish Manager, who gave a brief report regarding the status of ongoing pump station projects, including updates for those pump stations at Enterprise Marine, Savanne Road, Williams Street, Isle de Jean Charles, and Coteau. He reported that all backup generators were functioning properly as of reporting and that three additional pumps had been received through the U.S. Army Corps of Engineers to be used on a first-priority basis in the Parish to better address backwater flooding in the Gibson/Bayou Black area.

Council Member D. W. Guidry, Sr. suggested that the weir located at Jim Bowie Park could be lowered and cleared as an effort to help localized flooding and shared his resolve to prevent flooding damage for Terrebonne Parish residents.

Upon Council Member D. W. Guidry's request, the Chairwoman recognized Mr. David Rome, Public Works Director, who stated that the Public Works Department has been in cooperation with the Consolidated Waterworks District to address the water restrictions at the aforementioned weir. He then clarified that Minors Canal would remain open but that he asked that the Elliot Jones Canal be closed to prevent the pumps in operation from circulating the same water. He also confirmed that, should Minors Canal be closed, advance notice would be given to locals in the area prior to closing to retrieve vessels or other property.

Upon the Chairwoman's request, Mr. Rome reported on his discussions with GOHSEP and plans to install temporary dams to help control water flow concerns with increasing water levels to be expected with the opening of the Morganza.

The Chairwoman read aloud letters from Council Member J. Navy and Council Member S. Dryden explaining their absences from the evening's proceedings.

Mr. S. Trosclair moved, seconded by Ms. C. Duplantis-Prather, "THAT the Council return to the regular order of business."

The Chairwoman called for a vote on the motion offered by Mr. S. Trosclair. THERE WAS RECORDED: YEAS: A. Williams, G. Michel, C. Duplantis-Prather, D. W. Guidry, Sr., A. Marmande, D. J. Guidry, and S. Trosclair. NAYS: None. ABSENT: J. Navy and S. Dryden. The Chairwoman declared the motion adopted.

Council Member C. Duplantis-Prather read aloud a proclamation proclaiming the month of May 2019 as "National Military Appreciation Month" in Houma-Terrebonne.

Council Member G. Michel announced that there would be a Memorial Day event at the Regional Military Museum beginning at 10:30 a.m. on May 25, 2019 and encouraged the public to attend.

Council Member G. Michel read aloud a commendation commending Houma Fire Department District Chief Hayward Sims Jr. on his recent retirement.

The Chairwoman recognized Mr. Hayward Sims, Jr., retired Houma Fire Department District Chief, who shared his many thanks for the opportunity to work for the Houma Fire Department and serve Houma and Terrebonne Parish in those times of emergency.

Several Council Members congratulated Mr. Sims on his retirement and thanked him for his dedication to his community for serving as firefighter and as a local pastor.

Council Member D. W. Guidry, Sr. read aloud a commendation commending Houma Fire Department District Chief Todd Rhodes on his recent retirement.

The Chairwoman recognized Mr. Todd Rhodes, retired Houma Fire Department District Chief, who thanked the Council for the commendation and shared his thanks for the opportunity to work for the Houma Fire Department and serve the community.

Several Council Members congratulated Mr. Rhodes on his retirement and thanked him and the families of the recently retired firefighters for their supporting the calls to serve the community as firefighters.

The Chairwoman recognized Mr. Keith Ward, Houma Fire Chief, who shared some of the statistics on record regarding the number of responses each retiree answered over their careers since 2001 and commended the retirees for their pride and dedication to the department and to the community at large.

#### **ORDINANCE NO. 9052**

AN ORDINANCE TO AMEND THE 2019 ADOPTED OPERATING BUDGET AND 5-YEAR CAPITAL OUTLAY BUDGET OF THE TERREBONNE PARISH CONSOLIDATED GOVERNMENT FOR THE FOLLOWING ITEMS AND TO PROVIDE FOR RELATED MATTERS:

- I. GENERAL FUND-OFFICE OF EMERGENCY PREPAREDNESS-2019 CITIES READINESS INITIATIVE, \$18,417
- **II.** LOWER LITTLE CAILLOU DRAINAGE PUMP STATION REPLACEMENT, \$892,651
- **III.** SPORTS COMPLEX-PARKING LOT, \$100,000
- IV. HOLLYWOOD ROAD EXTENSION BRIDGE, \$99,740

## **SECTION I**

WHEREAS, the Louisiana Department of Health and Hospitals, Office of Public Health has requested to participate in contracts with designated Parishes for the purpose of aiding cities and increasing their capacity to deliver medication and medical supplies during a large scale public health emergency, and

**WHEREAS**, this initiative focuses on a very specific element of preparedness, the ability to provide antibiotics to the entire population within forty-eight hours of the decision to do so, and

**WHEREAS**, Terrebonne Parish is one of the designated Parishes with whom the Office of Public Health has contracted to fulfill the grant requirements of the Public Health Emergency Preparedness (PHEP) Program for \$18,417.

**NOW, THEREFORE BE IT ORDAINED**, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2019 Adopted Operating Budget be amended to recognize the funding for the 2019 Cities Readiness Initiative Budget. (Attachment A)

#### **SECTION II**

**WHEREAS**, Terrebonne Parish Consolidated Government has been awarded \$892,651 by the Department of Transportation and Development for the Lower Little Caillou Drainage Pump Station Replacement, and

**WHEREAS**, these funds will be used for Lower Little Caillou Drainage Pump Station Replacement, also known as Lashbrook pump station replacement.

**NOW, THEREFORE BE IT FURTHER ORDAINED**, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2019 Adopted Operating Budget and 5-Year Capital Budget be amended for the Lower Little Caillou Drainage Pump Station Replacement. (Attachment B)

#### **SECTION III**

WHEREAS, additional funding is needed for the Sports Park parking lot for \$100,000, and

**WHEREAS**, the funding source is from the Parishwide Construction Fund through exchanged funding.

**NOW, THEREFORE BE IT FURTHER ORDAINED**, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2019 Adopted Operating Budget and 5-Year Capital Outlay Budget be amended for the Sports Park Project. (Attachment C)

#### **SECTION IV**

**WHEREAS**, funding is needed for engineering of the Hollywood Road Extension Bridge for \$99,740, and

WHEREAS, the funding source is from the Road and Bridge Construction Fund.

**NOW, THEREFORE BE IT FURTHER ORDAINED**, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2019 Adopted Operating Budget and 5-Year Capital Outlay Budget be amended for the Hollywood Road Extension Bridge. (Attachment D)

#### **SECTION V**

If any word, clause, phrase, section or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections and other portions of this ordinance shall remain in full force and effect, the provisions of this ordinance hereby being declared to be severable.

## **SECTION VI**

This ordinance shall become effective upon approval by the Parish President or as otherwise provided in Section 2-13(b) of the Home Rule Charter for a Consolidated Government for Terrebonne Parish, whichever occurs sooner.

#### **RESOLUTION NO. 19-182**

## PARISH OF TERREBONNE IN THE NAME AND BY THE AUTHORITY OF THE TERREBONNE PARISH COUNCIL

A RESOLUTION CONCURRING WITH A RESOLUTION ORDERING AND CALLING A SPECIAL ELECTION TO BE HELD IN THE FIRE DISTRICT NO. 8 OF THE PARISH OF TERREBONNE, STATE OF LOUISIANA, TO AUTHORIZE THE RENEWAL OF A SPECIAL TAX THEREIN, MAKING APPLICATION TO THE STATE BOND COMMISSION IN CONNECTION THEREWITH AND PROVIDING FOR OTHER MATTERS IN CONNECTION THEREWITH.

WHEREAS, the Board of Commissioners of the Fire District No. 8 of the Parish of Terrebonne, State of Louisiana (the "District") will adopt a resolution calling an election on **October 12, 2019** to authorize the renewal and levy of special taxes therein.

WHEREAS, the District has requested that this council concur in said resolution.

NOW THEREFORE, BE IT RESOLVED by the Terrebonne Parish Council that:

Section 1. This Council does hereby approve, ratify and concur in that certain resolution of the Board of Commissioners of the Fire District No. 8 of the Parish of Terrebonne, State of Louisiana to be adopted on July 2, 2019. (Exhibit A)

Section 2. This resolution shall become effective immediately upon its adoption.

## THERE WAS RECORDED:

YEAS: A. Williams, G. Michel, C. Duplantis-Prather, D. W. Guidry, Sr., A. Marmande, D. J. Guidry, and S. Trosclair. NAYS: None. ABSTAINING: None. ABSENT: J. Navy and S. Dryden. The Chairman declared the resolution adopted on this the 22<sup>th</sup> day of May 2019.

The Chairwoman recognized Ms. April Newman, CPRA representative, along with Ms. Jennifer Smith, NOAA representative, who gave a brief overview regarding the Bayou DeCade Ridge and Marsh Creation Project. Ms. Newman reported that the project was projected to begin construction within the next year with construction funds being provided through federal and state sponsorship. She thanked the Council and Mr. Mart Black for their support of the project to create or nourish 473 acres of marshland and restoring 11,131 linear feet of a 5 feet high ridge in the Bayou DeCade area.

Several Council Members thanked CPRA, NOAA, and Mr. Mart Black for their efforts toward supporting and promoting the funding of the 27 million dollar project and shared their optimism for the project and its benefits to the Parish.

The Chairwoman recognized Mr. Teddy Crochet, Acadian Ambulance Operations Manager, who addressed earlier concerns raised by Mrs. Darlene Williams regarding ambulance staging in the Johnson Ridge area. Mr. Crochet stated that their staging policies for law enforcement were consistent throughout their service areas, with staging being determined by the nature of an emergency call, not the location. He clarified that he could not divulge details regarding a particular response due to HIPAA and patient confidentiality laws, and he stated that

their policy for staging until law enforcement officials secure a scene was in the interest of protecting the well-being of the employees.

The Chairwoman recognized Ms. Darlene Williams, Gray resident, who asked Acadian Ambulance for clarification regarding their policy for determining the degree of safety required to respond to an emergency call then shared some of her concerns regarding the staging policy as currently implemented. She then suggested that efforts could be made to improve the assessments, response times, and staging policies with Acadian Ambulance and law enforcement when responding to non-threatening medical emergencies.

The Chairwoman suggested that a group discussion be held between Acadian Ambulance, Terrebonne Parish Sheriff's Office, and other agencies in order to find any potential improvements that could be made with regards to improving response times when staging for emergency calls.

Mr. Crochet reiterated his concern for potential risks for emergency responders attempting to perform their duties and clarified that, should their dispatchers or the 911 operator determine there is a concern for safety in responding to a call, they will stage until the scene is cleared by law enforcement so they can also operate safely.

Council Member C. Duplantis-Prather suggested that Terrebonne Parish 911 also be included in the group discussion then thanked Ms. Williams and Mr. Crochet for their input and clarifications.

The Chairwoman recognized Mr. Matthew Matherne, Houma resident, who shared his concerns regarding the upkeep and safety of sidewalks and crosswalks in and around the downtown area of Houma and asked for assistance or guidance in addressing those issues.

Council Member C. Duplantis-Prather thanked Mr. Matherne for his initiative and stated that the Council could contact Public Works or Administration to address the upkeep of the sidewalks he had discovered in need of care then suggested that he contact the MPO to share his support for improving visibility of crosswalk boundaries and other features for those roads declared as state highways in and around the downtown area.

Council Member D. J. Guidry suggested that Mr. Matherne could attend the next MPO Committee meeting where several Council Members are also members of that Committee and bring his concerns to be discussed and to become more involved.

Council Member G. Michel suggested that Mr. Matherne get in contact with his Council representative and that they could work together to determine the best contacts or courses of action to see his desired improvements made.

The Chairwoman recognized Ms. Caroline Mosely, Gibson resident, who presented to the Council a video which surveyed the annual flooding found at and around her home present since March 2019. She then stated that both she and service people are unable to access her home during this flooding due to the private road having been abandoned and left in disrepair.

Council Member G. Michel suggested that the Parish could contact the owner of the property and road to enforce proper maintenance of the roadway as needed for emergency vehicle access as a measure to see some improvement.

The Chairwoman recognized Mr. David Rome, Public Works Director, who clarified that the issue has been a flooding issue over 20 years then gave a history of the rejected flood control measures attempted in previous years to prevent flooding in the area. He stated that funding still existed via the Statewide Flood Control Plan for building a levee and suggested that the local residents be contacted to approve rights-of-way that would allow such a levee to be constructed. A discussion ensued relative to the Parish's ability to provide assistance with regards to the current state of the private road and flooding. Mr. Mike Toups clarified that in order for the Parish to accept the road and take over maintenance of it, the owner would have to provide hard surfacing for the roadway to be eligible for acceptance as per the Parish Code.

The Chairwoman recognized Mr. Anthony Rainey, Gray resident, who stated he is currently serving on the Recreation District No. 1 Board and seeking re-appointment but was told by the Board Chairman he could not be re-appointed due to his working for the Terrebonne Parish Recreation Department.

The Chairwoman recognized Mr. Julius Hebert, Parish Attorney, who stated that, pending Mr. Rainey's job description with the Recreation Department as a Boys and Girls Supervisor, there could be potential conflicts of interest between the position with the Recreation Department and the Recreation District Board. He then recommended that the Council move to hold nominations open for the expiring term on the Recreation District No. 1 Board until the next Council Meeting so that greater detail could be collected before he provided a legal opinion on the matter.

Council Member G. Michel shared his support for postponing a vote to appoint someone to the Recreation District No. 1 Board until the next Council Meeting so that Mr. Rainey could still seek to be re-appointed to the board should the legal opinion allow for it.

Upon Council Member D. W. Guidry's request, Mr. Hebert clarified that similar situations would have to be adjudicated on a case by case basis as individual job descriptions and their potential for conflicts of interest could greatly vary per the individual situation.

The Chairwoman called for a report on the Public Services Committee meeting held on 5/20/19, whereupon the Committee Chairman, noting that ratification of minutes calls a public hearing on June 12, 2019 at 6:30 p.m., rendered the following:

At this time in the proceedings (5:46 p.m.), Chairman J. Navy relinquished the chair to Vice-Chairwoman C. Duplantis-Prather.

Committee Member J. Navy asked that Agenda Item No. 10- Discussion and possible action regarding maintenance costs of Recreation District Projects such as Airbase Splash Park and Field of Dreams Projects, be placed on the agenda to clarify questions regarding maintenance cost and other fees associated with maintaining said parks.

Mr. David Waitz, Engineer with Waitz Engineering and Surveying Company, addressed the Council relative to the matter of maintenance cost for various splash parks. He explained that the Airbase Splash Park has twenty (20) cylindoids that turn on a specific water feature. He

stated that the cost of this item is approximately \$90.00 and its estimated life expectancy is approximately ten to fifteen years, with proper maintenance and cleaning. Mr. Waitz further explained that the water is filtered through a pass through system, which means that the water comes from the water supply and runs through the different features and then goes into the gravity system; stating that this project is relatively "low" maintenance as it relates to cost. The only cost incurred is the cost of water.

Mr. J. Haston, Recreation District No. 9 Director, addressed the Council relative to the matter of maintenance cost as it relates to the operation of splash parks. He explained that Bayou Black operates a splash park that is approximately 7,000 square feet that uses the water pass through system. He stated that the cost for the amount of water used in the last two years is approximately \$5,600.00, which also includes the cost of water for the swimming pool. Mr. Haston explained that the splash park opened in April 2016 and has a high usage rate during the months of April and May when school is in session for field trips, etc. He further explained that the park is open in April, on weekends only, and when school is out they are open seven days a week until school starts. Accordingly, Mr. Haston stated that the park is closed during the months of October through April, with no cost incurred during this time; noting that they have three employees that work two at a time in thirty minute intervals and there has been no incidents of accidents stating that they monitored the splash park for safety.

Committee Member J. Navy explained that the splash park is "not" going to be a burden for the Recreation Districts; noting that the main cost for the splash park is the cost of water.

Committee Member D. J. Guidry stated that he has been in contact with Waterworks Director M. Sorbert regarding the price of water and the maintenance cost for the upcoming splash park and was told that the parish will be sold water at cost price. He further stated that this project will be a great asset to Terrebonne Parish.

Upon questioning from Committee Member J. Navy regarding the maintenance cost of the Field of Dreams Project, Planning and Zoning Director C. Pulaski explained that the Recreation District No. 2,3 is responsible for the maintenance cost of the Field of Dreams project under their operational agreement.

Parish Attorney J. Hebert explained that under the "current" CEA (Cooperative Endeavor Agreement), Recreation District No. 2,3 is going to be responsible for the maintenance for the Field of Dreams (Bayou Country Sports Park); stating that this park will probably generate funding to cover the maintenance cost.

Discussion ensued with several Committee Members expressing concerns over maintenance cost for other recreational facilities and whether or not the facilities will be profitable and of economical benefit.

Planning and Zoning Director C. Pulaski explained that the Bayou Country Sports Park is a part of the Master Plan; stating that it is a regional park for all parish citizens with an economic development component. Mr. Pulaski stated that the Bayou Country Sports Park, as part of the Master Plan, will be comprised of five softball fields, five baseball fields, four multi-purpose fields, eight-court tennis complex, a gymnasium, two open-air pavilions, a pond and sand bars, a volleyball park area, a playground, a dog park area and splash park areas; noting that the only component of the Master Plan that has been eliminated is the skate park that was constructed by Houma-Terrebonne Civic Center.

Further discussion ensued with several Committee Members discussing the usage of the hotel/motel tax as it relates to tourism, recreation and the Field of Dreams Project.

Committee Member C. Duplantis-Prather asked Comptroller K. Dupre to research the hotel/motel tax provisions and present that information to the Council for clarification purposes.

Mr. D. J. Guidry moved, seconded by Mr. J. Navy, "THAT, there being no further business to come before the Budget & Finance Committee, the meeting be adjourned."

The Vice-Chairwoman called for the vote on the motion offered by Mr. D. J. Guidry. THERE WAS RECORDED:
