

## NOTICE TO THE PUBLIC

The Terrebonne Parish Council is seeking individuals to serve on various boards, committees, and commissions designed to maintain and improve the quality of life in our community. The agencies in need of members are governmental or quasi-governmental organizations that require people who are familiar with the agency and are willing to give of their time and talents. At the January 11, 2012 meeting of the Parish Council, individuals are scheduled to be appointed to the following agencies:

- Bayou Blue Fire Protection District Board: (Two vacancies). Interested individuals must be resident/property owners of the Bayou Blue Fire District (Terrebonne Parish side) and interested in the administration of fire protection services in the area.
- Recreation District No. 1 Board: (One vacancy) Interested individuals must be residents of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein.
- Downtown Development Corporation: Two vacancies, one to be nominated by a garden club and one to be nominated by the Historical and Cultural Society. Interested individuals must be citizens of Terrebonne Parish and interested in the future development of downtown Houma.
- Houma Public Trust Financing Authority: Two vacancies. Interested individuals should be residents of the parish and interested in overseeing a financial program for the parish.
- Terrebonne Parish Communications District Board: One vacancy. Interested individuals must reside within the area of North Terrebonne, and be able to attend regularly-scheduled meetings of the board, which oversees the operations of the Enhanced 911 Emergency Response System.
- Terrebonne Parish Tree Board: One vacancy. Interested individuals must be residents of the Parish, and be able to attend regularly-scheduled meetings of this board.
- Bayou Cane Fire Protection District Board: (Four vacancies). Interested individuals must be resident/property owners of the Bayou Cane Fire District and interested in the administration of fire protection services in the area.
- Coteau Fire Protection District Board: (Three vacancies). Interested individuals must be resident/property owners of the Coteau Fire District and interested in the administration of fire protection services in the area.
- Fire Protection District No. 4 Board: (Three vacancies) Interested individuals must be resident/property owners within the boundaries of Fire District No. 4 and interested in the administration of fire protection services in the area.
- Fire Protection District No. 5 Board: (Three vacancies). Interested individuals must be resident/property owners within the boundaries of Fire District No. 5 and interested in the administration of fire protection services in the area.
- Fire Protection District No. 6 Board: (Two vacancies). Interested individuals must be resident/property owners within the boundaries of Fire District No. 6 and interested in the administration of fire protection services in the area.
- Fire Protection District No. 7 Board: (Three vacancies). Interested individuals must be resident/property owners within the boundaries of Fire District No. 7 and interested in the administration of fire protection services in the area.
- Fire Protection District No. 9 Board: (Three vacancies). Interested individuals must be resident/property owners within the boundaries of Fire District No. 9 and interested in the administration of fire protection services in the area.
- Fire Protection District No. 10 Board: (Two vacancies). Interested individuals must be resident/property owners within the boundaries of Fire District No. 10 and interested in the administration of fire protection services in the area.
- Schriever Fire Protection District Board: (Two vacancies). Interested individuals must be resident/property owners within the boundaries of the Schriever Fire Protection District and interested in the administration of fire protection services in the area.
- Village East Fire Protection District Board: (Three vacancies). Interested individuals must be resident/property owners within the boundaries of the Village East Fire Protection District and interested in the administration of fire protection services in the area.
- Houma-Terrebonne Regional Planning Commission: (Three vacancies). Interested individuals must contact the Council Clerk's office to obtain an application to serve as a commissioner, should be residents of Terrebonne Parish

and familiar with zoning and subdivision regulations. There are usually two meetings per month.
