

NOTICE TO THE PUBLIC

The Terrebonne Parish Council is seeking individuals to serve on various boards, committees, and commissions designed to maintain and improve the quality of life in our community. The agencies in need of members are governmental or quasi-governmental organizations that require people who are familiar with the agency and are willing to give of their time and talents. At a meeting of the Parish Council, individuals are scheduled to be appointed to the following agencies:

- **Bayou Blue Fire Protection District Board:** (One vacancy) Interested individuals must be a resident property taxpayer of the Bayou Blue Fire District (Terrebonne Parish side) and interested in the administration of fire protection services in the area.
- **Village East Fire Protection District Board:** (One vacancy). Interested individuals must be a resident property taxpayer of the Village East Fire District and interested in the administration of fire protection services in the area.
- **Fire Protection District No. 8 Board:** (One vacancy) Interested individuals must be a resident property taxpayer of Fire District No. 8 District and interested in administration of fire protection services in the area.
- **Fire Protection District No. 9 Board:** (One vacancy). Interested individuals must be a resident property taxpayer of Fire Protection District No. 9 and interested in the administration of fire protection services in the area.
- **Recreation District No. 1 Board:** (One vacancy) Interested individuals must be residents of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein.
- **Recreation District No. 4 Board:** (One vacancy) Interested individuals must be residents of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein.
- **Recreation District No. 10 Board:** (One vacancy) Interested individuals must be residents of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein.
- **Library Board of Control:** (One vacancy) Interested individuals must be citizens of Terrebonne Parish and must be willing to perform all duties and powers with respect to the parish public library system as enumerated by state law.
