

## NOTICE TO THE PUBLIC

The Terrebonne Parish Council is seeking individuals to serve on various boards, committees, and commissions designed to maintain and improve the quality of life in our community. The agencies in need of members are governmental or quasi-governmental organizations that require people who are familiar with each agency and are willing to give of their time and talents. \*At an upcoming meeting of the Parish Council, individuals are scheduled to be appointed to each of the following entities:

- **Bayou Blue Fire Protection District Board:** (One vacancy) Interested individuals must be resident property taxpayers of the Bayou Blue Fire District (Terrebonne Parish side) and interested in the administration of fire protection services in the area. (\*6/10/15)
- **Houma-Terrebonne Public Trust Financing Authority:** (One vacancy) Interested citizens should be a resident of the parish and interested in overseeing a financial program for the parish. (\*6/10/15)
- **Coastal Zone Management & Restoration Advisory Committee:** (One vacancy) Representing the public. Individuals must be interested in coastal zone management issues, and must be willing to make decisions based upon information provided by the Parish's Zone Management and Restoration Department Director and Staff. (\*6/10/15)
- **Recreation District No. 9 Board:** (One expiring term) Interested individuals must be a resident of the recreation district and be willing to attend regularly-scheduled meeting to discuss and take action on matters pertaining to recreational facilities and activities therein. (\*6/10/15)
- **Consolidated Waterworks District No. 1 Board:** (One expiring term) Interested individuals must reside within either Council District No. 9, a qualified voter, and willing to attend regularly-scheduled meetings to discuss and make informed decisions on matters pertaining to the Terrebonne Parish waterworks system. (\*6/10/15)
- **Recreation District No. 11 Board:** (Two expiring terms) Interested individuals must be a resident of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. (\*6/24/15)
- **Terrebonne Parish Library Board of Control:** (One vacancy due to a resignation) ) Interested individuals must be citizens of Terrebonne Parish and must be willing to perform all duties and powers with respect to the parish public library system as enumerated by state law. (\*6/24/15)
- **Recreation District No. 6 Board:** (Two expiring terms) Interested individuals must be a resident of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. (\*7/22/15)
- **Terrebonne General Medical Center Hospital Services District No. 1 Board:** (Three expiring terms) One representing a Civic Organization (nominated by a bona fide local civic or community organization), one representing the Medical Society (3 nominees from the Terrebonne Medical Society), and one representing the Terrebonne Bar Association (3 nominees from the Terrebonne Parish Bar Association).(\*7/22/15)
