

## NOTICE TO THE PUBLIC

The Terrebonne Parish Council is seeking individuals to serve on various boards, committees, and commissions designed to maintain and improve the quality of life in our community. The agencies in need of members are governmental or quasi-governmental organizations that require people who are familiar with each agency and are willing to give of their time and talents. \*At at upcoming meeting of the Parish Council, individuals are scheduled to be appointed to each of the following entities:

**Terrebonne Parish Youth Advisory Council:** Two representatives from Covenant Christian; 1 Alternate from south of the Intracoastal. Members shall be residents of Terrebonne Parish, enrolled in an institution of education in Terrebonne Parish and shall be at least 13 years old and not older than eighteen years old or a high school senior. \*(4/10/19)

**Children & Youth Services Planning Board:** Six Board Members terms are expired. (Call Council Staff for nomination procedure) \*(4/10/19)

**Bayou Blue Fire Protection District:** One expiring term on 4/13/19 \*(4/10/19)

**Bayou Cane Fire Protection District:** One (1) expired term. \*(4/10/19)

(FIRE DISTRICTS: R.S. 40 – 1496.D.(1) Each member of the board shall be a resident property taxpayer of the district.)

**Terrebonne Parish Tree Board:** One vacancy due to resignation. \*(4/10/19)

(The Board's responsibility is to study, investigate, counsel and develop and/or update annually, and administer a written plan for the care, preservation, pruning, planting, replanting, removal or disposition of trees and shrubs in parks, within public rights-of-way along streets and in other public areas.)

**Recreation District No. 2,3:** Three expiring terms in May. \*(4/24/18)

**Recreation District No. 4:** One expiring term on 5/24/19. \*(5/8/19)

**Recreation District No. 3A Board (Representing Village East Subdivision):** Two vacancies representing the Village East Subdivision (Ordinance No. 9034 – Increase Board from 5 to 7 Members) \*(5/22/19)

(Interested individuals must be a resident of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities.)

**Terrebonne ARC:** Three expiring terms on 5/31/19, one nominated by the NAACP, one nominated by the TARC Membership and one nominated by the Houma-Terrebonne Chamber of Commerce. \*(5/22/19)
