The Terrebonne Parish Council is seeking individuals to serve on various boards, committees, and commissions designed to maintain and improve the quality of life in our community. The agencies in need of members are governmental or quasi-governmental organizations that require people who are familiar with each agency and are willing to give of their time and talents. \*At at upcoming meeting of the Parish Council, individuals are scheduled to be appointed to each of the following entities:

- **Recreation District No. 3A Board:** One vacancy. Interested individuals must be a resident of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. \*(5/25/16)
- **Children and Youth Services Planning Board:** One vacancy to serve as representatives of various entities/organizations. Interested individuals should contact the Council Clerk's Office for specific information regarding the duties and responsibilities for these positions. \*(5/25/16)
- **Terrebonne ARC:** Three expiring terms on 5/31/16, nominated by the NAACP, Membership and the Chamber of Commerce. \*(5/25/16)
- **Recreation District No. 9 Board:** One expiring term on 6/8/16. Interested individuals must be a resident of the recreation district and be willing to attend regularly-scheduled meeting to discuss and take action on matters pertaining to recreational facilities and activities therein. \*(5/25/16)
- **Coastal Zone Management & Coastal Restoration Advisory Committee:** One vacancy representing the Commercial Fishing Industry. Individuals must be interested in coastal zone management issues, and must be willing to make decisions based upon information provided by the Parish's Zone Management and Restoration Department Staff.
- **Waterworks District No. 1 Board:** Three expiring terms on 6/24/16, representing Council Districts 1, 2 & 4. Interested individuals must reside within either Council District No. 1, 2 & 4, a qualified voter, and willing to attend regularly-scheduled meetings to discuss and make informed decisions on matters pertaining to the Terrebonne Parish waterworks system. \*(6/22/16)
