#### **INTRODUCTION**

Terrebonne Parish Consolidated Government ("TPCG") is seeking experienced professionals with relevant experience and expertise to provide Architectural & Engineering Professional Services.

The intent of this Request for Qualifications (RFQ) is to solicit a submittal of qualifications to identify one or more Architectural and/or Engineering firms for inclusion in a pool from which TPCG or its affiliated agencies may select for projects on an as-needed basis, according to firm qualifications, readiness and capabilities of the pool.

The scope includes, but is not limited to the following:

- Pump Stations
- Wastewater Management Plan
- Wastewater / Sewer Improvements
- Stormwater Management Plan
- Boat Launches / Fishing Piers
- Water Quality and Flood Risk Reduction
- Street Improvements / Construction
- Building Improvements / Rehabilitations / New Construction

The projects are funded by Community Development Block Grant- Disaster Recovery (CDBG-DR) funds under the *Resilient Communities Infrastructure Program (RCIP)*, granted to TPCG by the Louisiana Office of Community Development – Disaster Recovery ("LOCD-DR or LOCD") in response to recovery and resiliency needs after the effects of Hurricane Ida in 2021 in Terrebonne Parish.

The Resilient Communities Infrastructure Program was established under the State's Action Plan for the Utilization of CDBG-DR Grant Funds in Response to 2020 and 2021 Federal Declarations Disasters<sup>1</sup> and ensuing Action Plan Amendments. Through RCIP the state and subrecipients will address unmet needs in the area of infrastructure across impacted areas in order to expand upon and improve resilient communities. The goal of this program is to reduce the overall risk to the population and structures from future hazard events, while also reducing reliance on federal funding in future disasters.<sup>2</sup>
